RESOLUTION

CONFIRMING THE APPOINTMENT OF MR. NATHANIEL KINNEY TO SERVE ON THE PLANNING COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-1505, Revised Charter of the City and County of Honolulu 1973. as amended (RCH), establishes a Planning Commission consisting of nine members appointed by the Mayor and confirmed by the Council to staggered five-year terms; and

WHEREAS, the major duties of the Planning Commission are to advise the Mayor, the Council and the Director of the Department of Planning and Permitting on matters concerning the planning programs, hold public hearings, and make recommendations on all proposals to adopt or amend the general plan, development plans, and zoning ordinances; and

WHEREAS, by Mayor's letter, dated March 22, 2021, the Mayor has appointed Mr. Nathaniel Kinney to the Planning Commission; and

WHEREAS, if confirmed by the Council, Mr. Kinney will serve for a term which expires on June 30, 2025; and

WHEREAS, Section 13-103, RCH, which applies to the Planning Commission. requires a member to be a registered voter of the city; and

WHEREAS, the Council has reviewed Mr. Kinney's gualifications and character and finds that he meets the requirements to serve on the Planning Commission and deserves confirmation for appointment; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body confirms the appointment of Mr. Nathaniel Kinney to the Planning Commission for a term expiring on June 30, 2025; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Mr. Kinney for his willingness to be considered for public service and actively participate in city government; and
