In response to Councilmember Tupola, Andrew Kawano, Director of the Department of Budget and Fiscal Services (BFS) stated that:

- The bonds are primarily sold to institutions and private investors.
- BFS was told by the underwriter that the information on the purchase of the bonds become public if the bond holder agrees to share that information publicly.

- The underwriter can do a publication at the time of the sale.
- BFS is looking at August to close the bonds.

Councilmember Say stated that he will have Merrill Lynch, the bond company, do a presentation on April 26 to the Council to explain the process of what bond financing is about.

She noted that in doing research on the issue, the City will be providing tax relief to over 7,500 property owners in the City and County of Honolulu, it will create five additional tiers for various property value categories starting at \$4 million and up to \$10 million. Councilmember Cordero stated that she looks forward to working with the

Committee on Budget, Budget Chair Say and the entire Council. She emphasized that the Bill would provide tax relief to over 7,500 property owners and it will not affect other residential properties unless their assessed value is above \$4 million and they do not have a homeowners exemption.
