With approximately a fifty percent increase in hours covered Ocean Safety will have to be an organization that will allow commensurate growth. Testimony	Aloha. The discussion you are having today has always been the dream of those working in Ocean Safety. From the late 1960s to the early 1970s, I had the distinct honor to serve the City as one of its Water Safety Officers ("Blue shorts" gang). Later in the 1970s I served as Water Safety Director for the County of Hawai'i. As I've noted back in those days in all the counties, the dream of all the Water Safety Officers and those in administrative capacities overseeing the lifeguards was always to have a separate Ocean Safety Department. The reasons for this are many but I've noted four major ones.
	First is the question of professional advancement. When I started with the city, the Water Safety Officers were under the Department of Parks and Recreation. In those days there were only three SR levels that one could advance to over a 25 year period. Thus, many considered the lifeguard profession as a stepping stone into the Honolulu Fire Department. This is still a

consideration that that lifeguards dwell on today. However, the question of a professional "ladder" has greatly improved over the years. In fact, an Ocean Safety Department can be established by simply removing it as a division from Emergency Services and establishing it as a department as the semblance of a career ladder has already been established.

Second is the degree of professionalism that is now demanded of Water Safety Officers. In all ways, the individuals within the Ocean Safety Division in the Department of Emergency Services are the Cities foremost ocean rescue personnel. Their training not only consists of but demands individual fitness and also the abilities to operate jet skis and other motor craft. The numbers of lives annually saved by the Cities Ocean Safety personnel supports finding.

Third is the fact that within the current Emergency Services Department, the needs and requirements of the EMTs and MICTs and their mobile intensive care vehicles are completely different from those officers of Ocean Safety; one serves on land the other on the oceans. Physical and responder training is uniquely different but, I might add, critical to saving lives.

And, finally, are the budget considerations. The needs and requirements of the individual divisions within the current Emergency Services Department are unique and require separate budget considerations based upon the unique needs of each division. Because we are an island surrounded by ocean, this requires that the budget needs and considerations of a Ocean Safety Department need to be reviewed and approved at the highest level of county government. This is currently not the case.

Thank you for the opportunity to provide supportive testimony for Resolution 21-122. Now is the time to implement the dream. Mahalo,

My name is Bruce Lum and out of great interest in the continued delivery of excellent service by the Ocean Safety and Lifeguard Services Division, to the people of the City and County of Honolulu, I am testifying in strong support of Resolution 21-122. I respectfully urge Mayor Blangiardi to exercise his executive reorganization authority to create a separate Ocean Safety and Lifeguard Services Personnel Department for the City and County of Honolulu.

In light of the State Legislature passing House Bill 1281 HD1 SD2 CD1, which divests the state's lead duties, for establishing and funding emergency services, from the state to the City and County or Honolulu, I believe that it is critical for the city to effect a transition that improves administrative effectiveness and prioritizes taxpayer health and safety. The three year transition of emergency medical services burden from the state to Honolulu County is highly troubling, because state funding will be completely phased out in 3 years without a clear plan about how Honolulu County will find the funding needed to support and deliver emergency medical services solely with county generated dollars. HB 1281 HD1 SD2 CD1 phases out funding from state general revenues for emergency medical services in the city and county of Honolulu before 7/1/2024!

HB 1281 HD1 SD2 CD1 Description:

Establishes a three—year transfer of certain duties, functions, and powers relating to emergency medical services for the city and county of Honolulu from the department of health to the city and county of Honolulu. Begins transition on 7/1/2021. Appropriates general funds to the city and county of Honolulu for emergency medical services for fiscal years 2021—2022 and 2022 2023. Appropriates moneys in the emergency medical services special fund to the city and county of Honolulu for fiscal years 2021—2022 and 2022—2023. Phases out funding from general revenues for emergency medical services in the city and county of Honolulu before 7/1/2024. (SD2).

So here is the urgency in my eyes. Currently the State reimburses the City for costs incurred by the City for the provision of emergency medical services, estimated to be \$49,671,411 for Fiscal Year 2022. the Department of Emergency Services ("DES") of the City and County of Honolulu ("City") is comprised of the (1) Emergency Medical Services Division ("EMS"), the (2) Ocean Safety and Lifeguard Services Division ("Ocean Safety"), and the (3) Health Services Branch. This \$49,671,411 reimbursement of costs incurred for the provision of emergency medical services is separate and apart from the budget and costs associated with the operations of Ocean Safety.

EMS and the Health Services Branch are by definition similar in administration, staffing, education and training. Revenue can be generated by Emergency and Medical Services provided by the EMS and Health Services Branch, but Ocean Safety lacks opportunity to bill for services rendered. Ocean Safety is the least similar of the three EMS Division's in operational and fiscal ways!

I see Ocean Safety's focus as being a blend of proactive and reactive disciplines applied constantly and consistently to provide peace of mind and safety to all of Oahu's ocean users and beach goers. Because Ocean Safety is uniquely defined by its operational environment (the ocean), Ocean Safety is constantly challenged to be ready for the extreme demands of the unpredictability of the ocean and the ways in which people engage the ocean environment. Ocean Safety officials are constantly endeavoring to improve their delivery of services through rigorous and consistent programs for staff education, training, staff fitness, staff use of tools, staff versatility, emergency skills, ocean knowledge, extreme ocean survival skills, and the unique list of qualities goes on and on.

From a purely practical standpoint, separating Ocean Safety out of the current EMS organization would allow Ocean Safety and Lifeguard Services greater autonomy, with respect to its budget and increasing demands on employees, to ensure that taxpayers can continue to receive the high level of service and safety they are accustomed to.

Ocean Safety personnel are constantly on alert, actively observing the people in the water and on the beach. They alert swimmers when jellyfish or sharks are present, Lifeguards help beach goers with minor injuries, like jelly fish stings or small abrasions or cuts, and provide advice as where to swim, where to go after the beach. On days when the beaches are crowded, it becomes increasingly demanding for the lifeguards to keep track of the various hotspots. Written Testimony	Aloha esteemed council members, My name is John Silberstein. I've been in the public safety first responder field here in Hawaii since 1985. I've spent the last 36 years navigating through both the ocean lifesaving and marine/conservation law enforcement fields. During my career I spent a decade as a front line City and County Water Safety Officer II, I've also served as a Lead Ocean Lifeguard Manager for a Federal jurisdiction beach, as well as stints as the Ocean Safety Chief /Administrator for both the islands of Oahu and Maui. I am also a veteran of the United States Coast Guard serving as a Maritime Enforcement Specialist and Rescue-station Boatswains Mate. I have personally observed close at hand (as well as participated in) the evolution of the Honolulu Ocean Safety and Lifeguard Services Division over the last few decades. With tremendous enthusiasm, I wholeheartedly support Resolution 21-122 requesting that the Mayor enact his authority in the interest of administrative efficiency by moving Ocean Safety from a division under EMS and establishing it as its own self-managed department with proper budgetary oversight and competent governance. This is long overdue. While on paper it may appear a good fit to have paramedics and other medical professionals managing lifeguards since both serve to save lives, however, in reality it only looks good on the surface in this circumstance and hasn't been working all that well. Subject matter experts should lead their own unique and distinct programs. High-ranking experienced Police leaders should manage the Police department, high-ranking Firefighters should manage Fire departments, and senior Paramedics should manage EMS and so forth. The same should apply to Ocean Safety. A career paramedic, doctor or lay public administrator may be the best fit in their respective field but would never be tasked to head up a Police or Fire agency. Beachboy stereotypes and Baywatch type shows often portray ocean lifeguarding as relaxing "day at the beach" but it is much more compl

program are often lost on those who have never actually performed the rigors of the job, nor have the capability to do so. The culture of the professional ocean lifeguard, especially in Hawaii, must be experienced in my opinion to be fully understood and these modern day professional lifesavers deserve senior leadership that gets it. They need to have faith that the decision makers understand their specific needs and the needs of the community. Ocean safety being run by EMS leaders is like comparing apples to oranges but we all know you can't graft an apple to an orange tree and expect it to grow and bear a hybrid fruit. Hawaii is an island state surrounded by water. Our lifestyle and traditions, as well as our tourism driven economy rely on the health and safety of our beaches. Why we here on Oahu don't have a dedicated Ocean Safety Department with all the bells and whistles in 2021 is mind boggling to me.

For far too long Ocean Safety has been treated like the red headed step child in the C&C public safety arena, however, arguably our Water Safety Officers have the greatest front line role and impact in the protection of our citizens and visitors. They are also often the first official face our visitors meet and greet and serve as unofficial ambassadors to our island. Our Water Safety Officers utilize a dynamic system of preventative measures and risk assessment to avert tragedy well before it ever becomes one. This is difficult to quantify in statistical terms as compared to other reactive public safety agencies that primarily respond to emergencies via 911 after incidents have already occurred. The science of open water lifesaving has to be viewed through the lens of those who understand this unique prevention approach.

We are lucky in Hawaii. Most people who become Water Safety Officers (WSO) either grew up in our dynamic ocean waters or did so elsewhere and relocated to Hawaii because it is a mecca for ocean recreation. Most WSO's come with incredible ocean knowledge and have been training for the physical and mental rigors of this job their entire life whether they realized it or not. Therefore we have some of the best watermen /women in the world working for the respective Ocean Safety agencies on each island. There is no shortage of talent. Honolulu Ocean Safety is the largest full time year round professional ocean lifeguard agency in the world. They are responsible for almost 200 miles of coastline. Hawaii lifeguards are often touted globally as the best of the best. But I am here to attest it is not labelled the best because it is an arm of EMS. It is not the best because of a sufficient budget, because of adequate staffing, a generous compensation and benefits scale, state of the art rescue equipment, adequate support facilities, best practice standards or senior departmental leadership and guidance. Quite the contrary. All of those aspects are woefully substandard and almost third world in many ways and I'll be glad to elaborate on this bold statement with anyone offline.

However, there is hope. We have never seen better top leadership in Ocean Safety at the Division level until present day. Chief John Titchen is an incredibly talented, well versed and capable leader and Deputy Chief Kevin Allen is a heck of a wingman followed by a somewhat recent increase in fresh support staff. But they can't make miracles happen and their vision to move the Ocean Safety program forward to where it needs to be is often hampered by layers of unnecessary fog above them. There is no clear benefit to the program or to the public they serve with regard to the additional layers of upper management that exists in the current organizational structure.

Historically Ocean Safety in general has not benefitted from any additional budgetary support by being an arm of the Honolulu Emergency Services Dept. since EMS is supported through directed State DOH funds. They have not received any additional equipment, advanced medical training, or support facilities by being part of HESD. On the contrary, Ocean Safety's limited as well as special funds have on occasion been tapped to support EMS special interests.

The quality and safety of our nearshore environment is far too important to not make it a top

priority. We already have the best ocean lifeguard staffing in the world. Now let's provide the best support and structure both the lifeguards and the public deserve. I am confident this is the Council and C&C Administration with the vision to make this happen. MAHALO

HFFA represents approximately 2,100 active-duty professional fire fighters throughout the State of Hawaii, of which more than 1,000 fire fighters of the Honolulu Fire Department. Aloha City Council Members of the City and County of Honolulu!

The Department of Land and Natural Resources (DLNR), Division of State Parks (DSP) is in support of RESOLUTION 21-122, which will create a separate department for Ocean Safety and Lifeguard Services Division (OS) to be called the Department of Ocean Safety. DLNR understands this reorganization would help EMS, as this function has been transferred back to the county from the state and EMS will be very busy starting July 1 as it begins to operate the EMS function with C&C funding.

This reorganization places OS on par with Fire, Police and EMS and optimizes their ability for increasing support. Having the ability to act on behalf of the OS mission at the city cabinet level establishes parity to all four major public safety agencies of the City & County of Honolulu and properly addresses the increasing demand of OS services. Additionally, DLNR also understands that OS is expected to begin a "dawn to dusk" program starting July 1, essentially increasing service by one third as much more operationally than they do now (factoring in all daylight hours).

We appreciate the working relationship OS has with our Division of State Parks for providing OS service at the Keawa'ula portion of Ka'ena Point State Park, so upgrading OS to department level will also enhance DLNR's goal of increasing public safety at this remote West Side park unit.
