In response to Councilmember Tupola, Dr. Ireland stated that House Bill 1281 has passed out of both chambers of the Legislature and is on the Governor's desk for his signature. He stated that the Department of Emergency Services has been preparing for the passage of

the Bill by getting ready to do billings. He noted that the financial package looks good for now and he does not anticipate coming to the Council for more funds in the next few years, but in the future would like to work with the Council on rates, collection and other opportunities for revenues as the services may grow with the aging community.

Councilmember Kiaʻāina voiced her support for Dr. Ireland's confirmation. She stated that Dr. Ireland and she both serve on the Kailua Neighborhood Board. Councilmember Kiaʻāina stated that she appreciates Dr. Ireland and his team for working with all communities and looks forward to working with them.

RESOLUTION CONFIRMING THE APPOINTMENT OF MR. NATHANIEL KINNEY TO SERVE ON THE PLANNING COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

Councilmember Elefante moved that Committee Report 143 and Resolution 21-84 be adopted. Seconded by Councilmember Kiaʻāina.

Councilmember Tupola moved that Committee Report 143 and Resolution 21-84 be postponed to the next Council Meeting. Seconded by Councilmember Tulba.

Councilmember Tupola stated that the reason for the postponement was a concern that the head of a union was opposing the nomination and wanted that to be resolved.

There was no public testimony.

In response to Councilmember Tupola, Nathaniel Kinney stated that:

- At a board meeting with the business managers that make up the alliance, the
  concern was discussed and he believes that the issue is resolved at this point. The
  outcome of the meeting was that what was in the past is in the past and moving
  forward communication will be improved between the members and if there are any
  issues that divide the alliance, it needs to be discussed before giving testimony at
  Council meetings.
- The Ethics Commission has stated that he should recuse himself on matters that were advocated on behalf of the Hawaii Construction Alliance before the Council. He also stated that from what he understands there is a very small amount of items that he would have to recuse himself from.
- When he is a commissioner, he would wear the hat of an objective citizen of Honolulu representing the constituents of the City and County of Honolulu and when he is not on the commission he will be doing the work of the Executive Director of the Hawaii Construction Alliance.
- He hopes the same standards apply to councilmembers and commissioners.
- All decisions that are made at the Planning Commission will go to the City Council for a vote unlike the Planning Commissions on the islands of Kauai, Maui, and the Big Island.
- He assures the Council that when he is serving on the Commission, he will serve as a member and constituent of the City and County of Honolulu and not as a paid member of any organization.

Councilmember Tupola stated that she would like every commission member to have a good experience and have no conflicts with their employer or any other entity.

Councilmember Elefante voiced his appreciation to Floor Leader Tupola's comments and motion. He stated that as the Chair of the Committee on Zoning and Planning, the Committee did review and look at the concerns raised by councilmembers. Councilmember Elefante noted that he did have the opportunity to meet and talk with the appointee on these issues. He stated that the Committee recommended reporting the Resolution out for adoption and asked councilmembers to not support the recommendation to postpone the measure for a month.

Councilmember Cordero stated that Councilmember Tsuneyoshi asked really great questions in Committee. She stated that the majority of the appointees have some type of conflict of interest. Councilmember Cordero stated that many great people with experience have become commissioners and come as individuals and not bring their day job into their position as a commissioner. She voiced her opposition to the postponement of the Resolution.

Councilmember Tsuneyoshi stated that she did attend the Committee on Zoning and Planning even though she was not a voting member and thanked Committee Chair Elefante for allowing her to ask questions of the nominee. She stated her concern is in regards to a representation from her district that was before the Planning Commission and at a commission meeting she observed the commissioner wearing different hats to weigh in on their decision. Councilmember Tsuneyoshi stated that she continues to have reservations and if the measure moves forward today, she will be voting with reservations. She noted that during Committee, Mr. Kinney shared that his is going to put on a hat of a committee member, as a father, and as a member of the community and she hopes that that will be the situation. Councilmember Tsuneyoshi stated that she hopes there are other vacancies on the Planning Commission and that the City will be able to get a diverse and qualified person on the Planning Commission who will look at things objectively because there are very difficult decisions to be made.

Councilmember Tupola thanked Councilmember Tsuneyoshi for her questions during the Committee meeting. She stated that if the measure moves forward, she will be voting with reservations. Councilmember Tupola stated that she just wanted to make sure the Council is taking the right step forward and wanted to hear from both sides and understand about potential conflicts. She stated that she is cognizant of the need for the Commission to have quorum and did speak with the Director of the Department of Planning and Permitting and the need to fill the Commission.

The motion to postpone Committee Report 143 and Resolution 21-84 failed.

Roger Morton, Director Department of Transportation Services (DTS) stated that the Department is in support of coming up with an extremely low income (ELI) or lower income fare for paratransit riders. He thanked Councilmember Tupola for the FD1 but recommended that it not pass at this time because DTS needs more time to work out the mechanics and would like to do this efficiently. He stated that he is willing to work with the Council and the Rate Commission to come to a consensus that would address the issue.

Councilmember Tupola stated that there was a good discussion and would like to work with the Department. She stated for the record that many people have asked the Council to consider the ELI for paratransit and wanted to make sure that the Director could state that he is in favor of having an ELI for paratransit but needs time. Councilmember Tupola stated that DTS needs to work with the Department of Community Services. She expressed to the Director that something needs to be done by the end of the year since the rate increase will start next year.

In response to councilmembers, Roger Morton, Director Department of Transportation Services (DTS) stated that:

- Lower income fares would require a statutory change. There are other issues with Chapter 13 and DTS intends to propose revisions to Chapter 13 and would incorporate the change at that time.
- DTS is in full support of the CD1 version but not in support of the FD1 version.
- DTS will be working on something and proposing a statutory fix before the end of the year which would be free standing from the underlying measure today.

Councilmember Tupola withdrew her motion to amend Bill 87 (2020), CD1 to an FD1. Councilmember Cordero withdrew her second.

The Chair stated that the motion on the floor is to adopt Committee Report 128 and pass Bill 87 (2020), CD1, as amended, on third reading.

She stated that she has raised concerns with the Department of Land Management (DLM) and the Department of Budget and Fiscal Services (BFS) on the conditions that surfaced after the Council approved the transfer of park lands. Councilmember Fukunaga stated the DLM and BFS have not been able to provide information on expenditures or documentation for the current lease arrangement. She stated that based on previous discussions with the Department, she cannot support the two resolutions knowing that the City is scrambling to make up revenues and are facing greater revenue shortfalls.

Councilmember Tsuneyoshi stated that the issue, as Councilmember Fukunaga said that the City acquired these properties and has no formalized agreement as to a request for bid (RFB) that shows all the details about who is using the property, how the individual was chosen, and what terms are of the usage and what benefits could be to the City. She shares Councilmember Fukunaga's concerns and cannot vote in support of the measures at this time. Councilmember Tsuneyoshi stated that she looks forward to hearing from the Administration on where they are currently on these matters.

In response to councilmembers, Scott Hayashi, Director Department of Land Management stated that:

- His predecessor was trying to get the RFB out by the end of last year but got held up with Corporation Counsel to get the draft lease agreement that was going to be attached to the RFB and then working out details with BFS, Purchasing Division.
- Currently, Corporation Counsel is done and DLM is working with BFS Purchasing Division on a handful of items.
- The Resolutions are just to hold the City over by extending the rental agreement on a month-to-month basis up to one year, but the RFB should be issued in two months.
- He will work with BFS Purchasing to make sure everything is in order and properly done. Once the RFB is issued, it would take another two months depending on the proposals and the bids coming in. He does not anticipate that the process will go smoothly.
- He will look into tightening up some of the requirements, such as the Administration's expectations between the City and the current lessee.
- The operating cost is about \$15,000 a month, there is no rent per se.

- The rent agreement was structured for the lessee to do improvement work on the property.
- The RFB will require rental payment.
- He will research back to when the property was transferred to the City and the arrangement between the Hawaii Community Development Authority and the two tenants.
- Once the RFB is issued, the process could be lengthy if the award is contested.
- There is no housing built on the parcels.
