WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973 (2017 Edition) provides the City Council ("Council") with authority to accept gifts to the City; and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City; and

WHEREAS, the policy provides for the acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, approved by the Managing Director, the Director of the Department of Parks and Recreation has submitted a request to the Council for acceptance of a gift to the City from The Association of Skateboarders in Hawaii for three (3) concrete skateboarding obstacles, one (1) metal flat bar, one (1) metal bench, and repairs to the existing fencing valued at \$129,211.47 to be installed at the skate park within the Kailua District Park; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift valued at \$129,211.47 from The Association of Skateboarders in Hawaii that is more fully described in the above-mentioned letter and the Declaration of Gift attached as Exhibit A; and
