VIEWING THE MEETING AND RESTRICTIONS ON ENTRY

Members of the public will not be allowed into the meeting room, but may view the meeting on a live broadcast. The meeting will be viewable: (1) by internet live streaming through <u>www.honolulucitycouncil.com</u> and (2) by televised live broadcast on Olelo TV Channel 54.

Some Councilmembers and presenters may be participating in the meeting by interactive conference technology from remote locations.

ORAL TESTIMONY

Oral testimony will be permitted on all items on the agenda, subject to the following restrictions:

- 1. Persons may submit oral testimony remotely through the Webex video conferencing platform. To participate, persons should visit <u>www.webex.com</u>, click "Join," enter meeting number **146 508 8888**, and complete the registration process. Registrants will receive an email that contains links and information on joining the meeting by either phone or video conference. Webex testifiers are strongly encouraged to register at least 24 hours before the start of the meeting. Remote testimony will be taken at the start of the agenda and then closed.
- 2. Each speaker may not have anyone else read their statement and is limited to a one-minute presentation.
