My interest in preserving the Ha'ikū Stairs comes from a botanical perspective. I have been a botanist by vocation for over 35 years, and have had the opportunity to hike to many beautiful native upland forests throughout the Hawaiian Islands. Hands down, the Ha'ikū Stairs hike is a unique treasure unlike any other in the State.

Not only does this hike afford a totally unique opportunity to ascend a steep ridgeline with relative ease and confidence, providing unparalleled breathtaking views, it also provides exceptional opportunities to educate the participant about some of the fascinating stories that make Hawaiian natural history so special.

Written Testimony Opportunities are increasingly rare these days for urban dwellers to get a taste of the wild wet uplands of the Ko'olau summit. The dismantling of the Stairs would remove by far the fastest, most readily accessible route for experiencing a native wet forest on O'ahu, and with it the unique golden opportunity to convey stories about the importance of watershed preservation and the unique flora and fauna that are the foundation of the watershed. To reach similar wet native upland habitats on a public ridge trail on O'ahu generally requires a roundtrip hike of 6 to 12 miles.

The Friends of Ha'ikū Stairs have provided mālama for the Stairs since forming in 1987, conducting routine trail cleanup and stair maintenance, and have created a cogent master plan for managed use of the Stairs. I have assisted in the past with their efforts to inventory the plant life along the Stairs. Preliminary surveys have identified about 125 different kinds of plants, with about 60% of them native to the Hawaiian Islands and found nowhere else in the world. There are a lot of stories that can be potentially be told, if the Stairs can remain in place.

Here's hoping that the legitimate concerns of area landowners and homeowners can be addressed while allowing for restoration of this unique treasure.

Written Testimony Friends, family, and visitors who have done the stairs would willingly pay a reasonable fee. This takes several hours and is arguably in line with the views from a helicopter ride, but with the reward of walking amongst the Ko'olau foliage to earn the views.

With changes to Maunawili, pillbox(es), the ever-deteriorating and overcrowded Koko Crater (which is rescue-heavy yet not on an agenda...), and decreasing trails, the stairs remain one of the safest hikes to catch views (compare to, say, 3 peaks).

I sincerely believe there are ways to save the stairs which will be cheaper than removal, have the potential to turn a longer-term profit, minimize negative impact on the community (noting that a handful of vocal people is not the same as a substanially negative impact on the community or even the vocal party), and be educational. Please further consider this matter and oppose the resolution to remove the stairs. Mahalo.

I strongly oppose RESOLUTION 21-154 to remove the Ha'ikū Stairs. The resolution is inaccurate and/or misleading in several respects, and would result in a very unfortunate decision.

For example, the resolution strongly implies that reopening the Stairs would cost the City more than \$900,000 in repairs and other improvements – when in fact City Council Resolution 20-323 of last December, which the Council chose to vote down, would have put this burden on the Stairs' private sector operator. Even with these stringent conditions, 14 potential bidders provided detailed plans for operating the Stairs, in response to the City's 2020 Request for Interest. For example, the Friends of Ha'ikū Stairs Concept Plan for managed access is posted on their web site (https://d35fd6ab-97b3-4733-9c46-

a329e025adee.filesusr.com/ugd/e3df2a c273635d8be2451185b406f7a60f7045.pdf). It's a serious plan, for people who are serious about solving this problem.

The resolution also misrepresents the conclusions of the Board of Water Supply (BWS) EIS. BWS went into the EIS process determined to remove them, but by the end, they had concluded that Managed Access [re-opening the Stairs to the public under controlled management and supervision, funded by the operator from hiking fees, and not by BWS water rate payers] was the alternative that best met BWS's objectives – even better than tearing them out.

Managed access would include provisions for parking, entrance fees, comfort facilities, waste management, environmental mitigation, cultural education, safety, liability insurance, maintenance, and the security features discussed below. And managed access would in fact make money for the City, in the form of a percentage of the revenues. How does spending \$1 million of the taxpayer's money to tear them out make sense?

The Kāne'ohe Neighborhood Board [KNB] passed a resolution in 2017 strongly supporting reopening the Stairs under managed access

(https://kaneoheneighborhoodboard.blogspot.com/2017/06/text-of-kaneohe-neighborhoodboards.html?fbclid=IwAR0ntCMA44Q52gwoGvCzKC\_WD9w3V6AVKPm9GjPjAA-YG-EcerCeEpfiFZs). You should take the time to read the case they made for doing so.

As for the influx of tourists, and their impact on resources: managed access is just that - managed. Hikers would be limited to 80 per day, and would need to get an online permit. The original access to the Omega Station up Haʻikū Road could be restored with the stroke of a pen by the Mayor and/or Governor. An off-site shuttle van could take hikers up to the Transmitter Building. The neighbors would not even see the hikers, much less feel their impact.

In sum, tearing out the Stairs is perhaps the worst option. What would it say about our state and our government if we destroyed a world-class resource because we couldn't figure out how to re-open a facility that used to operate unsupervised, with no trespassing, and no impact on the surrounding neighborhoods?

It might help the City Council to make an informed decision if they understood what prompted 20,000 people a year to hike the Stairs starting in the 1980s, when it was legal to do so [i.e., before it was 'forbidden fruit'] – even before the lure of 24/7 social media. What do these people see that our government does not? Why do people who normally take an elevator to avoid a flight of steps skip sleep and risk fine/arrest to climb 3922 of them, in an ascent that consumes more than 1000 calories?

As the KNB resolution notes, trespassing in the Haiku neighborhood is not acceptable, and must cease. Managed access cannot work unless this intolerable intrusion on people's privacy is eliminated.

There will always be those who do not want to pay a reasonable entrance fee, and attempt to enter illegally. Therefore, an advanced security system with high-tech monitoring equipment is critical from day one for the success of managed access. The operation must include a night-time security presence at the Stairs, in the valley, and within the community to prevent this after-hours trampling of lawns and invasion of privacy. Substantial and effective fencing would need to be installed at the base of the Stairs and several other strategic areas already identified in Haʻikū Valley. At least one security guard should be on duty 24 hours a day, and a roving guard in the adjoining community would monitor for illegal hikers and report them to the police.

A Security Planning Group, inclusive of neighbors and all other stakeholders, should be set up to help develop and supervise the security operation, and should meet as often as necessary to improve the operation. The Stairs should not be re-opened until a solid solution is developed.

There is a real demand from the public that can't be met any other way. The Stairs are irreplaceable, and future generations should get to see why. The Stairs are an incredible resource, and everything should be done to make their re-opening a success.

I am also seeking transparency on the decision to nominate Anne Botticelli to the Police Commission. In order to "Enhance the public confidence, trust and support in the integrity, fairness and respect of the police department, its officers and employees." as stated in the HPC mission statement, I believe that transparency and accountability are imperative in moving forward given this year's state of HPD's misconduct.

I'd like to pass along some questions for Anne Botticelli to answer, honestly and with the intention of gaining the public's trust and support.

HPD has been guilty of not adhering to their own policies. For example, on April 1st former Police Chief Susan Ballard announced a number of policies, one regarding use of force against vehicles, "officers may not discharge their weapons unless the person in the vehicle either threatens someone with deadly force by means other than the vehicle itself or other specific circumstances warrant the use of deadly force" in which UH Criminologist, Meda Chesney-Lind remarked "If these policies are followed, we will not see as many lethal encounters between police officers and citizens." Less than a week later, officers shot into the back of a stopped vehicle killing 16 year old Iremamber Sykap.

Written Testimony

While the Commission has approved taxpayer funds for the defendants' defense, how would you have responded to HPD's inability to follow their own policies?

What does police accountability look like to you? What circumstances do you think warrant disciplining officers?

You've been a Board Director of some incredible organizations supporting local communities here in Hawai'i. Can you speak to some of the in-person, or on the ground work you've done within these communities that demonstrate your understanding of the perspectives of the communities most impacted by policing?

While HPD has denied racial and wealth policing disparities, despite their own reports

demonstrating as much; do you acknowledge that these disparities exist (as according to HPD annual use of force reports)?

What is your role as a Commissioner in addressing and eliminating these policing disparities?

WHEREAS, the USCG initially allowed public access to the stairs with a sign-in sheet and waiver system but restricted public access in 1987 due to vandalism and liability concerns, and

WHEREAS, the USCG decommissioned its facilities in 1997 and relinquished its easement rights to the Board of Water Supply ("BWS") in 1999, and the BWS began to negotiate with the City Administration to transfer the property to the Department of Parks and Recreation ("DPR") the site was not needed for water source development, and

WHEREAS, from Fiscal Year 1999 to Fiscal Year 2003, a total of \$2,790,000 was budgeted the City's Executive Capital Budgets for the Haiku Valley Nature Preserve (Haiku Stairs) project, of which at least a portion of moneys were appropriated to construct improvements to the stairs; and

WHEREAS, in 2001, the City refurbished damaged portions of the stairs and worked on securing legal access with the intent of reopening the stairs for public recreational use, and

WHERAS, in response to a growing number of hikers trespassing on both its lands and surrounding privately-owned properties in order to access the base of the stairs, the BWS 2008 closed the trail leading to the stairs and hired security to deter trespassers, but illegal hiking on the stairs continued and created serious conflicts with the neighboring community and potential liability for the BWS, and

WHEREAS, trespassing increased with the coming of social media, which enabled the posting of illegal directions to the stairs and the sharing of panoramic pictures that have encouraged people from around the world to take the hike, and

WHEREAS, special duty Honolulu Police Department ("HPD") officers positioned in surrounding neighborhoods and hired by the BWS recorded turning away a total of 3,610 vehicles and 11,427 individuals between August 2017 and March 2020, which figure does not include individuals attempting to hike from Moanalua Valley or illegally access the stairs from other locations in Windward Oahu; and

### Vol. 1, 6.4.3.3 paragraph 1 notes:

"...most people would not trespass with a legal way to access Ha'iku Stairs."

WHEREAS, for Fiscal Year 2022, the City Administration has allocated \$250,000 for the continued security of the stairs provided by HPD special duty officers; and

#### Vol. 1, 6.1.1. notes:

"The third-party operator would also be required to pay maintenance, security, and structural upkeep costs for  $Ha'ik\bar{u}$  Stairs."

WHEREAS, as a legal public access to the base of the stairs does not exist, hikers starting in Haiku Valley must illegally cross a combination of State- and privately- owned residential properties to connect to the illegal access trails; and

### Vol. 1, 6.4.3.3 paragraph 1 notes:

"... most people would not trespass with a legal way to access Ha'iku Stairs."

WHEREAS, residents of Haiku Valley have reported the following continuing problems with trespassing hikers:

- 1. Nightly disturbances, including slamming car doors and loud voices that cause neighborhood dogs to bark, from hikers arriving between 2 a.m. and 4 a.m. to climb the stairs to watch the sunrise
- 2. The presence of strangers and their cars creating safety concerns for young children;
- 3. Hikers parked cars blocking private driveways and hindering the ability of emergency vehicles to pass through narrow streets;
- 4. Hikers walking through private property at all hours and using private water hoses to wash themselves or for drinking water, often without turning those hoses off;
- 5. Hikers throwing trash and waste onto private property, disrespecting or threatening property owners, and vandalizing or damaging private property; and
- 6. Hikers relieving themselves in the street, against private rock walls or in other private areas; and

#### Vol. 1, 6.4.3.3. Paragraph 1 notes:

"Disturbance to Ha'ikū Valley residential areas would... decrease because most people would not trespass with a legal way to access Ha'iku Stairs..."

### Later, in its final paragraph, Vol. 1, 6.4.3.3. notes:

"This alternative would decrease trespassing in Ha'ikū Valley, control neighborhood disturbances, and mitigate environmental impacts."

WHEREAS, illegal hiking in Haiku Valley increased the number of service calls to the HPD concerning the stairs from 20 in 2011 to approximately 160 in 2017, and the number of emergency calls in the area to the Honolulu Fire Department grew from one per year in 2002 to about 11 per year in 2018; and

#### Vol 1, 4.10.2 notes:

"To obtain the results shown [here], HFD searched ...their records database, and cross referenced with the area of Ha'ikū Stairs and the wilderness hiking areas that are connected or close by, including trails in Moanalua Valley. The data shown.... is not an exact result for Ha'ikū Stairs only. It could include people on recreational hikes in other areas.

"The location where rescues are performed vary.... Persons could be hiking from Moanalua Valley, whether their destination is Ha'ikū Stairs or not."

I have requested a detailed report of all HFD responses to the Ha'ikū Stairs area in recent years to help to clarify the ambiguity of data referenced here.

#### Vol. 1, 6.6. notes:

"Conditions are expected to improve under the Conveyance Alternative as 911 calls to the police and fire departments are anticipated to decrease due to managed access and increased safety and security measures."

#### Volume 1, 6.4.3.3 notes:

"...most people would not trespass with a legal way to access Ha'iku Stairs."

WHEREAS, in response to community complaints, the HPD issued 93 citations for trespassing on State property and made six arrests between March 14 and March 23, 2021 during an operation that focused on illegal hikers on the stairs; and

#### Volume 1, 6.4.3.3 notes:

"... most people would not trespass with a legal way to access Ha'iku Stairs.

WHEREAS, on June 21, 2021, an HPD officer reported being assaulted by a trespasser who illegally accessed the stairs; and

#### Volume 1, 6.4.3.3 notes:

"...most people would not trespass with a legal way to access Ha'iku Stairs."

WHEREAS, hikers have introduced invasive plant species into the area, particularly at the summit of the stairs; and

### Vol 1, 6.4.5.3 Paragraph 4 indicates a prevention plan is tenable:

"A prevention plan should be developed to curb the ongoing introduction of alien plant seeds from hikers."

Removal of the stairs will not stop hikers from hiking elsewhere with their shoes, and with the seeds, with the same net impact on the 'āina. Conversely, a guided experience of the Ha'ikū Stairs offers a unique opportunity to capture those seeds for destruction by requiring participants to scrub their shoes in a controlled environment.

WHEREAS, the BWS transferred ownership of the stairs and the land around it to the DPR on July 1, 2020, and the City Administration then began to prepare a request for bids to select a private company or organization to "provide a safe and well- managed access to the stairs"; and

WHEREAS, the City Council ("Council") on December 9, 2020 considered Resolution 20-323, which would have authorized the City to execute a 12-year concession agreement with an unspecified vendor to develop a managed access plan and guided hikes at the stairs, but did not adopt that resolution due to community concerns; and

This was perceived by many as a courtesy deferment to the incoming administration.

WHEREAS, the Council believes that a "managed approach" to the stairs will not be effective as the stairs' worldwide social media profile will continue to attract trespassing hikers, and their numbers will grow as the City's economy recovers from the COVID-19 pandemic and tourists return to Oahu; and

#### Vol. 1, 6.4.3.3 notes:

"most people would not trespass with a legal way to access Ha'iku Stairs."

Inasmuch as social media has been a tool to announce the presence of the Ha'ikū Stairs to the world, it it also effective in spreading the updated structure of a managed experience in educating visitors before they visit Hawaii.

WHEREAS, the Council notes that in January 2020 the BWS prepared a Final Environmental Impact Statement ("FEIS") on possible alternative actions for the stairs and proposed removing them at a cost of \$986,266, as such a removal would:

- 1. Stop trespassing and end disturbances in local neighborhoods;
- 2. Increase public safety by eliminating calls for emergency assistance from injured hikers;
- 3. Remove the liability to which the City, as property owner, is exposed if trespassing hikers are injured; and
- 4. Protect the environment by reducing negative impacts from hikers on the surrounding watershed lands; and

To rephrase this in a way that reads more clearly to me:

In 2016 the BWS proposed removal of the Ha'ikū Stairs. In April of 2017, BWS launched an EIS to study the impact of that proposed action. In Jan 2020 the FEIS was complete. The 3-year project found managed access was notably better than the action initially proposed. Factually, the EIS does mention the cost of removal would be roughly 1 million, and that the 'proposed action' (full removal) would also have a list of beneficial effects. In context of the entire document, however, the conclusion of the EIS shows the Conveyance Alternative (managed access) is the most beneficial of all actions considered, as noted in Vol 1, 6.5:

"The Conveyance Alternative [managed access] was scored with six Good ratings...; and two Fair ratings. The scoring for the Conveyance Alternative does not include a single Poor rating. This option has the highest overall score compared to the Proposed Action [complete removal of the stairs] and the other alternatives that were evaluated. [partial removal and no action]

WHEREAS, while the FEIS assessed a conveyance alternative that would open the stairs for public use through a managed access approach, the Council notes that the managed access option anticipated financial and other contributions from the City, including approximately \$900,000 in funding from the BWS to establish and improve legal access to the stairs, potential funding for a comfort station at the base of the stairs, and on-street parking or parking at the heavily-used Kaneohe District Park; and

The EIS has estimated managed access will return 1.2 million to taxpayers over 21 years, whereas removal would cost taxpayers \$940,000. When compared to the cost of removing the stairs, managed access leaves the City and State cumulatively \$2,140,000 better off over 21 years as noted in Vol. 1, 6.6:

"Over the 21-year analysis period, the least long-term value to the City and State would occur with the No-Action Alternative (approximately negative \$4 million), and most value would occur with the Conveyance Alternative (approximately positive \$1.2 million). Falling in between would be the Proposed Action (approximately negative \$940,000) and the Partial Removal Alternative (approximately negative \$190,000)."

WHEREAS, the negotiations needed to establish a legal access route to the stairs for a managed access approach would be complex and require legal agreements between numerous landowners, including potentially both government and private landowners who may not wish to allow access to the stairs through their properties; and

The EIS identifies an access route entirely on state land in 'The Summary of Rationale for Selection of Po'okela Street as the Preferred Access Route' Vol 1., 6.4.6.1: "The Po'okela Street access route rose to the top during the evaluation of the three potential access routes.... The access route is entirely on State land, and, in preliminary discussions with affected State agencies, access easements are possible with conditions."

WHEREAS, the Council finds that the only viable solution to mitigate liability and legal issues to the City, reduce nuisances and disturbances to local neighborhoods, increase public safety, and protect the environment is to remove the stairs and its accessory structures; and

#### Regarding managed access, Vol 1, 6.4.2 Notes:

"There are many different operations models that could be emulated, both locally and beyond. Hanauma Bay Nature Preserve and Diamond Head State Park are two local models...."

In all, the EIS considered 20 land areas, covering 3,871 acres (Table 3-1). Its 4,528 pages are overwhelming, and yet in light of the impact of this action, are worth the exhaustive study.

This diverse work of 7 volumes was compiled from the expertise of 1,100 private individuals, 26 community interest groups, 14 document and media agencies, 11 Elected Officials including Council Member for District Three, 10 City agencies, 27 State agencies, and 9 Federal agencies. These individuals and agencies, over a

course of 1,006 days, contributed their best to a \$500,000 project which came to a studied conclusion on January 24th, 2020 that the most beneficial course of action for the people of Hawaii is the Conveyance Alternative. (Vol. 1, 6.5 - Summary Comparison of Proposed Action and Alternatives by Project Objectives)

The BWS subsequently in April of 2020, voted unanimously to pursue the Conveyance Alternative - so long as the city would accept stewardship of the land within 18 months. Board member Max Sword said it best: "So if we do tear it down, we're still stuck". The land transfer to Parks was promptly initiated in the summer of 2020 as the first step toward the Conveyance Alternative

In light of the labors of so many who have brought us to this point, a deep consideration of their work in this EIS is not only prudent and measured, it is the pono thing to do.

WHEREAS, Ordinance 21-21, the Executive Capital Budget and Program for Fiscal Year July 1, 2021 to June 30, 2022 which was unanimously approved by the Council, included \$1 million for the removal of the stairs; now, therefore,

The monies earmarked for removal of the stairs may be set aside for the Conveyance Alternative.

BE IT RESOLVED by the Council of the City and County of Honolulu that the City Administration is urged to remove the Haiku Stairs and its accessory structures to stop trespassing, reduce disturbances to local neighborhoods, increase public safety, remove potential liability to the City, and protect the environment; and

I urge the Committee to retire this resolution today, or to transfer it to the Parks and Community Services Committee where it is more fitting. Note: on the board of that committee is Carol Fukunaga, also a stakeholder in this issue.

I urge City Administration to accept a meeting with me to continue the interview I took in 2017 (APPENDIX J), and to share new learnings of the recent years with perspective adapted to moving forward in 2021 with a Conveyance Alternative.

Both Ha'ikū and Kamananui valleys that lead up to Keahiakahoe are cultural treasures that need to be re-assessed as areas that require pro-active cultural stewardship by organizations and individuals that are dedicated and committed to its protection and long-term viability.

In 1995, we began to restore an ancient Hawaiian fishpond in Kāne'ohe Bay and have now worked with over 100,000 participants including schools, community, visitors in culture and place-based practices. The Haiku Stairs are a historic structure that served a vital role in the success of World War II's Pacific Theater and should not be torn down without compelling reason which there current is none. Access issues have always been exacerbated by the county's actions to limit access through state and county easements, causing conflict with private landowners and hikers crossing unimproved land. There are reasonable solutions that are actively not being implemented or considered making this resolution an inappropriate and premature action. I also feel compelled to speak again common misconceptions about the Haiku Stairs, misconceptions that are being used as arguments to tear the stairs down. I'd like to point out that the stairs are not dangerous as some may suggest. In fact, it's the only hike in Hawaii with a handrail the entire length. There are no deaths associated with the stairs other than one gentleman who suffered a heart attack on the stairs. There was also never a problem with hikers trespassing in people's yards as hikers only needed to use access roads going through unimproved land. This misconception was pushed notably by one landowner in the nearby neighborhood that was known for placing a board of screws facing outward from his property in order to harm hikers, something the City and County failed to condemn or require removal of. This health and safety hazard existed for at least two years until a hiker was injured and threated to sue the landowner that placed the hazard. After two decades of mishandling this issue, it is time for the Council to do the right thing and create safe access to the Stairs for all communities.

Written Testimony In 2016 the BWS proposed removal of the Ha'ikū Stairs. In April of 2017, BWS launched an EIS to study the impact of that proposed action. In Jan 2020 the FEIS was complete. The 3year project found managed access was notably better than the action initially proposed. Factually, the EIS does mention the cost of removal would be roughly 1 million, and that the 'proposed action' (full removal) would also have a list of beneficial effects. In context of the entire document, however, the conclusion of the EIS shows the Conveyance Alternative (managed access) is the most beneficial of all actions considered, as noted in Vol 1, 6.5.

URGING THE CITY ADMINISTRATION TO REMOVE THE HAIKU STAIRS AND ITS ACCESSORY STRUCTURES TO STOP TRESPASSING, REDUCE DISTURBANCES TO LOCAL NEIGHBORHOODS, INCREASE PUBLIC SAFETY, REMOVE POTENTIAL LIABILITY TO THE CITY, AND PROTECT THE ENVIRONMENT.

WHEREAS, the Haiku Stairs (the "stairs") a steel structure consisting of 3,922 and structures that extend from an elevation of 400 feet in Haiku Valley to an elevation of 2,820 feet on the ridgeline of the Koolau Mountains; and

WHEREAS, the properties on which the stairs sit are protected watershed lands owned by the City and the State Department of Hawaiian Home Lands; and

In Vol 1, 6.4.3.1 we find P-1 designation a not prohibitive to managed access:

"The parcel that hosts Ha'ikū Stairs is located in the City P-1, Restricted Preservation zone,... Per ROH Chapter 2: LUO Sec. 21-3.40, "the purpose of the preservation districts is to preserve and manage major open space and recreation lands..." A Conditional Use Permit minor may

be required for any new development within the P-1... district."

WHEREAS, the U.S. Navy built the stairs the 1940s to access communications facilities on the ridgeline, and the U.S. Coast Guard ("USCG") operated its Omega worldwide communications facility at the stairs site from 1975 until 1997; and the stairs site from 1975 until 1997 unt

WHEREAS, the USCG initially allowed public access to the stairs with a sign-in sheet and waiver system but restricted public access in 1987 due to vandalism and liability concerns; and WHEREAS, the USCG decommissioned its facilities in 1997 and relinquished its easement rights to the Board of Water Supply ("BWS") in 1999, and the BWS began to negotiate with the City Administration to transfer the property to the Department of Parks and Recreation ("DPR") the site was not needed for water source development; and

WHEREAS, from Fiscal Year 1999 to Fiscal Year 2003, a total of \$2,790,000 was budgeted the City's Executive Capital Budgets for the Haiku Valley Nature Preserve (Haiku Stairs) project, of which at least a portion of moneys were appropriated to construct improvements to the stairs; and

WHEREAS, in 2001, the City refurbished damaged portions of the stairs and worked on securing legal access with the intent of reopening the stairs for public recreational use; and WHEREAS, in response to a growing number of hikers trespassing on both its lands and surrounding privately-owned properties in order to access the base of the stairs, the BWS 2008 closed the trail leading to the stairs and hired security to deter trespassers, but illegal hiking on the stairs continued and created serious conflicts with the neighboring community and potential liability for the BWS; and

WHEREAS, trespassing increased with the coming of social media, which enabled the posting of illegal directions to the stairs and the sharing of panoramic pictures that have encouraged people from around the world to take the hike; and

WHEREAS, special duty Honolulu Police Department ("HPD") officers positioned in surrounding neighborhoods and hired by the BWS recorded turning away a total of 3,610 vehicles and 11,427 individuals between August 2017 and March 2020, which figure does not include individuals attempting to hike from Moanalua Valley or illegally access the stairs from other locations in Windward Oahu; and

Vol. 1, 6.4.3.3 paragraph 1 notes:

"...most people would not trespass with a legal way to access Ha'iku Stairs."

WHEREAS, for Fiscal Year 2022, the City Administration has allocated \$250,000 for the continued security of the stairs provided by HPD special duty officers; and Vol. 1, 6.1.1. notes:

"The third-party operator would also be required to pay maintenance, security, and structural upkeep costs for Ha'ikū Stairs."

WHEREAS, as a legal public access to the base of the stairs does not exist, hikers starting in Haiku Valley must illegally cross a combination of State- and privately- owned residential properties to connect to the illegal access trails; and

Vol. 1, 6.4.3.3 paragraph 1 notes:

"...most people would not trespass with a legal way to access Ha'iku Stairs."

WHEREAS, residents of Haiku Valley have reported the following continuing problems with trespassing hikers:

1. Nightly disturbances, including slamming car doors and loud voices that cause

neighborhood dogs to bark, from hikers arriving between 2 a.m. and 4 a.m. to climb the stairs to watch the sunrise

- 2. The presence of strangers and their cars creating safety concerns for young children;
- 3. Hikers parked cars blocking private driveways and hindering the ability of emergency vehicles to pass through narrow streets;
- 4. Hikers walking through private property at all hours and using private water hoses to wash themselves or for drinking water, often without turning those hoses off;
- 5. Hikers throwing trash and waste onto private property, disrespecting or threatening property owners, and vandalizing or damaging private property; and
- 6. Hikers relieving themselves in the street, against private rock walls or in other private areas; and

#### Vol. 1, 6.4.3.3. Paragraph 1 notes:

"Disturbance to Ha'ikū Valley residential areas would... decrease because most people would not trespass with a legal way to access Ha'iku Stairs..."

Later, in its final paragraph, Vol. 1, 6.4.3.3. notes:

"This alternative would decrease trespassing in Ha'ikū Valley, control neighborhood disturbances, and mitigate environmental impacts."

WHEREAS, illegal hiking in Haiku Valley increased the number of service calls to the HPD concerning the stairs from 20 in 2011 to approximately 160 in 2017, and the number of emergency calls in the area to the Honolulu Fire Department grew from one per year in 2002 to about 11 per year in 2018; and

Vol 1, 4.10.2 notes:

"To obtain the results shown [here], HFD searched ...their records database, and cross referenced with the area of Ha'ikū Stairs and the wilderness hiking areas that are connected or close by, including trails in Moanalua Valley. The data shown.... is not an exact result for Ha'ikū Stairs only. It could include people on recreational hikes in other areas.

"The location where rescues are performed vary.... Persons could be hiking from Moanalua Valley, whether their destination is Ha'ikū Stairs or not."

I have requested a detailed report of all HFD responses to the Ha'ikū Stairs area in recent years to help to clarify the ambiguity of data referenced here.

Vol. 1, 6.6. notes:

"Conditions are expected to improve under the Conveyance Alternative as 911 calls to the police and fire departments are anticipated to decrease due to managed access and increased safety and security measures."

Volume 1, 6.4.3.3 notes:

"...most people would not trespass with a legal way to access Ha'iku Stairs."

WHEREAS, in response to community complaints, the HPD issued 93 citations for trespassing on State property and made six arrests between March 14 and March 23, 2021 during an operation that focused on illegal hikers on the stairs; and

Volume 1, 6.4.3.3 notes:

"...most people would not trespass with a legal way to access Ha'iku Stairs.

WHEREAS, on June 21, 2021, an HPD officer reported being assaulted by a trespasser who illegally accessed the stairs; and

"...most people would not trespass with a legal way to access Ha'iku Stairs."

WHEREAS, hikers have introduced invasive plant species into the area, particularly at the summit of the stairs; and

Vol 1, 6.4.5.3 Paragraph 4 indicates a prevention plan is tenable:

"A prevention plan should be developed to curb the ongoing introduction of alien plant seeds from hikers."

Removal of the stairs will not stop hikers from hiking elsewhere with their shoes, and with the seeds, with the same net impact on the 'āina. Conversely, a guided experience of the Ha'ikū Stairs offers a unique opportunity to capture those seeds for destruction by requiring participants to scrub their shoes in a controlled environment.

WHEREAS, the BWS transferred ownership of the stairs and the land around it to the DPR on July 1, 2020, and the City Administration then began to prepare a request for bids to select a private company or organization to "provide a safe and well- managed access to the stairs"; and

WHEREAS, the City Council ("Council") on December 9, 2020 considered Resolution 20-323, which would have authorized the City to execute a 12-year concession agreement with an unspecified vendor to develop a managed access plan and guided hikes at the stairs, but did not adopt that resolution due to community concerns; and

This was perceived by many as a courtesy deferment to the incoming administration.

WHEREAS, the Council believes that a "managed approach" to the stairs will not be effective as the stairs' worldwide social media profile will continue to attract trespassing hikers, and their numbers will grow as the City's economy recovers from the COVID-19 pandemic and tourists return to Oahu; and

Vol. 1, 6.4.3.3 notes:

"most people would not trespass with a legal way to access Ha'iku Stairs."

Inasmuch as social media has been a tool to announce the presence of the Ha'ikū Stairs to the world, it it also effective in spreading the updated structure of a managed experience in educating visitors before they visit Hawaii.

WHEREAS, the Council notes that in January 2020 the BWS prepared a Final Environmental Impact Statement ("FEIS") on possible alternative actions for the stairs and proposed removing them at a cost of \$986,266, as such a removal would:

- 1. Stop trespassing and end disturbances in local neighborhoods;
- 2. Increase public safety by eliminating calls for emergency assistance from injured hikers;
- 3. Remove the liability to which the City, as property owner, is exposed if trespassing hikers are injured; and
- 4. Protect the environment by reducing negative impacts from hikers on the surrounding watershed lands; and

To rephrase this in a way that reads more clearly to me:

In 2016 the BWS proposed removal of the Ha'ikū Stairs. In April of 2017, BWS launched an EIS to study the impact of that proposed action. In Jan 2020 the FEIS was complete. The 3-year project found managed access was notably better than the action initially proposed. Factually, the EIS does mention the cost of removal would be roughly 1 million, and that the 'proposed action' (full removal) would also have a list of beneficial effects. In context of the

entire document, however, the conclusion of the EIS shows the Conveyance Alternative (managed access) is the most beneficial of all actions considered, as noted in Vol 1, 6.5: "The Conveyance Alternative [managed access] was scored with six Good ratings...; and two Fair ratings. The scoring for the Conveyance Alternative does not include a single Poor rating. This option has the highest overall score compared to the Proposed Action [complete removal of the stairs] and the other alternatives that were evaluated. [partial removal and no action]

WHEREAS, while the FEIS assessed a conveyance alternative that would open the stairs for public use through a managed access approach, the Council notes that the managed access option anticipated financial and other contributions from the City, including approximately \$900,000 in funding from the BWS to establish and improve legal access to the stairs, potential funding for a comfort station at the base of the stairs, and on-street parking or parking at the heavily-used Kaneohe District Park; and

The EIS has estimated managed access will return 1.2 million to taxpayers over 21 years, whereas removal would cost taxpayers \$940,000. When compared to the cost of removing the stairs, managed access leaves the City and State cumulatively \$2,140,000 better off over 21 years as noted in Vol. 1, 6.6:

"Over the 21-year analysis period, the least long-term value to the City and State would occur with the No-Action Alternative (approximately negative \$4 million), and most value would occur with the Conveyance Alternative (approximately positive \$1.2 million). Falling in between would be the Proposed Action (approximately negative \$940,000) and the Partial Removal Alternative (approximately negative \$190,000)."

WHEREAS, the negotiations needed to establish a legal access route to the stairs for a managed access approach would be complex and require legal agreements between numerous landowners, including potentially both government and private landowners who may not wish to allow access to the stairs through their properties; and

The EIS identifies an access route entirely on state land in 'The Summary of Rationale for Selection of Po'okela Street as the Preferred Access Route' Vol 1., 6.4.6.1: "The Po'okela Street access route rose to the top during the evaluation of the three potential access routes.... The access route is entirely on State land, and, in preliminary discussions with affected State agencies, access easements are possible with conditions."

WHEREAS, the Council finds that the only viable solution to mitigate liability and legal issues to the City, reduce nuisances and disturbances to local neighborhoods, increase public safety, and protect the environment is to remove the stairs and its accessory structures; and Regarding managed access, Vol 1, 6.4.2 Notes:

"There are many different operations models that could be emulated, both locally and beyond. Hanauma Bay Nature Preserve and Diamond Head State Park are two local models...."
In all, the EIS considered 20 land areas, covering 3,871 acres (Table 3-1). Its 4,528 pages are overwhelming, and yet in light of the impact of this action, are worth the exhaustive study. This diverse work of 7 volumes was compiled from the expertise of 1,100 private individuals, 26 community interest groups, 14 document and media agencies, 11 Elected Officials including Council Member for District Three, 10 City agencies, 27 State agencies, and 9 Federal agencies. These individuals and agencies, over a

course of 1,006 days, contributed their best to a \$500,000 project which came to a studied conclusion on January 24th, 2020 that the most beneficial course of action for the people of

Hawaii is the Conveyance Alternative. (Vol. 1, 6.5 - Summary Comparison of Proposed Action and Alternatives by Project Objectives)

The BWS subsequently in April of 2020, voted unanimously to pursue the Conveyance Alternative - so long as the city would accept stewardship of the land within 18 months. Board member Max Sword said it best: "So if we do tear it down, we're still stuck". The land transfer to Parks was promptly initiated in the summer of 2020 as the first step toward the Conveyance Alternative

In light of the labors of so many who have brought us to this point, a deep consideration of their work in this EIS is not only prudent and measured, it is the pono thing to do.

WHEREAS, Ordinance 21-21, the Executive Capital Budget and Program for Fiscal Year July 1, 2021 to June 30, 2022 which was unanimously approved by the Council, included \$1 million for the removal of the stairs; now, therefore,

The monies earmarked for removal of the stairs may be set aside for the Conveyance Alternative.

BE IT RESOLVED by the Council of the City and County of Honolulu that the City Administration is urged to remove the Haiku Stairs and its accessory structures to stop trespassing, reduce disturbances to local neighborhoods, increase public safety, remove potential liability to the City, and protect the environment; and

I urge the Committee to retire this resolution today, or to transfer it to the Parks and Community Services Committee where it is more fitting. Note: on the board of that committee is Carol Fukunaga, also a stakeholder in this issue.

I urge City Administration to accept a meeting with me to continue the interview I took in 2017 (APPENDIX J), and to share new learnings of the recent years with perspective adapted to moving forward in 2021 with a Conveyance Alternative.

Thank you for your time and care in this matter.
