Councilmember Tupola encouraged Ms. Botticelli to let the public know her vision and direction as previous Police Commissioners did.

Councilmember Cordero thanked the nominee for being at the hearing and looks forward to discussion in the Public Safety Committee. She stated that as a Police Commissioner, one of the important roles is to select the new Police Chief and asked that the nominee consider the types and values of the person being sought for the position.

Councilmember Tsuneyoshi noted that she previously voted with reservations for Resolution 21-141 because it includes general improvement bond funds that have to do with capital improvement budget specific to the City. She stated that her concerns for approving the bond floats are that information that was requested for the final budget amounts for the project, final deadlines for the project, and how the project is going to be moved forward was not received. Councilmember Tsuneyoshi stated that the only option to hold the Honolulu Authority for Rapid Transportation (HART) accountable is to stop floating bonds whenever they ask. She noted that another issue she has is relating to the City's debt ceiling limits. Councilmember Tsuneyoshi stated that the long-term financial obligations does not only affect us but it affects future generations. She stated that she will vote with reservations on Resolution 21-141 and in opposition to Resolutions 21-142 and 21-143 because the project is not going to be without a revenue source.

Councilmember Say explained the amendment to Resolution 21-141. He stated that Councilmember Tsuneyoshi's comments in regards to this measure was taken into consideration.

In response to councilmembers, Andrew Kawano, Director, Department of Budget and Fiscal Services (BFS) stated that:

- BFS will determine how well the bonds sell over the next month. He projects that
 the City will be borrowing at less 2 percent across the series of bond issuances. He
 stated that the City will borrow only what they need to keep the capital projects
 going and to meet their commitment for HART.
- In terms of issuance of bonds, the full amount is not always borrowed.
- He will keep the Council updated on any changes that are made regarding the bonds.
- Resolution 21-141 is the General Obligation bonds for the City Capital Improvement Projects (CIP) which includes the budget for the Administration and each councilmember's district. It also includes \$26 million to refund tax exempt commercial paper.
- Resolution 21-142 is the bond float for HART and is subject to the Memorandum of Understanding requiring that HART use general excise tax (GET) and transient accommodations tax (TAT) proceeds to reimburse the City for debt service.
- Resolution 21-143 is part of the series to cover the \$214 million required by the recovery plan.

- After obtaining input from the underwriter, bond counsel, the Acting Treasurer, the Deputy Director of BFS, Treasury staff and the Corporation Counsel, he determines the amount of each bond sale.
- The debt ceiling is 15 percent of the assessed valuation of all City property. The
 City's assessed valuation is about \$255 billion and 15 percent of the assessed
 valuation of all of City properties is about \$36 billion, which is the legal limit in terms
 of what the City is capable of borrowing.
- He stated that the City wants to make sure that based on current levels of revenue for HART, the GET and TAT, and expenditure needs that the City is well within its debt service limit.

Councilmember Tsuneyoshi thanked the BFS Director for his oversight and for making sure that the City is fiscally responsible, accountable, and transparent moving forward. She stated that what happened previously led to concerns from the general public and from councilmembers who have followed the process and questioned why the same things seem to keep happening. Councilmember Tsuneyoshi stated that she looks forward to Director Kawano's leadership because it could impact future generations of taxpayers, mayors, and councilmembers who will need to budget for other very critical projects.

Councilmember Say stated that he appreciates Councilmember Tsuneyoshi's point of view. He explained that when the operating budget was adopted, he shared that the three biggest expenses were salaries, post-employment and pension employee benefits, and service. Councilmember Say stated that he was happy Councilmember Tsuneyoshi brought up questions so that the general public could listen to an open, honest and transparent discussion. He noted that the Council did not approve HART's CIP budget request and reduced the amount to \$1.4 billion. Councilmember Say stated that a letter was sent to the Mayor indicating the Council's three priorities for the use of rescue monies: (1) homelessness; (2) affordable housing, workforce housing, low income housing; and (3) stream cleaning.

RESOLUTION ADOPTING A REVISION TO THE PUBLIC INFRASTRUCTURE MAP FOR THE PRIMARY URBAN CENTER DEVELOPMENT PLAN AREA.

The following amendment was posted on the agenda:

Resolution 21-48, CD1, Proposed FD1

Councilmember Elefante moved that Committee Report 195 and Resolution 21-48, as amended to CD1 be adopted. Seconded by Councilmember Kia'āina.

Councilmember Fukunaga moved that the Resolution be amended to the posted FD1. Seconded by Councilmember Tsuneyoshi. Councilmember Fukunaga explained the FD1 amendment.

The following individual testified:

Battalion Chief Kevin Mokulehua, Honolulu Fire Department (Support CD1 version)

In response to councilmembers, Battalion Chief Kevin Mokulehua, Honolulu Fire Department (HFD) stated that:

- The intent of the Public Infrastructure Map (PIM) is for HFD to establish the general area for a fire station symbol to plan for a future location. The HFD identified some areas that they were interested in and is continuing to research those areas. The goal of the PIM is for the HFD to open up future funding for a station.
- The timeline for construction of a new fire station is at least ten years out. Currently, Waialua Fire Station is currently in the queue. The HFD hopes that if Resolution 21-48 is adopted, they will be able to start the process for a new fire station.
- Floor Draft 1 recommends that the HFD meet with the community through a public hearing and then do a follow up report. Presently the HFD had conversations via email with Kevin Lye of the neighborhood board and discussed establishing a collaborative effort with the community to make sure they are in agreement.
- He would defer to the Office of Housing regarding the relocation of homeless services and free food distribution sites in the Floor Draft 1.
- The HFD had four meetings, three with neighborhood boards and one with Councilmembers Fukunaga and Cordero and will continue to collaborate with the community. He stated that the HFD meets with neighborhood boards each month to provide information, stats, and fire safety tips and informing them of this project is in addition to those meetings.
- The current fire station is approximately 9,000 square feet and is listed as a national historic location. The park next to the station is not conducive or a viable option for a future fire station due to the shape of the park.

 The HFD understands the community's concerns regarding the relocation of the fire station and having trucks in other areas. The HFD's concern is for the safety of the firefighters and community members. He stated that the HFD can do a better job collaborating with the community.

Councilmember Cordero stated that she does not support the proposed Floor Draft. She noted that the HFD already and willingly continues to work with councilmembers and the community. Councilmember Cordero stated that the conditions and/or requests that are in the Resolution are valid and should be required but is inconsistent with the PIM process. She stated that she will vote no on the Floor Draft.

Councilmember Elefante stated that he is also in opposition to the proposed Floor Draft. He noted his appreciation to Councilmember Fukunaga for her advocacy for her community and to the HFD for having dialogue with the community. Councilmember Elefante explained that a PIM amendment is intended to notify the community that the City will be placing a government service in the area. He agreed that it is important to take action by collaboration, communication, and coordination. Councilmember Elefante urged councilmembers to support the posted CD1 version of Resolution 21-48.

Councilmember Tsuneyoshi voiced her support for the proposed Floor Draft 1. She stated her vote of support for Councilmember Fukunaga who represents the area and continues to be very engaged with her community and provide a voice for her community. Councilmember Tsuneyoshi stated that the Floor Draft 1 is a good way to put into real terms and language the request for the continued collaboration by the HFD. She noted the concerns and comments from Councilmembers Cordero and Elefante.

Councilmember Fukunaga stated that the presentations made by the HFD to the neighborhood boards has intensified the level of opposition by the Downtown Chinatown community. She noted that during the March 24 meeting, Zoning and Planning Chair Elefante deferred action on the Resolution partly in response to over 106 signatures in opposition to the Resolution. In June there were 176 signatures in opposition and presently there are over 250 signatures in opposition. Councilmember Fukunaga stated that the record demonstrates that the people are becoming increasingly frustrated because they do not feel like their concerns are being heard. She urged councilmembers to support the proposed Floor Draft 1 as a means to get a report to be used for future Council decisions.

Councilmember Tupola stated that she sees both sides of the argument. She supports Councilmember Fukunaga making sure the community voices are heard and that there is an overwhelming amount of opposition to the Resolution.

Resolution 21-48, CD1 failed to be amended to the posted FD1.

In response to councilmembers, Battalion Chief Kevin Mokulehua, Honolulu Fire Department stated that:

- The HFD supports the passage of Resolution 21-48 in its current CD1 form. They
 would like to get started as soon as possible because of the lengthy planning
 process.
- The HFD can involve the community in looking at options in the area but at this time there is no detailed plan as to when the planning will start.
- The HFD is committed to meeting with the community. The plan is to meet with Downtown Chinatown as well as Kalihi-Palama and Nuuanu-Punchbowl.

The Chair stated that the motion now on the floor was to adopt Committee Report 195 and Resolution 21-48, CD1.

Committee Report 195 and Resolution 21-48, CD1 as amended were adopted.
