Your Committee on Transportation, Sustainability and Health, which considered Resolution 21-169 entitled:

"RESOLUTION AUTHORIZING THE MAYOR OR THE MAYOR'S DESIGNEE TO ENTER INTO A MASTER USE AND OCCUPANCY AGREEMENT WITH THE HONOLULU AUTHORITY FOR RAPID TRANSPORTATION AND THE UNIVERSITY OF HAWAII FOR EXCLUSIVE RIGHTS TO USE AND OCCUPY UNIVERSITY PROPERTY AT UNIVERSITY OF HAWAII – WEST O'AHU, LEEWARD COMMUNITY COLLEGE, AND HONOLULU COMMUNITY COLLEGE FOR THE HONOLULU RAIL PROJECT,"

introduced on June 9, 2021, reports as follows:

The purpose of the Resolution authorizes the Mayor or the Mayor's designee to execute the Master Use and Occupancy Agreement ("MUOA") in substantially the form attached to Resolution 21-169 as Exhibit A and, additionally, execute any incidental or related agreements, amendments, or other documents in furtherance of the purposes of the MUOA, so long as these incidental or related documents do not increase the financial obligation of the City.

Your Committee received written testimony in support of the Resolution from the Department of Transportation Services and the University of Hawai'i.
