Your Committee on Transportation, Sustainability and Health, which considered Resolution 21-194 entitled:

"RESOLUTION URGING THE CITY ADMINISTRATION AND THE STATE OF HAWA!" TO IMPLEMENT A COVID-19 HEALTH CARD FOR ESTABLISHMENTS AT HIGHER RISK OF TRANSMISSION OF COVID-19,"

introduced on August 27, 2021, reports as follows:

The purpose of the Resolution is to urge the City Administration to work with the State of Hawai'i to develop, implement, and mandate, by executive order if necessary, a program for the use of a digital health card.

At your Committee's meeting on September 2, 2021, with testimony received remotely, two persons testified in support of, 97 persons testified in opposition to, and 17 persons offered comments on, the Resolution.

Your Committee also received written testimony from 67 persons in support of, and over 8,000 persons in opposition to the Resolution, while 42 persons offered comments on Resolution 21-194.
