Bill 34 (2021) is a repeat of Bill 2 (2018) which did not pass.

This Bill would ban commercial activities from "Sunset Beach Park, Haleiwa Beach Park, and Haleiwa Alii Beach Park", and all city owned or operated beach rights-of-way and easements from Sunset Point to Kaiaka Point in Waialua. That's 8 miles of coastline from Sunset Beach through Haleiwa. This language is being added to the City Ordinance that already bans all commercial activities from Waimanalo Beach Park, Kaiona Beach Park, Kaupo Beach Park, Makapuu Beach Park, and Bellows Feild Beach Park, and all city owned or operated beach rights-of-way and easements from Lanikai to Kapoho Point (Castle Point). That's basically all of Kailua, All of Waimanalo, and now they want to ban them from all of the North Shore.

Written **Testimony**  This Bill is kind of a moot point after they passed the Parks Rules back in September. The new rules are so restrictive that it makes getting the permit that allows commercial stops at City Beach Parks not worth even trying to get.

It used to be that if I got a Parks Permit for Commercial Stops that that permit was good for all of my tour vans for that month to stop at any of the City Beach Parks, after providing proof of Commercial Insurance with coverage of One Million Dollars, with the City and County as an Additionally Insured. This permit was limited to 5 tour companies per month.

Under the new rules, they have divided the island up into 5 districts, and a permit is now only good for 1 of my tour vans to be able to do a Commercial Stop only in that 1 specific district. None of my other tour vans would be able to do a commercial stop in that same district. And again, this is limited to 5 tour companies per district.

The North Shore is in District 4 which runs from Makapu'u Point, along the windward coast line and the north shore to Kaena Point. So, District 4 covers half of the coastline of the island. But they can only issue 5 permits for that district, to 5 different tour companies, who

then can only have 1 of their tour vehicles do a commercial stop in that district for that month. So that's a total of only 5 vehicles that are allowed to do a commercial stop in that district for that month.

So, banning commercial stops, in the way that Bill 34 is trying to do is pretty pointless, as long as the new Park Rules that was passed in September are enforced. (But that is the problem; nobody enforces these rules. Even if this Bill is passed, nobody is going to be there to enforce it.)

On July 1st, I went to the Parks Department to try to get the permit for Commercial Stops, as I had done in the past before the new rules were passed, and after hearing how restrictive the new rules were, I ended up walking out without applying because the permit would be practically useless. I would have to choose only 1 of my tour vans to allow their customers to stop at a City Beach Park?! That's ridiculous. How do I tell 1 family, you can, but have to tell these other families you can't?!

Actually, I had went to the Parks Department office at the end of June, and at that time, they couldn't even explain the new rules to me, they said that they didn't know how the rules work, because nobody had tried to apply yet. Actually, the owner of another tour company told me in June that he had tried, but like me, once hearing how restrictive the new rules were, he walked out without applying. The person at the Parks Department that was trying to answer my questions said, Look, you gotta understand, We didn't make these rules, they were pushed on us by the City Council.

Btw, the other 4 of the 5 districts that they divided the island into, are not desirable to get a permit for. District 5 is Waipio Peninsula in Waipahu. District 1 is Aina Haina, District 2 is Kaka'ako, and District 3 is Waianae. District 4, which covers the entire Windward coast and the entire North Shore would be the most desirable district, and that is divided into only 5 permits for only 5 vehicles, 1 vehicle per tour company.

But I don't think that the people that are passing this bill even know all this.

Tour companies are already banned from all State Parks, so we are not allowed to go to Malaekahana beach, Kahana Bay beach, Kaena Point, both North Shore and West side, Keaiwa state park, La'ie Point state wayside, Ulupo state wayside, Pu'u O Mahuka state park, Pu'u Ualaka'a state park (Tantalus lookout), etc...

We're not allowed into 2 of the 4 botanical gardens maintained by the City, Ho'omaluhia Botanical Gardens, and Koko Crater Botanical Gardens.

Out of the 34 hiking trails that are maintained by the Na Ala Hele Trail & Access Program, Commercial tour companies are only allowed on 7 of them if they have the permit from DLNR.

Then they banned us from all of the beaches in Kailua, and then they banned us from all the beaches in Waimanalo. Together, Kailua and Waimanalo, that made 10 miles of coastline off limits. With the exception of Waimanalo Bay Beach Park, thanks to Bill 93 (2017) which allowed for up to 5 tour vans, if you pay \$165 per van, per month for the permit. But they're trying to take that away as well with Bill 77 (2020).

People complain that places like beaches are too crowded, and they blame it on tour companies.

If you look at the vehicles that are at these places, only a small percentage of them are tour vehicles. Most of them are rental cars or private cars and trucks driven by local residents. As we know now that the results of the most recent Census has been released, the population of this island is now over 1 million people. Most of the vehicles at these sites are Toyota trucks, Camry's, Lexus, etc..., not rental cars, or tour vehicles. So you can't blame all of this on tourism.

But you can see how with all the restrictions that I showed above, how that confines tour companies into a smaller area which of course makes those areas seem crowded, because that the only places that they can go to.

If tour companies were less restricted, they would be spread out more, and places wouldn't seem so crowded.

Also, these rules just drive people underground, to give illegal tours, in illegal vehicles, which are probably not on Commercial Insurance, and not registered with the PUC, or DOT, and not paying taxes.

You think that you are helping, but you are creating a bigger problem.

People who want to go to these places that tour companies are not allowed to go to, are just going to get a rental car, and go on their own, with no guide to keep them safe, or to tell them to pick up their trash, or to tell them to not climb on sensitive sites, etc...

We should be encouraging tourists to go with a guide. Not only does this keep them safe, and our island safe, but it also creates jobs for locals.

Dear Parks Committee Members,

I am writing to support Bill 34 and ask for your support as well. Many people living on the North Shore are negatively impacted by overt-tourism, unbelievable traffic, and the overcommercialization of our local parks and beaches. There is no room for locals and people who live here to go to Shark's Cove, PUeaneas, Three Tables, Waimea Bay, Ali'i Beach, and Chun's. Licensed and unlicensed vendors have completely taken over Chun's and Pua'ena's. At Pu'ena's (part of Haleiwa Beach Park), there are often over 100 people taking surf lessons at a time and 8-10 tour vans depositing hundreds of people and several buses. Shark's Cove often has hundreds of visitors on "Snorkel Tours", and 8-10 scuba lessons with 10 people at a time. The over-use is really taking its toll. There is no parking available for the people who live here, even early in the morning or after work, and certainly not on the weekends. Traffic delays from Haleiwa to Sunset are affecting everyone. A 15-17 minute drive should be regularly 1.5 to 2 hours, and lasts from 9 in the morning to 2pm towards Sunset, and from 2pm to 7pm towards Haleiwa. This is a single route in and out and poses emergency response-time issues and quality of life problems for everything from getting to doctor's appointments to school drop-offs and pickups to being able to go grocery shopping. Many people live on the North Shore and work in healthcare, education, construction, farming, and/or are stay-at-home parents. Most of the people who live here do not work for tour van companies or for surf lesson companies and our lives are really being impacted so that a few can make money from our public parks and beaches.

Dear Honorable Chair Tulba & Parks Committee Members,

Thank you for your consideration and for taking the time to read my testimony on Bill 34.

I believe there is a potential for unintended consequences in this bill. The Term Commercial Activities is overly broad. On the surface, it appears that this bill is targeting tour buses and the term commercial is not defined, and as such could ban all commercial activities including surfing lessons.

An amendment to SECTION 2. Section 10-1.2 subsection (h) could be helpful, "Commercial activities, including recreational stops by commercial tour companies, are not allowed at any time at Kailua Beach Park and Kalama Beach Park, except as otherwise provided in this chapter for commercial filming and permitted surfing activities.

Access to the ocean to practice the sport of surfing via the City Parks and rights-of-ways is cherished by everyone, native Hawaiians, residents & visitors alike. It is this last group of short term guest to our islands that need the most management and guidance when accessing our natural resources. Surf Schools provide just that. Besides the physically demanding efforts put in the water we also teach our students to use sun-safe sunscreen, to not wear reef shoes so as not to damage the reef and more.

Legislation denying people, for any reason, access to the ocean on the North Shore, should also consider the following:

- 1. Haleiwa is Designated the Surfing Capitol of the World per state legislation HCR161 2004
- 2. Surfing is designated as the official individual sport in the State of Hawaii since 1998
- 3. Surfing is an indigenous activity
- 4. Surfing and swimming are legacy sports
- 5. Surfing is now an Olympic sport
- 6. There are miles and miles of empty beaches on the North Shore

#### In addition:

**Existing Rules:** Extensive ordinances are already in place governing surfing lessons by both the City and State.

Room for Everyone: The North Shore has miles and miles of mostly empty beaches.

**Culture:** Surfing is Hawaii's gift to the world: This bill would restrict access of kama'aina and malihini alike from participating in this treasured tradition.

Visitor Experience: The majority of surf students say that learning to surf was the highlight of their trip to Hawaii.

**Safety:** Without surf instructors who are trained lifeguards, visitors will inevitably rent boards from surf shops and risk getting swept out to sea.

Sense of Place: Surfing originated in Hawaii – The North Shore is the Surfing Capital of the World and surfing is our State Sport (both as designated by State Legislation). The North Shore is famous around the world and on the internet for its surfing. Wikipedia's description of the North Shore begins with surfing and learning to surf followed by television and film, accommodations, activities. **Economy:** Surfing lessons provide tax revenues and much-needed income for North Shore locals..

The North Shore has miles and miles of coast line with most of the beaches unused. There is room for all of us. Please amend this bill to allow for permitted ocean activities, and work with us to come up with a win/win solution.

My name is Thomas T Shirai Jr a lifetime resident of Mokule'ia and descendant of a Piko Ohana of Waialua Moku spanning at least 10 generations. I'm active in Community and Cultural Affairs in Waialua Moku currently serving my 5<sup>th</sup> consecutive term on the North Shore Neighborhood Board with a total of 20 years participation. I am providing testimony as an individual. I've served 2 terms on the Oahu Island Burial Council and also on The Office of Hawaiian Affairs Native Hawaiian Historic Preservation Council (no longer existing) along with Ka'ena Point Advisory Group and several consultations for projects in Waialua Moku. I am a recognized Lineal Descendant of Kawaihapai and Pa'ala'a (Kai) Ahupua'a along with several Cultural Descendant Recognitions within Waialua Moku which includes Puaena Point. I am also recognized by The Department of Interior thru NAGPRA (Native American Graves Protection Act) as a Lineal Descendant and Po'o of The Kawaihapai Ohana which is a Native Hawaiian Organization (NHO).

I am providing TESTIMONY OF SUPPORT WITH FURTHER AMENDMENTS IN BILL 34 CD1 with the follow

Include Puaena aka Puaena Akua as part of the geographical places mentioned in Bill 34. This
is a very culturally sensitive area comprised of the cove and its shoreline which are part of a
huge TCL (Traditional Cultural Landscape) documented in Bishop Museum Publication entitled
Archeology of Oahu (McAllister-1933) and compiled in the current Sites of Oahu. It was
identified as Site 234 Haka Kau Kanaka which is that inlet and Site 235 Pohaku Puaena
situated on the shoreline of the cove.

Site 234 was used in Pre-Western Era where uncared deceased bodies of individuals where placed on the reef or ledges to decompose and consumed by Mano (shark) therefore making it a burial ground. Both Bishop Museum Publications mentioned documents that it was the resting place of a beloved Chief of Waialua named Elani who is the Father of Kaahana who was Ruler of Oahu during that time prior to being conquered by Kahekili.

My Ohana were the Cultural Informants of Waialua for Bishop Museum and featured in their publications and among them are my Grandfather's (David Peahi Keao Jr) Grandmother Annie Keahipaka and Uncle Oscar Cox making them my Great-Great Grandmother and Great-Great Grand Uncle who are Direct Lineal Descendants of Chief Elani and King Kaahana. My Great-Great Grand Uncle Oscar Cox was U S Marshal of Waialua in the early 1900's and an alumni of Kamehameha School for Boys c/o 1890. His son is Andrew Elani Cox and he donated the land where Waialua High & Intermediate School is situated which was originally named Andrew E Cox School.

Regarding Pohaku Puaena (Site 235) it's famous for healing powers, dream interpretation and attracting fish. People from all parts of Oahu came to it especially for healing and dream

interpretation. Attached with this testimony is the only existing photo of Pohaku Puaena taken by Bishop Museum in 1933 featuring my Great-Great Grandmother Annie Keahipaka (center with the hat) and members of our Ohana with Pohaku Puaeana. My Ohana are the Keepers of Pohaku Puaena.

Recent coverage by Hawaii News Now show the influx of tourist directed to Puaena Cove due to the overcrowding at Laniakea to view the Honu. The video clip showed a lot of tourist swimming in the cove along with them touching or perhaps walking on Pohaku Puaena without knowing the area.

After 1998 when I first opposed Puaena-Eco Camp it was because of the above mentioned reasons whereas I went against members of my Ohana (including Kupuna) and other community members against this project. I was encouraged by my Grandpa David Peahi Keao Jr who was 83 years old at that time to stand firm against this project which went bankrupt and would have only provided minimum wage jobs that entailed groundskeeper or housekeeper because that already had staff from the mainland for those administrative positions.

2. The second requested amendment I'm requesting is that this portion of Haleiwa Beach Park be designated as a Kapu Area limiting to restricted usage for subsistence gathering for pole (shore casting) outside of the cove and limu picking.

Puaena was once abundant with limu manauea, limu palahalaha (sea lettuce) and limu eleele that grew on the rocks.

- 3. Absolutely no recreational activity in the cove waters due to it being a burial ground.
- 4. Designated area to scatter ashes of deceased loved ones since it's a burial ground.
- 5. Puaena Cove be used for Cultural Educational Purposes especially for our younger generations of Hawaiian Ancestry

Thank you for the opportunity to share my mana'o and take these additional recommendations into consideration and add similarity to the proposed Bill 34 CD1. Malama Pono.

Site 235. Stone with curative powers, near Puaena Point, Waialua, (Sometimes covered by sand)

Partially covered by the sands of the beach and continually washed by the tides is a smooth oval-shaped stone about 2 feet high and 4 feet long which represents a woman known as Puaena who came in the following of Pele from Tahiti. For its curative powers the stone was famous, and Hawaiians came to visit it from all parts of Oahu. Seaweed was placed on the stone and a petition for aid addressed to it before the injured part was touched to the stone. If the ceremony was properly performed, the cure would be certain to follow. People also came to Puaena to inquire about the prosperity of the times and were answered through the medium of dreams.

This is Tamayo Perry with the surf school Oahu Surfing Experience. My sincerest apologies for waiting until the last minute to write to you all. Between working my lifegaurding job and helping my mother manage her cancer situation, I've been absolutely spread thin. Once again, I'm not asking for sympathy, but rather, I'm just explaining to you why it's taken me so long to respond to the drafting of & the contents of Bill 34.

I would like to start by thanking you all for always giving your best efforts of actually physically meeting with the people of Hawai'i, whom these major issues actually effect. So far, in my humble opinion, you are all doing an outstanding job in office & I appreciate your thoughtfulness very much so.

Written Testimony

I am writing to you in presentation of offering a few possible solutions to the commercial surfing side of Bill 34.

However, I must make it known to you, if you haven't already noticed already, but there will be serious ramifications or rather, grave & unintended consequences that stem from Bill 34 by way of the main contents of the Bill using the verbiage, "Commercial Activities.... are Not Allowed At Any Time"!

This is not an insult but rather an astute observation & i hope you don't take this the wrong way, but unfortunately, last I checked, the Government of Hawai'i was not maintaining a realistic viability in the arena job of creation. In the State of Hawai'i, Livable Job Opportunities with wages that produce a realistic way to provide for your family are slim to none. Living out here on the North Shore is even much much more difficult to survive. Most

of us are all living pay check to pay check & literally one pay check shy of becoming homeless.

If Bill 34 is passed, it would mean an upwards of 250 NorthShore residents, both Kanaka Maoli & Kama' āina alike, would be put out of a life sustaining job & one step closer to homelessness.

Myself, as well as many of my fellow surf instructors that reside here on the North Shore, we pass on kuleana of Hawaiian Culture as we teach surfing. Our beautiful Hawaiian Island Chain is the Birth Place of surfing & surfing is one of the most amazing & inspirational lifestyles that has ever graced planet earth. The moving art, lifestyle & modern day sport of surfing nearly disappeared from existence back in the early 1900's & if it wasn't for a young Hawaiian named Duke Kahanamoku, one of the most fascinating aspects of Hawaiian Culture would have vanished into obscurity. We the next generation of Hawaiian surfers & surf instructors fill in where Duke left off, continuing to perpetuate one of the most vital pieces of Hawaiian Culture to the next generation Hawaiian as well as the traveling malahini alike, who comes to our islands clueless & uninformed of the sacredness of Hawaiian Culture. Many of our educational surf schools become this avatar to important maintenance of a potentially dying culture.

I need to get it straight off my chest by stating that I am opposed to Bill 34 & I kindly ask that you Kill Bill 34 in its tracks before it causes irreparable damage.

If your counsel is absolutely hell-bent on eradicating "All Commercial Activity" from the North Shore Coast Line, I will accept your decision only on one condition, and that one condition would have to be that you be fair to ALL!

What I'm saying, is that this Bill 34 effects the little Mom-N-Pop operations on the North Shore. The small entrepreneurs that have endured major lack of job opportunities & used their creativeness & survival skills to create self employment & work positions against all odds. For example, my business has been in operation for roughly about 12 years now. So to be fare to ALL, you would need to ELIMINATE ALL COMMERCIAL SURFING

COMPETITION from the North Shore as well!!!

Most Professional & Amateur Commercial Surfing Competition here on the North Shore is owned & operated generally by

CORPORATE/FOREIGN ENTITIES who do a lot of major structural damage to our Public Owned BEACH PARKS. Please Do Not for one second use ambiguous semantics by acting like "A surfing Competition" or "Surfing Event" can be looped holed or maintain an exemption of being granted a permit by having the vague terminology such as "Commercial Filming Activities" in Bill 34, because no matter what terminology that is being used in Bill 34, a "Surfing Competition" with judges & competitors is still a "COMMERCIAL SPORTING EVENT/ COMMERCIAL ACTIVITY" no matter how one may be spinning it. Not only do I teach the very beginner in the culture & skill of surfing, but I also I teach & instruct young professional & amateur surfers before, during & after surfing competitions on the North Shore.

If you take away my permit because you are determined to pass Bill 34 without revising it so Surf Instructors have an exemption from this Bill, it would be a bizarre hypocrisy because i no longer would have the ability to legally instruct competitors in Commercial Competitions here on the North Shore.

So to be fare to the Kanaka Maoli & Kama' āina, the True Backbone & real residents of the North Shore, if you are going to terminate our livelihood, then ALL COMMERCIAL SURFING COMPETITIONS MUST NEVER BE ALLOWED to be permitted, held & operated again.

I hope I am making my plight for the little man crystal clear. Food on our tables & the roof over our head is very much at stake at this very moment.

To give you a better idea of my background & credibility, I am a former professional surfer who was endorsed and paid very well by major corporate surf companies such as Rip Curl Clothing & in my later years O'neill Inc. These companies didn't pay me to surf in competitions but rather they paid me for my skill set & expertise in surfing Pipeline, as well as surfing many of the other extremely dangerous & infamous waves of the world. What I'm about to present to you is by no means 2nd hand in nature but rather it is through my real life experiences & accumulated knowledge that has kept me safe & alive to this day. My whole life's formula has to do with safety, risk assessment & risk management. As well, I am a lifelong part of this North Shore Community & I to want to be in harmony with my community, especially while running my business. I pride myself through a self-created business formula on being community friendly, I stress the issue of keeping my community safe & as a community member, I to can not stand the eye sore that a few rogue surf schools have created with advertisement style commercial tents & an over saturation of surf students at certain surfing lineups out here on our North Shore beaches.

So here are my proposed solutions.

- 1. We have a C&C rule or law that currently exists that allows for 1 instructor to a 5 student ratio. This is in my expertise is absolutely ludicrous. 1 lone instructor can not realistically safeguard 5 students in a rogue environment such as the wild ocean. Especially out here in our North Shore waters. It is by no means safe for students or the surfing public at large to allow a 1 instructor to a 5 student ratio. This law or rule needs to be changed to No More then a 1 instructor to 3 student ratio. This will force schools to hire more qualified instructors to help manage their students. Not only will this create a few more jobs for our Northshore residents but also, this will help guarantee public safety in the lineups. More qualified instructors in the lineup will help keep their beginning students contained and from drifting off in the current without supervision. Rogue, unattended students is the catalyst for seriously hurting each other as well as the general public. Unattended students is always the biggest danger in the surf.
- 2. Renting any type of surfing equipment on the Northshore should be banned all together. You should Not be allowed what so ever to rent surfboards, bodyboards, SUPs or floating pool toys. These type of tourists who rent these kinds of equipment generally get sucked out to sea, causing unwanted stress on the already overburdened & overwhelmed lifegaurd force. There have already been several documented cases of tourists drowning because of renting surfing equipment and not having a guide or professional instructor with them.
- 3. The C&C laws & rules that currently exist (and they really already need to be enforced by authorities), state that there is absolutely no soliciting, advertising or tents allowed to be set up in C&C Beach Parks or parking lots. I stress once again, that this existing rule needs to be enforced! Several rogue & lawless schools take advantage of the communities lack of awareness to what the rules really state. As I am quite convinced that this is one of the communities main irritations towards the surf schools. The left side right side & of Hale'iwa Beach Park (Puena Point) is loitered with illegal surf tents & advertisements posted up all over the park & beach entrances. I'm not sure on the standing rules as far as State DLNR is concerned & if there is a loop hole as to if a surf school can set up a tent & advertise on the actual beach, like how they do at Chuns Reef & now a new surf school tent that has just popped up on Laniakea Beach. Surf School Tents in the Chuns & Laniakea area are another major reason contributing to the heavy traffic. If this law was enforced, it will also curb the

temptation for a school to solicit & illegally take cash payments for walk ins. Meaning tourists who see the tents & walk up for an unannounced lesson.

- 4. The Northshore geographically is a fairly small arena. In all hindsight, there eventually needs to be a Cap or limitation to the amount of permits that are allowed to be issued out here. I don't know how this can be done legally, but It should DEFINITELY NOT be a highest bidder solution. This would be absolutely unfair to small business such as myself who have been operating legally for nearly 10 years now. I pride myself in running a business that is based on safety, being community friendly & flat out offering an exceptional cultural service. If it is based on the highest bidder, my small business would be squeezed out. As well, big business would only care about making as much money as possible & in return they would have no regard for the safety of their clients as well as the safety of the general public. Rather, I was thinking the solution might be to use the methodology of how they grant boat slips to people in harbors. A Grandfather clause or something? First come first served & the later folk who are attempting to get a permit get on a waiting list until another company loses their permit for breaking the existing rules, the owner of the permit possibly dies or just flat out gives up on running their surf school business. Then the next in line steps in.

Treat surf schools like the corporation known as the World Surf League (WSL)/Tripe Crown. Make it part of the law for surf schools to Not be able to operate on Holidays.
- 6. Last but not least. Please Do NOT even consider isolating surf schools to 1 to 3 beaches. This is by no means safe jamming everyone into a few small, isolated locations. It is very much the opposite & this thought process is just down right dangerous. As well, I have a special skill set that allows me to teach the very beginner all the way up to the highest levels of professional surfers. My wife & I coach the very same professional surfers that are competitors in the Triple Crown. We need access to coach at the same venues as the Triple Crown. This also goes hand in hand without creating a time restraint for this type of coaching. If the contest starts at 8:00am, I need to be allowed to get out there even earlier into the lineups with my students to get them ready for the competition. I sometimes have my professional clients out there as early as 6:00am so I can have them ready to perform once it's showtime.

I'm pretty sure that these are some good, well thought out solutions and a fair compromise towards the concerns of the tax paying public who want unhindered access to their beach parks and surfing locations. I hope this sheds a little light on this hot topic of interest. Thank you once again Heidi for all that you do & for sincerely listening to the little people of Hawai'i. I do not envy your difficult position in finding a proper solution, but I will always be there to help you in any way I can. I am not submitting testimony for or against Bill 34. However, I am urging an alternative solution, with actual actionable proposals that will positively impact our Community without drastic negative impact on local businesses. There are precedents for this from Hawai'i over a thousand years.

There is an action word for what I am proposing in the Hawaiian Language. I certainly hope everyone concerned about this issue, especially those not from here like myself, knows the word and action I mean. However, for those of you born and raised here, I have a humble request I was given by those who taught me about these islands we love so much.

Let's fix this. We can sit together (even virtually or in a field 10 feet apart) and work through these issues. I am again proposing a Convention/Committee made up of the Community, Cultural Practitioners, the Industry, Regulatory and Safety Branches, and anyone who cares to work on an O'ahu Master Plan for the Tour Operators on the island.

Written Testimony

The alternative is the same, whether we pass or don't pass Bill 34. Next year, we will be back here, or maybe the year after talking about a different beach. Worse yet, probably the same ones. Like every Bill before it regarding this issue, enforcement might last a couple of months then the next issue will come up. Companies who care will immediately comply, and those that don't know or don't care won't. Nothing will happen to them, they will continue to operate, and the Community will continue to be left all on their own to do enforcement.

When I proposed this, I was instructed to give a little background on the specific examples. That is the Hawaii State Tour Standards Certification Course. It came about basically with a convention, under similar sentiments from the Community and Industry. This Committee/Convention produced results that positively changed the visitor industry until it's steward Uncle Larry Zablan passed a few years ago. There are several of us who are trying to continue this legacy.

Immediately, I called around to my teachers involved in this and asked why they did this back then? They confidently replied because it was the right thing to do. Whether you're interests lie in Sovereignty, turtles, traffic, careers, livelihoods, or childhood fishing grounds. I certainly hope you all will see that sitting down, making things right, and working on a solution together is the only way to handle these massive issues.

Hawai'i has always been an example to the rest of the World. When it was purely Oceanian's brave enough to sail the Pacific, Hawai'i was a beacon. The Kingdom of Hawai'i led the World in civil rights in it's day, without even trying to.

Treaties and Embassy's, groundbreaking Government structures merging the traditional Ali'i system with the new Parliamentary and Republic political designs. There were roads, schools, and there was even travel insurance for visitors.

That changed after the overthrow of the Kingdom. Whether we know about it or like it, our industry was directly involved and benefited from those actions. Over tourism is not a uniquely Hawai'i or American problem, but it has a unique history and place in these islands many people aren't aware of, but we can do this, and we have done it before.

I certainly hope you will join me in calling for a Convention style effort to replace this Bill with something meaningful, enforceable, and without the negative impact on small businesses facing another shutdown.

### Tour Operations Convention:

I propose a conventional style format to draft an O'ahu Action Plan as a replacement for Bill 34. One where the Community, Neighborhood Boards, Cultural Specialists, Elected Representatives, Tour Industry Professionals, Regulatory Branches sit down and write a replacement bill, one that helps the Community, without decimating small businesses and written in a way that may be realistic to enforce.

### Brief "Tour Guide" History:

- +Started by the Waikīkī Beach Boys, foreigners quickly saw an opportunity to make money.
- +Took the industry from the beach boys and sold "Sailor Jerry" style to tourists
- +Visitor Industry as a whole used tool of Occupation/Annexation
- +Hawaiian Cultural Renaissance happens in the 70's
- +Smaller, local Companies begin to form, eventually growing over time. (ENOA, POLYAD, Roberts)
- +New companies, new drivers, lots of discrepancies, and wrong information
- +State puts together a convention/committee to develop a Professional Standards Course for the tour industry.
- +The Committee was comprised of Education, Government, hotels, and eventually Tour Operators.
- +Certified guides impacted millions of visitors, hundreds of lives in the local Community.

Most CDL drivers are born in Hawai'i, most Hawaiian, and Polynesian. Many are rehabilitated and have put in the hard work to reform their lives and impact their communities positively. It is one of the very few industry jobs where people make a decent living.

During the first few months of the pandemic, 100's of years of tour guide experience retired or changed careers. At this current moment, most Companies in operation are locally owned, or at least family-owned. It is a high overhead business. Tour operation is not the section of the Hospitality Industry where people get rich. However, this section of the industry has a tremendous impact, both negative and positive. We will hear both sets of consequences during this process, and a lot on both sides is accurate.

### State Certification Convention Background

- + First manual and courses signed by Governor Waihe'e in 1993. It included the School of Travel Industry Management, Vice-Chairperson for the Office of Chancellor, Unions, the Hyatt, Department of Labor, and more, but NO Tour Industry Professionals.
- +It was all Educators, most of whom had never done a tour. So when presented with real-life questions and scenarios, they had no credibility. While they had the information, they had no idea about the presentation in that format and the interpretations about that information.
- +1996 Governor Cayetano rolled out island-specific and advanced manuals with the Tour Industry Support, including guides, trainers, and executives.
- +The Nā Leo o Hawai'i program was created, and stewardship was awarded to Uncle Larry Zablan.
- +For the next 30+ years, it taught 100's if not 1000's of guides accurate information and how to present complex subjects, respect the Community, both behind the wheel and the places you go. It taught us we are representing Hawai'i every time we step on the job.
- +That this was a responsibility and a gift, and we should treat it as such.
- +It took ex-criminals, many of whom had served a hard time, and gave us a purpose. A purpose that is greater than making money and simply surviving. But an opportunity to perpetuate a thousand plus years of groundbreaking knowledge, breathtaking beauty, and a love for this Community, it's culture, and it's customs.
- +Those Conventions and Committee's saved some of our lives, and now it's our turn to return the favor.
- +KCC tried to re-launch the State Certification Program. However, they invited the Tour Drivers who had graduated from this program in for a couple of meetings, then kicked us all out and did what they were going to do anyway. We need a fourth push on that program, and that should be in this Convention's objectives.

### Tentatively agreed to in advance

- +Limiting beach and hiking trail access to a predetermined grid (approx: 10 beaches/trails island-wide), including parking spaces and restrictions based on vehicle size.
- +That, of course, includes no commercial activity at Kailua, Waimānalo, and Laniākea.
- +No commercial activity on Sundays and Public Holidays at beaches or public hiking trails.

### Other areas to address

- +Community concerns, cultural concerns, enforcement challenges, excess unenforced laws, PUC approval process.
- +Clear area/course for owners/managers to understand the various laws that affect tour Company's, local State and Federal.
- +Posting license/permit numbers online and change enforcement to include advertising.
- +It is revisiting the State Certification Program to make it accessible and affordable. It is currently in the same stage as '93-'96, great information, but it is not sold in a viable format.
- +Fixing the Recreational Permit in a way that is possible for Companies to apply, secure, advertise based on, and follow. The rewrite completely destroyed any possibility of that program working and included zero enforcement.

  Letting certain areas rest during certain times of the year.
- +Just for example, Pua'ena could be tour busses in summer when it's flat and surf schools in winter when there are waves.
- +Possibly Marine Conservation District needs to be created
- +Help us reform the industry in a way that helps the Community, Local Business, and Enforcement Branches alike.
- +Getting Ko'olina and Turtle Bay to open up access to help contain impact.

Who will be involved?

+Anybody that wants to find a real solution, but to be more specific:

Community including Native Hawaiian Advocacy Groups and Neighborhood Boards, Kahu's and Konohiki's, Tour Operators, Council and Representatives, Enforcement Branches, Water Safety Professionals, Nā 'Ala Hele Trails, and other small business owners directly and indirectly affected by the tour bus operation industry.

How long will it take?

- +End of September, a rough outline for the Convention and issues to be tackled, as well as a plan submitted to be worked on by the Committee.
- +January should have a final outline to present for editing and prepare for the first reading.
- +February begin the hearing process.
- +The plan should be in action for the tourism return in Summer 2022 with Industry, Community, and Regulator Support for the first time since 1996.

If we fail, pass Bill 34, and then we'll be back in a year or two for another bill for a different beach.

The reason I believe we can get it done so quickly is that the foundation is there. The

Certification Course already exists, it's just not being utilized. Laws that would handle most of the "problem Companies" already exist, they are just either not enforced or unenforceable in their current format. I also already have virtually every location on the entire island (and Statewide) vehicle size and appropriate parking areas. With a quick update, we can easily use that as a foundation to start from and widdle down the details from there.

The reason I don't outright support this Bill, will be voiced by the rest of my colleagues, and they're right. The reason why I don't outright oppose Bill 34, the Community will speak to and was spoken to, on the beach commonly referred to as Laniākea a couple of weeks ago, and they're right too. This Convention/Commission is not my idea. It's not a new idea. People talk about wanting to have more direction in the industry, more voice. This can be done. Now is the time.

As has always been the case here, if you want to know where you are going, you must know where you are, and you must know where you have been. We know where we have been. We know where we are because we've been here before. This was the right thing to do then, and this is the right thing to do now.

I do not believe there is an argument against that, only the belief that it cannot be done. The lack of trust in one another, caused by years of miscommunication, overreactions, and heartbreak from broken promises on all sides, is legitimate. It's righteous, and it's justified. Nobody can fix that but us. Now is the time. O'ahu is the place. It may be long overdue, but we know what they say about the best time to plant trees. If we

fail, pass the Bill, but if we don't do this, you might as well start drafting the next ones now.

As one last hope, I close with a question Uncle Larry always asked.

"Of all the people the visitor interacts with on vacation, which makes the biggest impact on them?" There were always a few guesses, but the answer was always the same.

"Naturally, it's the people they spend the most time with, their tour drivers."

We also have the most significant impact on the Community, both positive and negative, for the same reason. We as an industry must always keep that in the forefront of our mind.
