SUBJECT: Testimony in Support of Resolution 21-169, Master Use and Occupancy

Agreement With The Honolulu Authority For Rapid Transportation And The University of Hawai'i For Exclusive Rights To Use And Occupy University

Property.

Dear Chair Cordero, Vice Chair Elefante, and Members of the Committee,

The University of Hawai'i supports Resolution 21-169, to authorize the Mayor or designee to enter into a Master Use and Occupancy Agreement (MUOA) with the Honolulu Authority for Rapid Transportation (HART) and the University of Hawai'i (UH) which will allow HART and the City to use UH real property at UH-West Oʻahu, Leeward Community College, and Honolulu Community College for rail and to locate rail stations.

This MUOA represents years-worth of negotiation and work by representatives of the City, HART, and UH. I believe the agreement satisfactorily addresses a myriad of details delineating the responsibilities between each of the parties. The University supports this MUOA because we support the rail system and the benefits that the rail system will offer to our University students, faculty, staff, and our campus neighbors at UH-West O'ahu, Leeward Community College (LCC), and Honolulu Community College (HCC). Accommodating the rail system by making land available on UH campuses demonstrates UH's commitment to this critical partnerships between the City, HART, and UH to deliver this significant public works project.

This long term agreement will be the University's commitment to the use of UH lands for operating rail, constructing rail improvements, rail stations, and the guideway. It will also address the use, administration and operation of the rail system while providing opportunities for UH communicate and work with City Administration on future use. For example, the agreement provides for a 12-member committee including representation from the City and UH.

The UH, HART, and the City are continuing to work on proposed rail improvement agreements that still need to be refined at UHWO for an interim park-and-ride and at HCC for the rail station that is anticipated to be located there. This MUOA is an important primer to frame these additional details.

I respectfully request that the Committee on Transporation, Sustainability, and Health approve Resolution 21-169. Thank you for your consideration.
