Honolulu City Council Committee on Transportation, Sustainability, & Health September 2, 2021 Resolution 21-193

Chair Cordeiro and members of the Committee, mahalo for the opportunity to submit testimony on behalf of the Hawai'i Lodging & Tourism Association, the state's largest private sector visitor industry organization.

The Hawai'i Lodging & Tourism Association—nearly 700 members strong, representing more than 50,000 hotel rooms and nearly 40,000 lodging workers—represents an industry that has worked closely with local government from the very beginning of the COVID-19 pandemic to help slow the spread of the virus in our community. We served as a conduit between our elected officials and the industry as we dealt with the suspension of travel, a mandatory quarantine policy, and the enactment of the Safe Travels program—a highly successful public health policy that kept residents and visitors safe while allowing the economy to begin the recovery process.

We now find ourselves in the midst of an unprecedented surge of new infections that threatens our health and our economic wellbeing. While the data shows that visitors are not contributing to the increase in case counts in any significant way, we do recognize that there has been an increase of infections directly related to the trans-Pacific travel of both residents and tourists.

Since the start of the vaccination exception for incoming travelers, more than 70% of both visitors and returning residents have utilized the option to provide proof of vaccination. Though the probability of breakthrough cases occurring remains low, we must be cognizant of the fact that vaccinated individuals can contract the Delta variant, unknowingly expose others around them, and ultimately contribute to community transmission. The most efficient way to mitigate this risk is to re-instate the pre-arrival testing requirement for incoming trans-Pacific travelers.

For this reason, HLTA supports Resolution 21-193.
