I am writing in opposition to the proposed Resolution 21-194, vaccine passport system and any further expansion of such a policy. First and foremost vaccine passports are a form of coercion, discrimination, and are a violation of human rights. These mandates infringe upon our 14th amendment rights as they are a direct deprivation of personal liberty.

To propose such a system given that the vaccines do not prevent the transmission of covid is dubious at best. For example considering the most vaccinated country Gibraltar, have recorded 5,332 covid cases and 97 deaths out of a population of 33,679; yielding a 16% infection rate and a .3% mortality rate from the total population. Gibraltar's vaccination rate is 116.3%, which should show less covid cases and deaths. [SEP]

#### Written Testimony

Conversely, the one of the least vaccinated countries, Nigeria, with a much larger population of 212,390,779 has 193,013 covid cases and 2480 recorded covid deaths; yielding a percentage of .09% infection of the total population and a .001% mortality rate. Nigeria's vaccination rate is 0.7%.

Furthermore, here in Hawaii we are a state with a population of 1,360,301. Our covid cases are 63,957 with a 5% infection rate and covid mortality percentage of .04% of the population while we have a vaccination rate of 60.4%.

What do the numbers tell us? That the currently available vaccines have little positive benefit and possibly a detrimental effect on the populations that they are administered to. In Nigeria, they have used ivermectin for River Blindness which has also been effective against Covid-19 outbreaks. When administered it would lead to recovery from Covid-19 within 48 hours. Countries like Israel and Japan are now looking into alternative treatments and are studying

the use of Ivermectin because of the low case counts in densely populated countries like Nigeria. Ivermectin has been used for over 50 years, not only do we know the side effects, but we also know the long term effects.

As more information is revealed about covid vaccines, evidence suggests that they are much less effective at preventing covid mortality rates and illness than advertised by their manufacturers. Further more, a Pfizer BioNTech briefing document from December 2020 shows statistics of adverse effects being higher in the younger tested population. I would also like to note that they only did a follow up 2 months after the 2nd dose was administered. This makes one wonder what the long term effects are, but we have no data on them because there is no longer a control group available. Every person within that trial is now fully vaccinated, according to a few online sources.

Another thing to consider are the constant changes in guidelines. Masks are effective, and are no longer effective. Who is considered fully vaccinated when there are more booster shots? We are being guided by opinions, not facts. These are the opinions of the CDC, WHO, NIH, and more. Why are we not transparent with important scientific information? There are a lot of scientific articles that are available about early covid treatment, and the effects of the vaccines.

Leave medical decisions up to each individual. It is not prudent or wise to apply a blunt one-size-fits-all approach to medical treatments for which there is no long term data and a questionable safety profile. We should be be able to decide what we put into our bodies without having our 14th amendment rights infringed upon. We are not a democracy, we are a constitutional republic.

Multiple medical studies show that those with preexisting immunity have long lasting and robust natural immunity to COVID.

A recent Cleveland Clinic study demonstrates that natural immunity acquired through prior infection with COVID-19 is stronger than any benefit conferred by a Vaccine, rendering vaccination unnecessary for those previously infected.

A comparative study by Goldberg et al "questioned the need to vaccinate previously-infected individuals" and noted that previously infected individuals had 96.4% immune protection from COVID-19, versus 94.4% in those injected with the Vaccine.

The Israeli Ministry of Health (one of the most highly vaccinated countries in the world) has recently released data showing that Israelis who had been previously infected with COVID (and

were not also vaccinated) were far less likely to become re-infected with the virus than those in the population who had been injected with the Vaccines.

Of the more then 7,700 new cases detected during the recent wave that commenced in May 2021, only 72, or less than 1%, were people who had previously been infected with COVID-19 and were never vaccinated. By contrast, over 3,000 cases, or 40%, were people who became infected for the first time, in spite of being vaccinated. The 72 instances of re-infection represent a mere 0.0086% of the 835,792 who are known to have recovered from the virus.

In the largest study comparing natural immunity gained through previous COVID infection to vaccine-induced immunity afforded by the Pfizer vaccine, people who recovered from COVID were much less likely than never-infected, vaccinated people to get Delta, develop symptoms or be hospitalized. What is profoundly worrisome though is that Medical studies show severe Vaccine side effects in persons previously infected with COVID-19. A person who previously had COVID-19, and

then receives a Vaccine, mounts an antibody response to the Vaccine that is between 10 and 20 times stronger than the response of a previously uninfected person.

A study published in the New England Journal of Medicine noted antibody titers 10-45 times higher in those with preexisting COVID-19 immunity after the first Vaccine injection, with 89% reporting adverse side-effects. The failure to protect a subpopulation at higher risk, such as this one, is unprecedented.

Dr. Richard Urso is a fully licensed, board certified, practicing medical doctor who has treated over 300,000 patients in his career, including over 450 COVID-19 recovered patients. In his professional medical opinion: "COVID recovered patients are at extremely high risk to a vaccine. They retain an antigenic fingerprint of natural infection in their tissues. They have all the requisite components of immune memory. Vaccination may activate a hyperimmune response leading to a significant tissue injury and possibly death."

Greetings people of Aloha,

I am opposed to vaccine passports:

In general, you need identification to prove who you are -- your identity as a person.

A vaccine passport attempts to link your identity to a biological or medical characteristic / condition / classification.

That's discriminatory / discrimination and establishes the basis for medical apartheid.

An extremely slippery slope -- in fact, it slides us directly into a pit of segregation and racistlike thought, speech, and behavior.

And that's actually happening right now -- racist-like thinking, speaking, and behaving!

You can see it on Main Stream / Social Media and directly experience it in person!

Vaccine passports will fuel division and rancor among the people of Aloha.

Where will it lead?

Nowhere good for sure -- there's absolutely no doubt about this leading us from bad to worse.

It's like racism, but it's actually worse -- the racist-like segregation is based on an intangible characteristic, something that has been done inside one's body, which is not stable, like one's fingerprints or facial structure; which helps to identify oneself positively; but is volatile / ephemeral, subject to internal (i.e., bodily adaptation to inoculations and boosters) and environmental variables (e.g., viral variants).

A person presenting a vaccine passport cannot be positively "identified" as "clean" / free from "contamination" -- they may be "infected."

The inoculations do not neutralize / kill the original virus nor its variants.

They were designed to lessen the severity of symptoms.

They do not confer immunity nor do they confer non-transmissibilty.

Inoculated persons can still get sick and still transmit virons / viral particles.

We are all in the same boat / on the same island in this regard.

Without a vaccine passport, segregated from society, one is left with subjecting oneself to, in the more or less standard technique, the intrusive medical procedure of a nasal swab that penetrates the nasal cavity up to and in some cases hitting the bone just under the brain, sometimes painfully, not once, but potentially every 48 hours, depending upon the schedule of social activities a person would like to engage in.

And being tested doesn't mean one is free from infection because the testing is and has been flawed -- false positives and false negatives have skewed infection-related statistics.

A person presenting test results that they have to pay for, quite possibly, every 48 hours may be infected as well as someone who has a vaccine passport.

So, in the absence of being able to positively "identify" / segregate people into the underlying categories of infected or not, what are we left with?

Racist-like thinking, speech, and behavior, which is unfounded -- just like it is for real racism!

We are very vulnerable to what is happening in the world -- which goes way beyond the pandemic -- in terms of the implications of being cut off from the world along many different

dimensions (e.g., supply-chain disruptions).

There are questions about each and every thing regarding this pandemic -- from bio-weapons to booster shots -- are we sure we know the truth regarding each aspect of this world-wide crisis?

We need to cut through the "fog" of this pandemic and focus on what really matters -- we need to prepare for worst-case scenarios!

Actually, being on this island is a blessing if we can come together in "The Gathering Place" and make self-sufficiency our goal.

People are going to continue to become sick and, unfortunately, some will die.

Eradicating a natural cornavirus, let alone a pathogen that escaped / was released from a Level 4 Bio Safety Lab, is not very likely because of how many coronaviruses there are (in general) and their ability to mutate.

They're here to stay -- and so are we!

This virus, whatever it is, like the yearly flu, cannot be defeated -- it's now part of the environment -- endemic.

We need to join together to help each other weather this storm and those in the future, like the upcoming flu season.

Analogy: When a hurricane hits our homeland, do we disregard / disparage people that didn't board up their house with plywood, didn't buy a generator, didn't stock up on water?

Do we penalize them for not having the wherewithal to prepare properly?

In the spirit of Aloha, we reach out and provide care and support -- sacrificing some of ourselves for our extended Ohana.

You can take analogies only so far, but hopefully that resonates with you.

Switching back to the pandemic, what really is the crux of the matter -- individuals presenting symptoms of infection that put them at risk.

This is the main thing and the main thing that needs to be addressed, ahead of preparing for global worst-case scenarios.

How can we address symptomatic infections?

Early treatment saves lives!

What is the early-treatment ptotocol that Primary Care Physicians are recommending to their patients?

What early-treatment protocols were used before members of our extended Ohana had to go the ERs?

Being inoculated or not, being tested or not, goes by the wayside once you or a loved one is presenting symptoms of infection, which is going to happen to some people, regardless of their vaccination status.

Early treatment saves lives is much more important than vaccine passports, and deserves much more attention than it has been given.

And a robust early response based on proven clinical protocols by front-line physicians will reduce the pressure on our ERs, hospitals, and our brave and courageous medical staffs.

Idea: Drop the passports and publish early-treatment protocols.
