

RESOLUTION

RELATING TO THE REAPPOINTMENT OF GLADYS A. QUINTO MARRONE TO THE ZONING BOARD OF APPEALS.

WHEREAS, Section 6-1516, Revised Charter of the City and County of Honolulu 1973, as amended ("RCH"), establishes the Zoning Board of Appeals consisting of five members appointed by the Mayor and confirmed by the Council to staggered five-year terms; and

WHEREAS, the major duties of the Zoning Board of Appeals are to hear and determine appeals from the actions of the Director of Planning and Permitting in the administration of zoning ordinances, zoning variances, and subdivision ordinances; and

WHEREAS, by Mayor's letter, dated September 21, 2021, the Mayor has reappointed Ms. Gladys Marrone to the Zoning Board of Appeals; and

WHEREAS, if confirmed by the Council, Ms. Marrone will be reappointed and serve for a term to expire on June 30, 2026; and

WHEREAS, Section 13-103, RCH, which applies to the Zoning Board of Appeals, includes a general qualification requiring a member to be a registered voter of the city; and

WHEREAS, the Council has reviewed Ms. Marrone's qualifications and character; and

WHEREAS, based on the review, the Council finds that Ms. Marrone qualifies to serve on the Zoning Board of Appeals and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body confirms the reappointment of Ms. Gladys Marrone to the Zoning Board of Appeals for a term expiring on June 30, 2026; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Ms. Marrone for her willingness to be considered for public service and actively participate in city government; and
