Aloha, my name is John Silberstein. I prior submitted testimony in support of the proposed Resolution 21-122 that serves to establish a DEPARTMENT of Ocean Safety and Lifeguard Services which removes the current division out from under the superfluous oversight of the Honolulu Emergency Services Dept. (HESD). I also articulated my decades long ocean lifeguarding background. I would like to reaffirm my strong belief that this effort (Resolution 21-234) is not only long overdue, it is the correct course to navigate in the interest of public service and the greater good. The upper leadership at HESD is probably quite versed in the emergency medicine field, ill give them that, and surely there is a component of that element in the ocean lifesaving realm, but, emergency medicine is only a small part of the story for professional lifeguards. 80% of the job is a combination of what I would call "local knowledge", superior physicality both on land and in the water, and most critical, the ability to develop a subject matter expert level of understanding and proficiency when it comes to performing in the dynamic surf and marine environment. Those are the skills that make a great C&C Lifeguard. No disrespect to anyone at HESD, but seasoned ocean lifesavers should be managing ocean lifeguard operations at ALL levels. If the senior leadership have never walked in the shoes of those under their charge, or in this case, "swam in their fins", how can they fully understand the needs, priorities and behaviors of the personnel and facilities they oversee? Lifeguarding is not rocket science, but there is a science to it and I've personally experienced an insulting arrogance from some admin types who assume that managing a lifesaving operation is like a day at the beach.

For example, in 2014 when I took the position of Chief Administrator at Ocean Safety, I discovered that a senior leader at EMS purchased thousands and thousands of dollars worth of swift water rescue gear for OSD. Swift water rescue and ocean rescue both deal with dynamic water, but, that's where the similarities end and are two completely different animals. SWR deals with technical rope rescues usually in raging flood waters. Something OSD will likely never train for nor respond to. To make matters worse, there's very few

geographical areas on Oahu that routinely experience this type of extreme flash flooding like Hilo or a few areas on Kauai. Fire rescue is the proper agency for this response. All of that extremely expensive and specialized gear is probably still sitting in a storage unit somewhere rotting. In my opinion this is borderline fraud, waste and abuse of taxpayer money. These are the kind of mistakes and decisions that are made due to a combination of arrogance and a lack of specialized experience.

All Ego's aside, seasoned paramedics should run EMS, seasoned firefighters should run HFD, seasoned law enforcement should run HPD, and seasoned ocean lifesavers should run OSD.

There is no real measurable benefit for OSD to remain under HESD but tremendous potential in managing their own people and functions.

Its time to match the expertise with the profession.

The Hawaii Fire Fighters Association, Local 1463, IAFF, AFL-CIO ("HFFA") represents approximately 2,100 professional active-duty fire fighters throughout the State of Hawaii and of which, more than 1,000 employees of the Honolulu Fire Department ("HFD") who, oftentimes, co-respond to emergency incidents with the City and County of Honolulu's Ocean Safety and Lifeguard Services ("Ocean Safety") and Emergency Medical Services ("EMS") Divisions. HFFA supports Resolution 21-234, which proposes to establish the Department of Ocean Safety in the City and County of Honolulu Charter of 1973 (Amended 2017).

Currently, individuals employed in the Ocean Safety and EMS Divisions are within the purview of the City's Department of Emergency Services, who oversees, in addition to the two aforementioned divisions, Oahu's Health Services Branch. The Ocean Safety Divisions' Water Safety Officers are primarily responsible for emergencies arising on beaches and near the City's shore waters, which require additional training, educational and risk reduction programs necessary to fulfill their core services with the utmost care. With Ordinance 19-26 (2019) expanding their work hours to encompass all daytime hours, from dusk to dawn, it substantially increased the scope of Ocean Safety services.

Creating a separate department for the Ocean Safety Division would better serve the Oahu constituency because it will provide the department with greater autonomy and expertise and allow the individuals within this department to receive the requisite programs and training for their expanded scope of duties. The autonomy would furthermore allow the newly created department more control of their respective budget to ensure the procurement of resources for its employees and the public they serve.

HFFA recognizes that the Hawaii Government Employees' Association ("HGEA") is the exclusive bargaining representative of Ocean Safety and Water Safety Officers, Bargaining Unit 15 and supports HGEA on the matter.

HFFA appreciates the City Council's favorable consideration of Resolution 21-234.
