WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973 (2000 Edition), as amended, provides the City Council ("Council") with authority to accept gifts to the City; and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City; and

WHEREAS, the policy provides for acceptance of the gift by an affirmative action by the Council; and

WHEREAS, through a letter dated November 17, 2021, approved by the Managing Director, the Interim Chief of Police of the Honolulu Police Department, has submitted a request to the Council for acceptance of a gift to the City from Glen and Sandra Moribe. The monetary gift of \$4,838.31 will be used by the Specialized Services Division's Canine Unit to purchase work-related training and equipment, including a new tent for their custom K9 truck.

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body gratefully accepts the gift of \$4,838.31 from Glen and Sandra Moribe that is more fully described in the above-mentioned letter dated November 17, 2017, and the Declaration of Gift attached as Exhibit A; and


