WHEREAS, if confirmed by the Council, Mr. Anthony will serve for a term to expire on June 30, 2026; and

WHEREAS, Section 13-103, RCH, which applies to the Board of Water Supply, includes a general qualification requiring a member to be a registered voter of the City; and

WHEREAS, after reviewing the nominee's qualifications, the Council finds that Mr. Anthony qualifies to serve on the Board of Water Supply and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that the reappointment of Na'alehu Anthony to the Board of Water Supply be confirmed for a term expiring on June 30, 2026; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Mr. Anthony for his willingness to be considered for public service and active participation in City government; and
