The purpose of the Resolution is to strongly urge the Department of Planning and Permitting ("DPP") to immediately address multiple outstanding violations related to the property at 54-406 Kamehameha Highway in Hau'ula identified as Tax Map Key 5-4-004:021.

At your Committee's meeting on January 13, 2022, the DPP Director testified in support of the Resolution. The DPP Director and the DPP Deputy Director discussed the DPP's numerous and ongoing attempts to achieve land use compliance at this property. The DPP has also coordinated with numerous other City and State agencies and departments to address the ongoing issues. The DPP Director, the DPP Deputy Director, and the Councilmembers discussed the complexity and constraints on the City's enforcement efforts, and what might be done to strengthen enforcement.
