## RESOLUTION

CONFIRMING THE REAPPOINTMENT OF FERNANDO J. FRONTERA TO SERVE ON THE BUILDING BOARD OF APPEALS OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 16-1.1(13), Revised Ordinances of Honolulu 1990 ("ROH"), establishes the Building Board of Appeals ("Board") consisting of nine members who are appointed by the Mayor and confirmed by the Council to five-year terms; and

WHEREAS, Section 16-1.1(13), ROH, provides that the Board has the duties of hearing and determining the following:

- (1) Appeals of decisions regarding the administration of the Building Code, Electrical Code, Plumbing Code, Housing Code, Fire Code, Building Energy Efficiency Standards, and building permit ordinance;
- (2) Petitions for variances from the Building Code, Electrical Code, Plumbing Code, Fire Code, and Building Energy Efficiency Standards;
- (3) Appeals of decisions regarding the administrative enforcement of the litter control ordinance; and
- (4) Appeals concerning the summary removal of unlawful signs from street rights-of-way and public malls;

#### and

WHEREAS, by Mayor's letter, dated January 10, 2022, the Mayor has reappointed Mr. Fernando J. Frontera to the Building Board of Appeals; and

WHEREAS, if confirmed by the Council, Mr. Frontera will be reappointed as an Engineer/Architect member on the Building Board of Appeals and serve for a term to expire on December 31, 2024; and

WHEREAS, Section 16-1.1(13), ROH, establishes a general qualification requiring four members of the board to be "currently licensed as engineers or architects with the State of Hawaii board of registration of professional engineers, architects, land surveyors, and landscape architects"; and
