DPP's recommendation to deny the Resolution was adopted by the Planning Commission on 11/24/21. An alternative proposal for farm worker housing is included in the LUO Update that will be heard by the Planning Commission on 1/18/22.

The DPP's recommendation is due to the Planning Commission by 5/11/22.
