As a resident of O'ahu and a water drinker, I strongly support Bill 48, requiring any operator of underground storage tanks with a capacity of 100,000 gallons or more, to obtain a permit from the City. It further stipulates that no permit will be granted unless the applicant proves that the tank or tank system will not leak regulated substances into the environment. We simply cannot permit underground storage tanks of that capacity or larger that pose such immense threat of leaking and contaminating our environment and water supply.

Dear Chair Waters, Vice-chair Kia‘āina, and honorable Council Members,

My name is Sabrina Cohan. I am a sixteen year old student living in Honolulu, and I am writing to you today to express my strong support of Bill 48.

Clean drinking water is a human right, and the operation of the Red Hill fuel tanks puts this right in jeopardy. The recent leakage of the tanks was not sudden, and there have been many warning signs throughout the years as to the tanks' structural instability. If the tanks are allowed to continue holding fuel 100 feet above Oahu's main aquifer, there is no guarantee that they will not leak again. I acknowledge that the Navy views the tanks as a national security asset, but the health of Oahu's residents cannot be compromised upon. The tanks must be decommissioned before the state of our aquifer deteriorates.

Bill 48 would prevent future crises of this sort before they begin, and would help to protect the right to clean water for the residents of Oahu for generations. This bill is vital to the continued health of the island, and to the protection of Oahu's environmental integrity. Our islands are beautiful, and should be protected, not exploited as a military asset.

As a young person living on Oahu, I am extremely passionate about environmental issues and protecting the natural beauty of this island for future generations. I also believe firmly in finding equitable solutions to environmental problems, and lifting up the minority communities affected most by environmental crises. The contamination of our aquifer is an issue of environmental justice, and poses serious threats to those communities that would not have the means to access fresh water should our groundwater be irreversibly harmed.

I appreciate your consideration of this bill, and would like to thank those who have fought for our right to clean water for decades. On behalf of the youth of Oahu, I hope that this council will pass Bill 48.

Dear Chair Waters and Council Members,
The tenuous condition of the Navy's Red Hill fuel tank installation has troubled local people for decades. Unfortunately, with the recent leaks on May 6, 2021, and November 20, 2021, and the knowledge that the Navy concealed information about past leaks, the situation has become increasingly perilous. Thus, representing the interests of our 4,100+ members, who are residents of Mānoa, the Mālama Mānoa Board of Directors implores the Honolulu City Council to vote in SUPPORT of Bill 48.

While we appreciate the mission of the Navy, we are seriously concerned with the lack of environmental stewardship at the Red Hill site. Specifically, we question the service life of the tanks, since they were constructed between 1940-1943, and are now in a dire state of erosion. The Navy's approach of cleaning, inspecting, and patching is not sufficient to protect the people living in Honolulu's primary urban core.

The scientific data that has been collected at the site does not provide ample evidence that the Navy is able to effectively maintain and operate the site safely until 2045. Consequently, we strongly support the Board of Water Supply's recommendation to move the fuel away from the aquifer into above ground storage tanks, and to reinforce the tanks with a secondary containment system. Also, we expect each tank and alarm system to be inspected more rigorously and frequently, at least annually. Furthermore, the Navy should be transparent and cooperate with BWS and DOH.

In Hawai'i, our watersheds have been revered and carefully managed with the ahupua'a system, which was created centuries ago by the High Chief Mā'ilikūkahi. Our people are just as precious as those living

in Manchester, Washington and Point Loma, San Diego, California, where the Navy relocated and improved other fuel tank facilities. Clean, fresh water is essential for life, and we deserve the equal treatment by the Navy to protect our constitutional right to life. We ask that the City & County of Honolulu, in coordination with DOH and the EPA, do whatever is in its power to expedite remediation of this disaster.

Aloha Chair Waters, Vice-chair Kia'āina, and Honorable Council Members,

The Hawai'i Youth Climate Coalition stands in **strong support of Bill 48**. HYCC is a youth-led, youth-founded organization dedicated to taking on the climate crisis through just and equitable means. Along with championing climate action, we value protection of land and water rights, and see the right to clean water as non-negotiable.

Bill 48's passage is important for addressing the Red Hill fuel tanks and future threats of leakage by storage tanks holding over 100,000 gallons of petroleum products. The leakage of the Red Hill fuel tanks is a threat to human welfare and our 'āina. It is of paramount importance that we, as a community and as a whole, should care for each other and put our health first. Additionally, we must malama 'āina and protect this spiritually, culturally, historically, and environmentally rich land. We cannot risk putting our people or our land in harm's way even further. This anti-environment episode is frankly unacceptable, and needs to be dealt with correctly and swiftly. We demand full transparency and accountability from the U.S. Navy, while ensuring adequate mitigation measures and safeguards are implemented to ensure this does not happen again. We cannot wait for further humanitarian and environmental disasters to occur with regards to the Red Hill fuel tanks.

As Bill 48 mentions, "eight of the currently operating tanks at the Facility have not been inspected pursuant to modern standards in more than two decades and are overdue for inspection." We need timely assessments followed by active responses to prevent disasters like the Red Hill fuel leaks in 2014 and this past November. In the past few months, the Navy has been pushing back against the removal of these tanks for the sake of national security, but public health is just as much of a national security asset as military operations are. The importance of our health and well-being should not be up for debate. If Bill 48's actions are implemented, and operators are required to have permits and be under stricter surveillance, we could prevent future fuel tank leaks and protect our community's health before the damage has been done.

As youth climate activists, we work towards replacing destructive practices with cleaner alternatives. For example, there are ongoing efforts to create sustainable aviation fuel as a possible alternative to harmful petroleum fuel. We appreciate that Bill 48 is working towards reducing the petroleum products that lie over the aquifer that supplies our drinking water. We

would like to thank those who have been at the forefront of this issue for several years, serving as trailblazers for the sake of our community, and to those who are taking firm action now to ensure that this same crisis does not plague our children and their futures.

We hope that this committee will pass Bill 48, and mahalo for considering our testimony.

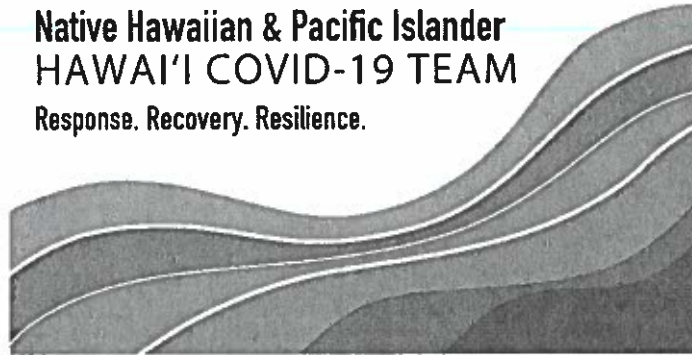

BILL 48: RELATING TO UNDERGROUND STORAGE TANKS
HONOLULU CITY COUNCIL REGULAR MEETING
THURSDAY, JANUARY 26, 2022 AT 10:00 A.M.**

We, the NHPI 3R Team, write to reiterate strong support for Bill 48 and urge the Honolulu City Council to pass this measure as a critical protection against any further loss of life or harm from the damage caused by the Red Hill Bulk Fuel Storage Facility. The history of spills, leaks, violations of environmental safety regulation, contesting of violations by the Navy, withholding of critical information by the Navy, and most recently, active endangerment of military personnel and families, shutdown of the Red Hill water shaft without appropriate and timely notification to the Board of Water Supply, shutdown of the Hālawā water shaft, and the dismissal of the Emergency Order to immediately defuel the Red Hill Bulk Fuel Storage Facility each stand as actions that did not center safety and health. Further details about the missteps and failures reflected this history are available widely for public review. We contend that the evidence appears to converge on two conclusions: first, that the only solution at this time is immediate defueling of the Red Hill Bulk Fuel Storage Facility; second, that the context of placing the Red Hill Bulk Fuel Storage Facility above a single source aquifer was never safe – not in 1940 and certainly not in 2021.

We are the Native Hawaiian & Pacific Islander Hawai'i COVID-19 Response Recovery Resilience (NHPI 3R) Team, a collective of over 60 Native Hawaiian and Pacific Islander organizations established in 2020 with more than 100 active volunteers who are health experts. Our statewide network, in alignment with the national NHPI Response Team (now the National Association of Pasifika Organizations), initially convened to work in various components of addressing COVID-19 for Native Hawaiians and Pacific Islanders through a variety of vehicles. As the immediate issues in COVID-19 have brought more attention to the disparities facing our communities, our work has expanded to prioritize health equity work by addressing systemic issues and root causes for the health of NHPI families who makeup more than 27% of the Hawai'i population according to the U.S. Census 2020.

As public health and population health experts, community advocates, and trusted leaders, we emphasize the need for actions such as Bill 48 and Resolution 21-276, which contribute towards protecting the communities that are too often overlooked or left behind in public policy but bear the most burden from public health and safety failures. We fully support and applaud the Honolulu City Council for calling a special meeting to address the time-sensitive environmental disaster that is Red Hill, which reflects the immediacy emphasized by grassroots and community-based organizations. Everyone needs clean water in order to live. Our precious island home provides natural resources that need intentional, thoughtful stewardship and fierce protection. The NHPI 3R Team underscores that water is an essential determinant to human life and collective health.

We support the pressing need to defuel Red Hill immediately as the sole solution and the passage of Bill 48 as a step towards that solution.

RE: Bill 48, CD1 – Relating to Underground Storage Tanks

Aloha e ka Luna Ho'omalua Waters, ka Hope Luna Ho'omalua Kia'āina, a me nā Lālā o ka 'Aha o ke Kūlanakauhale a me ke Kalana o Honolulu.

Kamehameha Schools recognizes that the health, well-being and resilience of Hawai'i's communities directly impact the ability of our keiki to succeed in their educational journeys and in life. There are few things as critical to the health of our community as access to clean water.

We are deeply concerned that discharges from the Navy's Red Hill Bulk Fuel Storage Facility have contaminated O'ahu's Southern Basal Aquifer, negatively impacting the health of those families that rely on the Navy's Red Hill and 'Aiea-Hālawā shafts for water. We are further concerned that these contaminants could spread to other water sources that our community relies on and into our environment.

The health and safety of our keiki and the environment in which they live is important to Kamehameha Schools. Therefore, we applaud the Honolulu Board of Water Supply for taking the precautionary measure of closing its Hālawā shaft, 'Aiea well, and Hālawā well, to reduce the risk of spreading contaminants to other water sources.

If this issue is not promptly addressed and the risk of future discharges is not mitigated, the ongoing health concerns and potential decrease in available water, as the Board of Water Supply has alluded to in its public statements, could result in significant long-term impacts for all of O'ahu. A reduction in water supply could result in a decrease in economic and other social activities, and a halt in much-needed housing development. For a community still being impacted by COVID-19 and in the middle of a housing crisis, these impacts could be profound and last for years to come.

For these reasons, we greatly appreciate the work done thus far by leaders across our community to identify the source of contamination and prepare and execute plans to address the immediate crisis and mitigate ongoing and future risks. We recognize much more must be done to ensure that the threat to our precious water resources is eliminated and thank the Council for its

leadership in seeking solutions. We continue to believe that greater transparency and information sharing are essential so that potential solutions, such as those being considered by the Council, can be thoroughly reviewed for feasibility and effectiveness, including with community consultation.

For these reasons, we encourage the Council to take action to address this issue that has the potential to critically impact the well-being of all O‘ahu residents.

Aloha Chair Waters, Vice Chair Kia'aina, and Members of the County Council,

My name is Camile Cleveland, and I am submitting testimony in support of Bill 48 on behalf of the Surfrider Foundation O'ahu Chapter and our thousands of volunteers, members and supporters. The Surfrider Foundation is a national nonprofit organization dedicated to the protection and enjoyment of our ocean, waves, and beaches. Surfrider maintains a network of over 180 chapters and student clubs nationwide, including 4 chapters in the Hawaiian Islands. The Surfrider Foundation focuses on many aspects of the environment such as coastal protection, plastic pollution, and water quality.

We are testifying in support of Bill 48 in order to ensure Oahu's primary drinking supply does not continue to be contaminated with petroleum.

Clean drinking water is a basic right for all people, and ensuring that "no underground storage tank or tank system that contains a large volume of petroleum product should be allowed to operate above a sole source aquifer on O'ahu unless it can be established that the tank will not release any regulated substance during its operating life" is an important and logical step in order to maintain that right for the people of O'ahu.

The large petroleum tanks at Red Hill Bulk Fuel Storage Facility have been leaking tens of thousands of gallons of fuel for over twenty years, fuel which inherently seeps into the nearby aquifer and enters our island's **primary source of drinking water**. Based on the Quantitative Risk and Vulnerability Assessment of the Facility quoted in the Bill, which was prepared for the Navy in 2018, we have near certainty (a 96% risk) of an acute leak happening in the next ten years. The knowledge that there undoubtedly be continued leaks from the tanks is a clear sign that they should be better regulated and decommissioned **for the safety and health of the island's people**.

This bill is a critical measure to ensure clean drinking water for a majority of the population of O'ahu and to avoid a massive health and safety crisis on the island. Thank you for your consideration of this testimony in strong support of Bill 48, submitted on the behalf of the Surfrider Foundation's O'ahu Chapter and all of our members and supporters.
