ACCEPTING A GIFT VALUED AT \$14,465.22 FROM BUMPER PRODUCTIONS LLC FOR OCEAN SAFETY DIVISION'S JUNIOR LIFEGUARD PROGRAM, REPAIRS TO A LIFEGUARD STATION AND AN ICE MACHINE FOR THE HAUULA TRAINING FACILITY.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973 (2017 Edition), as amended, provides the City Council ("Council") with authority to accept gifts to the City; and

WHEREAS, Resolutions 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City: and

WHEREAS, the policy provides for the acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, approved by the Managing Director, the Director of Honolulu Emergency Service Department has submitted a request to the Council for acceptance of a gift to the City from Bumper Productions LLC valued at \$14,465.22 for an ice machine for the Hauula Training Facility valued at \$6,215.22, repairs to a lifeguard station at Pupukea Beach Park (also known as Rock Piles) valued at \$1,000.00; and monetary donations of \$4,750.00 and \$2,500.00 to support the Junior Lifeguard Program to reopen in summer 2022; and

WHEREAS, the description and value of the gifts are set forth in the Declaration of Gifts attached hereto as Exhibits A-D and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift valued at \$14,465.22 from Bumper Production LLC that is more fully described in the above-mentioned letter and the Declaration of Gifts attached as Exhibits A-D; and
