PUBLIC HEARING/SECOND READING

BILL 41 (2021), CD1 – COMMITTEE REPORT 8

A BILL FOR AN ORDINANCE RELATING TO TRANSIENT ACCOMMODATIONS.

Councilmember Elefante moved that Committee Report 8 be adopted and Bill 41 (2021) pass second reading as amended to CD1. Seconded by Councilmember Kiaʻāina.

Councilmember Fukunaga stated that in discussion, each region has their own issues that need to be addressed. She stated that she will vote in support of the measure because of the many monster homes in her district, the many complaints that she continues to receive, and the listing that she has seen on-line of illegal vacation rentals within her district. Councilmember Fukunaga stated that she is hopeful that the Council will come up with a more complete set of solutions and that it may not all fit within the same Bill but that it is a good time to understand the various kinds of concerns that may arise within different regions.

In response to councilmembers, Eugene Takahashi, Deputy Director, Department of Planning and Permitting (DPP) stated that:

 The DPP is implementing the enforcement in Ordinance 19-18 and thanks to the Council the DPP staff and inspectors have additional tools to enforce advertising and they are still enforcing reoccurring violations for advertisements.

- A public hearing on the rule making raised numerous concerns, so the Administration decided to re-evaluate their position on the rules. As a result, the current Bill was proposed.
- The DPP is working with Councilmember Elefante and the Planning and Zoning Committee on the concerns regarding Bill 41 (2021).
- One of the issues of Ordinance 19-18 is the 30-day enforcement. He stated that the City had good intentions when the bill passed but there are those that intentionally try to get around the system which is a challenge for the DPP.
- The last Ordinance corrected the previous concerns of zone A-1 and A-2. The DPP
 has a list of Nonconforming Use Certificates (NUC) that are allowed outside of the
 resort area but they do not have a registration process for permitted uses within the
 resort area because it is not allowed at this time.
- The DPP does not have a dedicated unit to do short-term rental enforcement which makes it challenging because staff also has to deal with other enforcement issues.
- The rules have not been adopted but the adopted Ordinance allows the DPP to enforce illegal advertisements.
- COVID is one of the many factors taken into consideration because some people
 use short-term rentals to circumvent the quarantine requirements imposed by the
 State.
- If a condo consented to a short-term rental then the City could consider that as part
 of the registration process for the new short-term rental units that would have been
 or could have been established under the previous ordinance. The Association of
 Apartment Owners would have to consent and provide documents to the City as part
 of the record that they have consented to the conversion of the building to shortterm rental.
- The registration process would require the DPP to confirm the legality of information provided by the legal owners.
- The DPP is open to discussion with Airbnb, Expedia and other platforms that advertise short-term rentals.
- The DPP is considering forwarding the Primary Urban Center Development Plan to the Planning Commission.

- Since the City allowed NUC registration back in the '90s, nothing has been adopted since 1990 to address short-term rental and short-term rentals have escalated and need to be addressed. Also, the registration process was closed and no one else could establish a legal short-term rental anywhere else.
- Anyone who has a legal NUC who rents out their entire home is taxed at the
 residential rate unless Real Property assessed them at the highest and best use
 which could result in a higher assessment.
- Pursuant to the last Ordinance, the NUC numbers need to be published and that will help the City validate the registration number is associated with the property which will help with enforcement.
- The DPP can look at reinserting the language to ensure that platforms are responsible for their content.
- The DPP would need to look into the Residential Landlord Tenant Code because the Bill as currently proposed is greater than 30 days and if the language were left in there would be a conflict.

In response to Councilmember Say, Duane Pang, Deputy Corporation Counsel, Department of the Corporation Counsel stated that:

- The Land Use Ordinance in addition to the Building Code and Electrical Code has both an administrative enforcement provision and an ability for the Directors to refer the matter to the Prosecutor.
- If there is a homeowner's association that has taken a vote that prohibits short-term rentals then the homeowner's association would prevail over the permitted use. The City does not want to override the private decision by the homeowner's association.
- As Deputy Director Takahashi indicated, the resort area and now the Kuilima, Ko'Olina and the Gold Coast areas would be allowed short-term rentals; however, now for the first time they must register and pay a registration fee.

In response to councilmembers, Mike Formby, Managing Director stated that:

 He would need to get back to the Council regarding whether the Administration supports a proposal for seven more enforcement positions in DPP.

 Short-term rentals is a priority for the Mayor and the primary way this can be discussed with the public is through the Council process that was heard from the testifiers today.

Councilmember Kiaʻāina thanked Chair Elefante and his staff for the version of the Bill. She stated that despite her disappointment that there is no full implementation of the MOUs between Airbnb, Expedia and DPP, she believes that this version of the Bill significantly improves the City's ability for enforcement. Councilmember Kiaʻāina encouraged the DPP to look at how the City can replicate Kauai's partnerships with hosting platforms. She stated that prohibiting advertising of daily and/or weekly rates, should be looked at, including fees, expansion, density maximum, property tax, and duration. Councilmember Kiaʻāina stated that she is concerned that the current version of the Bill took out the exemptions for individuals and her position will be determined by the length that will distinguish a short-term rental from a long-term rental.

Councilmember Elefante thanked Chair Waters for having this measure on the agenda and also to those that testified. He stated that the Bill is a work in progress and is an improvement from what was transmitted by the Planning Commission and proposed by the Administration. Councilmember Elefante stated that in Committee he will take a closer look and re-evaluate the provisions contained on page 26 and 33, on page 16 and 18 which relates to the Gold Coast, KoʻOlina and fines; on page 26 multi-family dwelling density limit, and the enforcement provisions. He asked councilmembers for their support and passage of the measure on second reading. Councilmember Elefante stated that this will not be the final version and anticipates that there will be other changes and provisions in working with the DPP, stakeholders, and councilmembers.

Councilmember Tsuneyoshi expressed her appreciation to Deputy Director Takahashi and Zoning Chair Elefante for working on the measure and noted that more work still needs to be done and that she looks forward to continued discussion in Committee. She thanked everyone who called in by Zoom and stated that their testimony is very important. She noted that she heard the frustration and concern from the testifiers regarding the fees. Councilmember Tsuneyoshi thanked the DPP in trying to fine tune Ordinance 19-18 and to do enforcement. She stated that she will vote with reservations on the measure because there are more issues to be worked on and looks forward to working with the Zoning Chair, Chair Waters, the DPP, councilmembers, and the community.

Councilmember Tulba stated that he has reservations on the measure. He noted that legal vacation rentals have been very disruptive in the residential community and he believes that Bill 41 (2021), CD1 is a step in the right direction. Councilmember Tulba stated that he

wants to make sure the City is fair to the residents that own transient units in the resort areas because he believes that they are a very important part of the solution. He noted that this issue is about encouraging the right uses in the right places and he looks forward to further discussion.

Councilmember Tupola thanked the Director, the Department, the Managing Director, the Zoning Chair, and everyone for their comments, including the testifiers. She apologized to the Zoning Chair and stated that she will be voting no on the measure and also noted that she voted no when the measure first came out because of the way it was transmitted, the amount of errors that were in it and the amount of amendments that were needed. Councilmember Tupola also stated that she cannot support the Bill because of the lack of stakeholder engagement, the need for current enforcement, consistency and uniformity, the jump in fees, and the lack of careful consideration of how to protect legal residents. She stated the we should be careful and mindful in the way that the measure proceeds and maybe take a step back and see if a better foundation can be laid to do what is right for the residents of Hawai'i.

Councilmember Cordero thanked the Department, Zoning and Planning Chair and his staff, and the Office of Council Services for their great work on the CD1. She stated that she voted no in committee and noted that she would like to see this Bill move forward along with the budget process. Councilmember Cordero expressed her concern regarding the huge jump in fines, the initial fines, as well as other concerns that were brought up during the hearing. She stated that there may be legality issues. Councilmember Cordero stated that she will be voting no on the Bill.

Chair Waters thanked councilmembers for all the comments and questions. He expressed his confidence that Chair Elefante will listen to everyone and their comments as well as the community. Chair Waters stated that by not doing anything, the City is failing. He noted that prior to the pandemic, there were 10 million visitors and the hotel industry said that they can only accommodate about 7 million so the question of where are those 3 million people staying should be discussed.

Councilmember Elefante stated for the record that he filed Disclosures of Interest with the City Clerk's Office (CC-17, CC-18, CC-19).

- They are resetting how to review the affordable housing plan from homelessness to affordable housing. It is a little complex with different components and they are working on the plan. They put out the solicitation for the \$40 million of affordable housing fund money and should start to get responses in February and will review those properties with the Council.

Councilmember Cordero stated that she is glad that Executive Director La Chica has joined the City and thanked the City Administration, the Managing Director, and the Mayor. She noted that she has experienced Executive Director La Chica's work in the community.

- They understand and respect the rights of the kuleana homeowners and landowners and are obligated to provide them access to their land in Punaluu and they are committed to honor this obligation and make sure it happens.
- This is a big construction project and at times for safety reasons, the access will
 need to be re-routed but they will work with the kuleana owners to provide a safe
 route to their land.
- In 2016, they received their first Special Management Area Use Permit (SMA) and engaged with the Punaluu Community Association, the Koolau Neighborhood Board and have attended the bi-monthly community association meetings to provide regular updates on the project.
- In November 2021 they attended meetings with the association, the Neighborhood Board, the Zoning Committee, individual councilmembers, and the Punaluu farmers to provide the updates.
- There is a lot of community engagement that needs to happen and that this project is intended to help the community by mitigating flooding.
- They meet with the community often and regularly as needed to answer their questions and concerns.

Councilmember Tsuneyoshi thanked Kamehameha Schools for being open to continued discussions. She stated that some community members may not have been involved and that she will be going out to the community for a site visit to see the area of impact. Councilmember Tsuneyoshi stated that there is a lot that can be done to continue to ensure the confidence in the community. She believes that it is important to continue the engagement with the community and the kuleana landowners and would be happy to be a part of that.

Councilmember Kia'āina would like Kamehameha Schools to do a better job on community outreach and would like them to treat the kuleana landowner separate from what is done for outreach on this project because their specific interest is ensuring that their rights to water and access is not infringed upon because of the project and that it is good community outreach to take care of someone who is in your ahupua'a. Councilmember Kia'āina would like the kuleana landowners to be treated appropriately and not just like the general public.

Councilmember Elefante thanked Kamehameha Schools for staying and addressing the concerns raised by councilmembers and appreciates the feedback and the willingness to work with the parties that may be impacted by the SMA permit.
