


Bringing the City's Enterprise Resource Planning platform into the 21st Century

Salaries

(\$413,835) (4.22%)

 PVP reductions are higher than in FY22. In addition the attrition of higher paid senior analysts, hiring at lower level entry level developers adds to the lowered salary costs.

Current Expenses

\$3,022,224 23.27%

 Increased costs are due to the reinstatement of costs for maintenance and telephone expenditures which were cut in FY21/FY22. Along with this is a one-time increase for funding of the Chinatown Cameras.

Equipment

\$190,000 28.79%

 Budgeted costs for Network Leaf Switches and Increased Storage Capacity exceeded the equipment request made in FY22.




