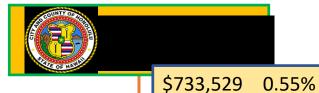


Who we are...

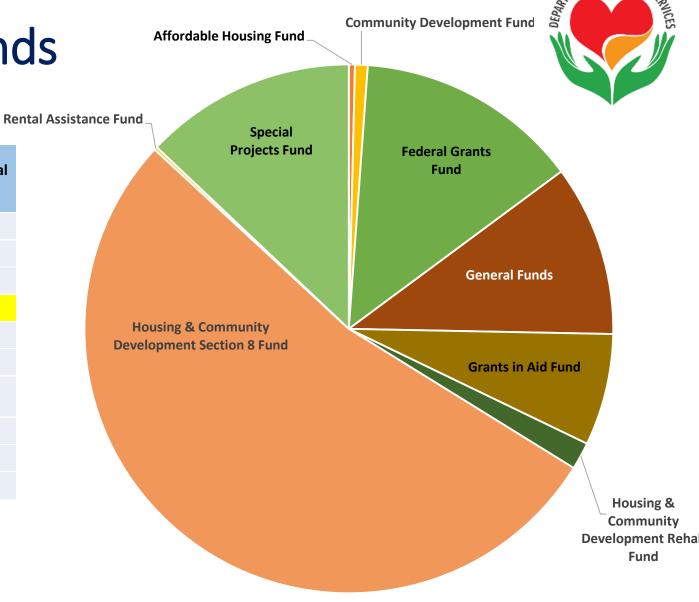

\$9.3 million Grants in Aid funding supports at least 61 grants. \$66.7 million federal funding supports over 3,900 Section 8, Family Unification, HUD VASH, Emergency Housing Voucher program rental vouchers. \$14.6 million state and general funds supports programs addressing homelessness, with 375 Housing First vouchers, Hale Mauliola, Punawai Rest Stop, transportation, and landlord engagement. \$15 million state and federal funds for sub-recipient grants, which provide assistance services to help 40,000 older adults remain in their homes and age in place.

\$1.7 million federal funding supports subsidies for 100 qualified renters participating in the Tenant Based Rental Assistance program. Sources of Operating Funds
