	Waikiki was a gathering place for families long before portable amplifiers were invented.
	There is still a large and very diverse community of at least 25,000 long-term, full-time residents who live mauka of Kuhio who have come from all over O'ahu, the outer islands, various states, and many countries to make it their home. People move to Waikiki because it is an urban neighborhood with several dozen apartment and condo buildings - many of which have lodged residents for over 80 years. Portable amplifiers blasting noise that can be heard in the residential neighborhood is NOT a tradition and is NOT why people move to Waikiki.
Written Testimony	In addition to being neighbors, the residents of Waikiki - as well as many jetlagged tourists - are a CAPTIVE AUDIENCE to the nonstop, highly amplified music and noise on Waikiki sidewalks. These people have rights, too. Attached please find a May, 2021 letter from the former condo board president of the Governor Cleghorn regarding the amplified noise from Kalakaua that affects the quality of life of residents mauka of Kuhio.
	Residents have personally asked Kalakaua street performers to meet them halfway by suggesting ways to have a win-win situation to respect each other's rights. Residents asked a group at the corner of Kalakaua and Kaiulani to simply lower their volume, but that never happened. They suggested moving to another area so that the sound would not go up Kaiulani Ave, but they didn't do that. They later asked if the band would just kindly place their loudspeakers on the ground instead of several feet high on poles, or to turn the loudspeakers to project parallel to Kalakaua instead of toward the Apartment Precinct - but each suggestion was
	met with, "We know our rights!!!", even though the rights to freedom of expression were never in question in the first place. It was simply the residents begging for two-way understanding

and human compassion that was never realized.

Trying to solve the problem with personal contact and also calling HPD have been futile; therefore I STRONGLY SUPPORT Bill 43 CD1 TW1 which will legislatively impose a fair compromise between the performers' and residents' rights. Mahalo for your kind understanding and consideration to pass Bill 43.

Dear Governor Ige, Senator Moriwaki, Representative Tam, Mayor Blangiardi, City Council Chair Waters, Rick Egged (Waikiki Improvement Association) and Bob Finley (Waikiki Neighborhood Board):

Residents in our Governor Cleghorn building located on Ka'iulani Ave between Kūhiō and Ala Wai Blvd have been subjected to highly amplified music from several street performers a few blocks away on Kalākaua Ave on almost a nightly basis for the past several weeks; most particularly Thursday through Sunday nights.

This was a problem before the pandemic, and we would like to address this now before even more street performers descend upon Kalākaua with their amplifiers as tourism returns. We do not believe that amplified music would be tolerated in any other commercial zone on the island, so why is it allowed in Waikiki? We ask that if there is currently no law against such amplification, that one be enacted. If there is a law, then we need it to be enforced because calls to HPD have not been effective.

While we have no objection to street performers or their freedom of speech and expression, the amplification of it has become a noise nuisance to us as residents trying to enjoy an evening at home in Waikiki's residential Apartment Precinct. Many residents in our building are forced to close all their windows to try to minimize the amplified sound in the distance. It is not a matter of whether or not the sound in the distance fails a decibel reading test from our lanais, but a quality of life issue and a matter of common courtesy and respect for residents and tourists alike.

Our building's residents are not alone. The nonstop noise on the sidewalks for several hours each evening would also be a nuisance to employees and jetlagged tourists at the Moana Surfrider, Outrigger Waikiki Beach Resort, and Princess Ka'iulani hotels, as well as to patrons and employees of the many shops and restaurants along Kalākaua.

We ask the Waikiki Neighborhood Board and the Waikiki Improvement Association to support us in asking our legislators to work together to quickly curtail this unnecessary source of noise nuisance. We thank everyone for your kind consideration.

	I support this bill not because I want quieter street performers, but because I want *better* street performers.
	When you allow amplification, whoever can afford the loudest speakers draws the biggest crowds.
	When we ban amplification, we go back to the roots of street performing anyone with an instrument can sit down and start playing.
Written	If they have enough talent, they'll draw a crowd.
Testimony	A single person playing a simple, pleasant melody on a ukulele has no chance of competing when someone is 10 feet away belting out tunes on a microphone, into a speaker blaring a karaoke track.
	I support street performers. They bring energy and excitement every night to Waikiki. But there is no reason to use amplification on a 10 foot wide sidewalk unless you just want to compete by being louder than everyone else. Banning amplification will prune out the performers who are relying on technology rather than talent.
	Banning amplification will also increase the number of opportunities for street performers, because more of them will be audible in a given amount of space.
	G
	Now to talk about the noise. I think Waikiki residents should expect a certain amount of

noise and the sounds from Kalakaua don't keep me up. But when I do go down there -- I have a small child and he loves the street performers -- I just don't want him to get permanent ear damage while watching them. Older relatives who come to Waikiki can't enjoy the music either, it doesn't come through well with their hearing devices.

In short - banning amplification will mean more street performers, better street performers, and that more people can enjoy the street performers. That's what I want to see.

I urge you to support this bill.

As the elected State Senator and State Representative of Waikiki, we testify in **strong support** of Bill 43 relating to amplified sound in Waikiki. As you know, Waikiki is a unique neighborhood in that residential apartments are located adjacent to resort and mixed-use areas attracting high pedestrian activity. It is commonplace for people to produce amplified sound from sidewalks for various reasons whether they are unauthorized street performers or people playing recorded music loudly.

Our offices receive regularly (almost daily) complaints of sidewalk noise generated from amplified noise (amongst other noise). The excessive noise disturbs the quality of life for residents and visitors alike. While we have been working with the Department of Health Noise Branch, Honolulu Police Department and the Liquor Commission to work on administrative solutions, Bill 43 would effectively prohibit the playing of amplified noise from sidewalks at levels exceeding a yet to be determined decibel level and provide for violation penalties. It would allow police to enforce against unwanted noise using a sound meter that measures by decibel, which they cannot now do.

We appreciate Bill 43 for the above reasons. It will help our community and others afflicted by excessive noise. Please pass Bill 43 for our community safety and health.
