Councilmember Tulba moved that Committee Report 56 be adopted and Bill 47 (2021) pass second reading. Seconded by Councilmember Tsuneyoshi.

In response to councilmembers, Laura Thielen, Director, Department of Parks and Recreation (DPR) stated that:

- DPR has concerns with the Bill because the bill goes directly to criminal citations and she believes that may not be the most effective way to reduce unauthorized activities in the parks. She also stated that they have the same goal as the Council, to have increased enforcement of the park rules.
- The American Rescue Plan Act (ARPA) Federal Recovery Fund Committee voted to support the City's Park Ranger Pilot Project.
- DPR would like to work with the Council to set up details of the Park Ranger Pilot Project and do a quarterly report of the findings and then to evaluate how to move forward to improve enforcement in the parks.

- The Bill amends a portion of the Ordinance that allows the Police Department to issue citations for a violation and then to arrest the person. She stated that another option to consider - the Building Department utilizes a noncriminal process under a separate section of the Honolulu Revised Ordinance in which a notice of violation is issued.
- The Park Rangers will not have enforcement authority and part of the pilot project will be for the Park Rangers to go out and get information the City needs to establish an effective enforcement system. They will also be working with the Corporation Counsel and the Honolulu Police Department (HPD) to determine whether a civil or criminal path would be more efficient for enforcement.
- DPR is also considering whether to set up a separate park enforcement authority similar to the Department of Land and Natural Resources, Division of Conservation and Resources Enforcement or continue with the Honolulu Police Department dealing with dangerous situations.
- She will look into whether the City or the State would receive the fines if a citation is issued and she would also propose a solution for the fines to go to the City.
- In the past, an HPD section dealt with park enforcement. She stated that the one position funded with Federal monies would be for a park manager who would review what was done in the past and what could be done in the future.
- The presence of workers and staff at City parks varies by the location and the number of people using the parks.

Councilmember Tsuneyoshi stated that she sees the need for legislation to clearly share the Council's desire to have a better handle of enforcement in the parks. She noted that Bill 37 can help DPR with enforcement and is glad that the DPR currently has a pilot program. Councilmember Tsuneyoshi stated that although ARPA will be discussed in the Committee on Housing and the Economy, a lot of decisions have already been made and discussed in the ARPA Committee that the general public has no knowledge of. She noted that she looks forward to the discussion on ARPA in the Committee on Housing and the Economy. Councilmember Tsuneyoshi stated she is in support of the measure and looks forward to the measure going back to Committee to have more discussion on the pilot program.

Chair Waters stated that the hard work is at the committee level, working with the Parks Chair and the Department of Planning and Permitting to learn how they issue their citations. He noted that he agrees with Councilmember Say that the fines should not go to the State and that the idea would be to mirror the language calling for civil penalties. Chair Waters asked councilmembers for their support on the measure.

Councilmember Fukunaga moved that Committee Report 44 be adopted and Bill 37 (2021), CD1 pass third reading, as amended to CD2. Seconded by Councilmember Kia'āina.

Councilmember Fukunaga provided councilmembers with copies of the Committee Report for Bill 37 (2021), CD2 and other documentation regarding the measure. She stated that the Bill does three things, it provides a short extension of time from May 3, 2022 to August 31, 2022 for condo or co-op associations to submit their Life Safety Evaluations to the Honolulu Fire Department; it extends all other compliance deadlines by five years; and it increases transparency and accountability on the part of the design professionals to require the scores in each category conducted be provided in writing to condo and co-op associations, their unit owners, and requiring the Honolulu Fire Department to include the aggregate Life Saving Evaluation score for each building on its website. Councilmember Fukunaga urged councilmembers to vote in support of the measure.

Councilmember Elefante thanked Councilmembers Fukunaga and Tsuneyoshi for their hard work. He explained his no vote in Committee; however, noted that he will be voting in support of the measure with reservations because of the explanation that Councilmember Fukunaga provided regarding extending the deadline by several years to accommodate compliance.

Councilmember Tsuneyoshi acknowledged the hard work of Councilmember Fukunaga. She stated that Councilmember Fukunaga took on the daunting task of trying to understand how the residents who live in the condos were feeling, working with the Honolulu Fire Department, and coming up with the best possible outcome.

Chair Waters thanked Councilmember Fukunaga for her hard work on the measure as it was not an easy topic that she undertook. He stated that many councilmembers have constituents in their districts that live in unsprinklered buildings and have met with them.

THIRD READING

BILL 38 (2021), CD2 – COMMITTEE REPORT 55

A BILL FOR AN ORDINANCE RELATING TO COMMERCIAL ACTIVITIES AT PUBLIC PARKS.

Councilmember Tulba moved that Committee Report 55 be adopted and Bill 38 (2021), CD1 pass third reading, as amended to CD2. Seconded by Councilmember Tsuneyoshi.

Councilmember Kia'āina shared the reasons why she introduced the measure and stated that the Bill is the right balance for Waimanalo based on the community input received. She thanked the Waimanalo Community, the Waimanalo Neighborhood Board, and the Parks Committee for helping her with the measure. Councilmember Kia'āina asked councilmembers for their support on the measure.

Councilmember Elefante thanked Councilmember Kia'āina for introducing the measure. He stated that he will be voting in support with reservations because he is concerned that the film, still photography, and small businesses do attempt to follow the process. Councilmember Elefante stated that he understands the concerns from the community and thanked those that have testified.

In response to councilmembers, Laura Thielen, Director, Department of Parks and Recreation (DPR) stated that:

- The Administration prefers to take an island wide approach. They have concerns on how to manage or enforce the measure.
- She recognized what Councilmember Kia'āina has done to try to make the amendments consistent with the existing laws that were passed under the prior Administration.

- She has noticed that residents seem to treat the filming industry different from other types of commercial activities because it is not consistent. She also noted that the residents take pride in seeing their community on television or in movies.
- DPR is in the process of updating its tennis rules because of a number of complaints about commercial activities on the tennis courts.
- DPR can only educate people on the park rules, enforcement would have to be done through the Honolulu Police Department.
- The Department of Land and Natural Resources (DLNR) did require permits for commercial activities on the beach many years ago in a deliberate attempt to make sure that the commercial activities would be operated with respect to existing residents utilizing the beach.
- She believes that the DLNR permits have a standard condition that the business needs to be in conformance with State and County laws, which is helpful.
- DPR has a rule that authorizes a commercial permit to operate certain activities and there is a charge for that permit.

Councilmember Tupola stated her support for the measure but will be voting with reservations. She thanked the testifiers who have expressed their support. Councilmember Tupola stated that the community needs to be able to enjoy the public space without the over-commercialization that has been reported. She encouraged the wedding industry to work with the community to come to a solution and take into account what the community has been facing for a long time. Councilmember Tupola stated that the Council needs to make sure to be able to reach the goal and in the interim there is the park ranger program to start. She would like to know if a permitted interaction group would be possible so that actual changes can be made to help the community feel the relief.

Councilmember Kia'āina stated that the majority of the violations that occur on the beach is within the jurisdiction of the DLNR and that this Bill does not intend to resolve all the problems. She stated that upon passage of the Bill, she has asked the Director of DPR to write to the head of Land Management at the Department of Land and Natural resources to request that the Wiki permits for commercial activities be taken off their website. Councilmember Kia'āina also stated that she will be working collaboratively with the State once the Bill is enacted into law.

Councilmember Tsuneyoshi stated that this has been a good discussion and that the Council is taking the time to go through the issues and details of taking action on the matter. She stated that the Council needs to pass legislation that shows the intent of what is desired. Councilmember Tsuneyoshi stated that she looks forward to working with DPR and that she supports the measure moving forward.

Councilmember Say stated that he will be voting no on the measure. He stated that he agrees with the DPR Director to have the measure be for the whole island of Oahu. Councilmember Say noted that this measure would not be fair to everyone. He would have liked to have seen certain days that certain activities can be permitted which would make enforcement easier because they would know what area the activities would be at.

Councilmember Say commended the Administration for submitting their budget. He stated for the general public that the FY2023 budget will be about \$3.92 billion and the number one source of revenues is the real property tax which would be about 36.08 percent of the total operating budget. Councilmember Say stated that the Administration is looking at the transient accommodations tax which is projected at \$85.8 million for FY2023.

Councilmember Tupola thanked Budget Chair Say for working on the measure. She stated that during the Budget hearing she asked the Administration for the missing metrics and they will be providing it at the next hearing. Councilmember Tupola stated that it is important for the Council to see where the budget is going and also to know what type of goals each department has. She thanked Chair Waters for suggesting putting the ARPA money in the budget to show transparency. Councilmember Tupola stated that she will support the measure with reservations.

Chair Waters stated that he will be voting in support with reservations on the measure because of his questioning of whether or not the American Rescue Plan money was put into the budget, which it was not. He also stated that in Bill 14, Section 12m asks the Council to waive the Charter to waive the oversight over the American Rescue Plan money received in the past or that will be received in the future which may not be legal.

Councilmember Tsuneyoshi stated that she will be voting in support with reservations for the reasons Chair Waters stated. She also has concerns about positions that will be transitioned from the Honolulu Authority for Rapid Transportation to the Department of Transportation Services and would like a breakdown of that.

Councilmember Elefante stated he will be voting in support of the measure. He asked the Administration to think about the funds from ARPA for positions and how they will be funded once those funds are gone.

Councilmember Cordero stated that she will vote in support with reservations on the measure for the reasons Chair Waters stated. She stated that another reason for her vote is her concern over the decrease in funding in the Departments of Community Services and Housing as the Mayor and the Administration stated that affordable housing and homelessness is a priority.

Councilmember Kia'aina thanked Chair Waters for bringing up the provision. She stated that she brought the matter up to the Managing Director and that he will be modifying the language.

- The Administration is aware of the National Association of Counties. He stated that the Managing Director shared information with him and he would defer the question to him.
- His role is to provide the financial infrastructure and support to push the funding out.
- He has considered working with the National Association of Counties but has not actually reached out to them.
- The first tranche of ARPA funds were received the second week of June 2022. BFS will be submitting budget communication 11 that will have the exact amounts and dates. It will also provide the amount that was spent, what was encumbered, and what was awarded.

Councilmember Say asked if there are projects that councilmembers want related to the public infrastructure funds, can they do a line item in the Capital Improvement Budget for FY2023 because this is the dilemma that the Council is facing today with the ARPA funds.

Councilmember Tsuneyoshi asked if the Administration can work with the Council on how to use the ARPA and other funds and be creative in the CIP budget. She stated that she looks forward to working through the process with the Budget Chair, the Committee, and the Administration.

Chair Waters stated that based on Director Kozlov's update on the Department of Design and Construction on the City Council's add on from last year's budget of a dozen projects, only about 9 were being done. He asked if the Administration would please consider releasing the money that the Council puts in for the add on for projects.

Councilmember Tsuneyoshi stated she will be voting no on the measure. She asked that the Council receive information on the full recovery plan and the updated details of the estimated cost before voting on the budget bills for the Honolulu Authority for Rapid Transportation (HART).

Councilmember Tulba stated that he will be voting no on the measure.

In response to councilmembers, Dean Hazama, Director of Finance and Nate Medding, Project Director, HART stated that:

- The recovery plan is an interim terminus that the Mayor mentioned. The \$1.6 billion in the Capital budget for the Civic Center Guideway and Stations includes the entire route to Ala Moana and the reason that was put into the budget was because HART intends or is thinking of procuring that particular design build section to have that option. This is an optional type of procurement whereby HART can exercise options as funds become available.
- HART is currently working on the draft recovery plan which will need to be presented to the HART Board and that meeting will be open to the public for review and comment. They do not have a completion date for the Recovery Plan.
- HART just completed the draft financial plan portion of the recovery plan and noted that the number will change because the Project Management Oversight Contractor (PMOC) is coming out with the risk refresh. HART is hoping the project costs will be reduced by the review and analysis.
- HART completed a value engineering 2-week workshop with 12 professionals lead by a certified value specialist that focused on how to build the remaining scope for the best value to money ratio. HART will give the scope determination to the Federal Transit Administration (FTA) and PMOC who will be on site on March 28, 2022 and at that time they will conduct the PMOC risk refresh. At that time, the final cost and Schedule will be determined.
- The Capital budget includes the majority of what would be affected by the recovery plan. The recovery plan would take off two stations and about a mile and a quarter of guideway and then part of the last 4 miles segment of the City Center and utility relocations project that has already been appropriated. Iwilei to Ward has been awarded and Dillingham will be awarded in October 2022.

Councilmember Tupola had a question regarding communication and stated that the Administration and HART should follow the protocol of communication.

Councilmember Tsuneyoshi stated that the General Obligation Bond and the ability to borrow and the debt service is tied to HART's budget. She also stated that the availability to use the TAT is based on HART's request. Councilmember Tsuneyoshi stated her concern that the Pearl Highlands Transit Center and parking garage and park and ride are under the list for value engineering. She stated that HART should go to the community and share information because they are told one thing and then it is changed.

Chair Waters stated that the recovery plan is due to the FTA by June 30, 2022. He asked that HART submit the plan as soon as possible so that the Council can have a meaningful discussion and decision making.

In response to councilmembers, Dean Uchida, Director, Director of Planning and Permitting (DPP) stated that:

- DPP's system is based on tax map keys by parcel. They flag lots that the State Historic Preservation Division (SHPD) notifies them on and they have been asking SHPD to provide a list to the DPP so that they can include that in their system so that when building permits are received, it can be automatically referred to SHPD.
- If the Oahu Historic Preservation Commission was functioning like SHPD then they could have helped to provide the DPP with the identification of which lots would require review.

- DPP recommend having the option to hire a consultant. He noted that the neighbor islands who have a commission still struggle with SHPD's decision because their in-house archaeologist may not want to make a decision without SHPD's input.

Chair Waters stated that Resolution 22-36 asks both DPP and SHPD to coordinate their historic site review and notification procedures to prevent the destruction of historic sites and resources. He asked for both DPP and SHPD to work out a solution.

In response to councilmembers, Alan Downer, Administrator, Hawaii State Historic Preservation Division (SHPD) stated that:

- SHPD does not have a problem sharing their information. He noted that the problem is they do not have enough staff.
- If someone from the public notifies SHPD that they found an archaeological site, SHPD would send an archaeologist out to confirm that information and then that information is put on their geographic information system (GIS).
- He would have to check with his GIS specialist if all sites that are reported include the TMK.
- SHPD has a grant from the ARPA fund but does not have funds to do a systematic survey of the State.
- He fully supports having an Oahu Historic Preservation Commission and would be open to working with an archaeologist from DPP.
- SHPD is concerned with confidentiality of burial sites but does not see any reason why a government agency cannot have access to the information.

Chair Waters stated his appreciation to SHPD and to DPP but to do nothing is not acceptable. He noted that the testifiers were really concerned and this happens in every district.

Councilmember Kia'aina asked that SHPD work collaboratively with Senator Schatz and Congressman Case.

Councilmember Tupola stated that she has worked with Regina from SHPD on the Kipuka database and offered to work with DPP to show them how the database works.

Councilmember Elefante stated that he hopes that the DPP and SHPD can have better communication, coordination, and collaboration when it deals with historic sites in the areas to be able to improve efficiency. He stated that he is in support of the Resolution.
