<p>Testimony:</p> <p>At the September 8th, 2021 City Council hearing when the agenda item regarding the removal of the Ha'iku Stairs was being addressed, Councilwoman Esther Kia'aina made a motion to dismiss all written testimony from area codes that are not 808 numbers. I feel compelled to give oral testimony as this now larger budget item for the same issue is again under City Council review and I want my voice to be heard. First and foremost I would like to clarify that my zip code is used to determine my electoral district, not my area code, and my area code has not matched where I've lived for the past 15 years. My zip code is in district 3 and this item affects my community.</p> <p>I would like this budget item for the removal of the Ha'iku Stairs to be struck from this budget. I believe that there are many benefits to keeping the Ha'iku Stairs that are not being properly addressed, and that the loss of the Stairs would be a loss of WWII history as well as a resource that could be utilized as a community benefit.</p> <p>The first issue I have is that the budget seems shortsighted. \$1.3 million dollars is what it costs to demolish a building, on grade, with adequate crane access from multiple sides. The second issue is the historical aspect, by definition of being older than 50 years the 80 year-old Stairs are historic and should be saved to protect history and Hawaii's role in winning the war. My grandfather was a prisoner of war for two years of his life, and as that generation is passing we are losing their stories, memories, and relics of that time - a time that should not be forgotten. The final issue I have is the community benefit these Stairs could provide. If access is managed as to not disturb the adjacent neighbors, revenue from the stairs could help serve the adjacent community. The Stairs are a landmark and should be protected as so.</p>

On December 27, 2020 I was bodysurfing at Sandy Beach when I had a freak accident and suffered a compound fracture to my right ankle.</p> <p>It was late in the day on a Sunday afternoon (a little after 5:00 pm) when the lifeguards are normally packing up for the day. Thankfully they were still on duty and were able to help me up the shoreline, get me stabilized and on a backboard for transport. From there, I was taken via ambulance to Straub where I underwent emergency surgery a few hours later to reset my bones.</p> <p>I'm very lucky that these lifeguards, Tanner Williams being one of them, were still on scene even though their working hours had technically ended. Had my accident occurred even 15 minutes later they may not have been there to provide the excellent service that they did. I am forever grateful for the care and attention that I received that day! Without a doubt, my accident is a testament to the need of extending ocean safety hours from sunup to sundown.</p> <p>With that said, I've also grown up bodyboarding and bodysurfing around the island and have seen multiple incidents where the brave men and women of C&C Ocean Safety have put their own lives in danger in order to rescue someone else's. <p>Testimony:</p> <p>The Haiku Stairs are a marvelous wonder of Oahu and have attracted visitors from all over the world. The experience of the Haiku are not something that a small group of elected officials has the right to remove from the landscape. Removing the stairs would cause massive erosion and destruction to the terrain from which it has existed for decades. It would also ensure more erosion on the Moanalua side as it is more frequently trafficked than the haiku side. It is also far more dangerous than the haiku side; the majority of injuries occur from the trecherous Ridgeline which hikers endure in order not to break the law. The haiku stairs could be accessed easily, legally, and safely if the gate accesses along Puoni Place and Kuneki St remained unlocked allowing safe transit to the bottom of the Haiku Stairs. The trespassing concerns are self-induced by local bureaucracies; if there were not arbitrary restrictions hikers would not be enticed to trespass. Numerous other hikes on Oahu begin in neighborhoods, and the neighbors tolerate the parking and influx of hikers. The Haiku neighborhood is not distinguished from Kuliouou, Lanikai, Maili, Waimano, or numerous others. People can hike there without issues, why is Haiku different? It is not dangerous; most rescues are made at Lanikai pillboxes and Koko Crater. The rescues performed in vicinity of the Haiku Stairs are usually from more dangerous portions of the Ko'olau Summit Trai such as Stairway to Hell or K2. (1) The Haiku Stairs are an important and unique Hawaii treasure.

(2) The Haiku Stairs did not cause inconvenience to the neighborhood when managed by the USCG.

(3) Stop Trespassing and Reduce Disturbances to Local Neighborhoods: The Managed Access Plan eliminates problems in the neighborhood and eliminates trespassing from the windward side. It is the lack of managed access that has caused the problems.

(4) Increase Public Safety and Remove Potential Liability to the City: The Haiku Stairs have an impeccable 7-decade history of safety, with almost no serious injuries. They are absolutely the safest way for climbers to access the ridge. Deliberate removal of the Haiku Stairs by the city will directly cause more hikers to use the much more hazardous Moanalua Valley Trail, directly causing more serious injuries and possibly deaths.

(5) Protect the Environment: The Environmental Impact Statement commissioned by the Board of Water Supply found the alternative to convey the stairs to the Department of Parks and Recreation for managed access scored the highest – much higher than removal of the stairs. Managed access brings with it education and appreciation for the cultural and environmental well-being of the mountainside. Hikers cause more environmental damage climbing the dirt Moanalua Valley Trail than stepping on the steel steps of the Haiku Stairs.

(6) To address the long standing Haiku Stairs issues, the best solution is managed access and not removal.

On April 27, 2020 the Board of Water Supply, which at the time owned the property containing the Haiku Stairs, considered the removal of the Haiku Stairs. The Board of Water Supply conducted an impressive on-line public hearing on the topic that elicited 4,489 pieces of written testimony and many hours of oral testimony. The testimony was an overwhelming 90% in favor of keeping the Haiku Stairs while implementing a management plan to control access, and only about 10% in favor of removing the Haiku

Stairs.

The Board of Water Supply decided upon a course of action favored by Mayor Kirk Caldwell that would transfer ownership of the affected property to the City's Department of Parks & Recreation. This was a sound decision. The Environmental Impact Statement commissioned by the Board of Water Supply found the alternative to convey the stairs to the Department of Parks and Recreation for managed access scored the highest. The Haiku Stairs are exceedingly safe, and removal of the stairs would have led to more hikers climbing from the much more hazardous Moanalua Valley Trail, causing more serious injuries and possibly deaths.

The property transfer was completed on July 1, 2020 and the City started to develop proposals for management of the Haiku Stairs to include control of access, limitations on the numbers, transportation of hikers to the stairs, security, and liability. These measures are designed to protect the environment and the peace and quiet of the nearby neighborhood. The City received 14 qualified bids and proposed a 12-year concession agreement for a managed access plan and guided hikes at the Haiku Stairs which the City Council recommitted to the Committee on Economic Assistance and Revitalization.

The rationale for the City spending about \$1M for restoring those stairs nearly 20 years ago was sound. With solid steps and handrails, they provide the safest access for many people to enjoy both the exercise and the spectacular views from the ridge. That rationale remains valid.

The stairs were made as good as new but the failure of various government agencies to implement a fair agreement for access to the stairs was irresponsible. For example, in 2004 the City and the Department of Hawaiian Home Lands worked out a responsible agreement to exchange 53 acres of the City's undeveloped land at Varona Village for 65 acres of DHHL land in Haiku Valley, but in September 2004 the City Council put the deal on hold pending more information about the city's plans and costs for the Haiku Valley. City Managing Director Ben Lee was reportedly frustrated by the postponement of what he called a "win-win" situation. It is the lack of legal access that has subjected the surrounding neighborhood to abuse over the years.

The Friends of Haiku Stairs has developed a Concept Plan for Managed Use of Haiku Stairs that comprehensively addresses all of the concerns that have been raised. The plan is sustainable, including an environmentally sound and sustainable business plan, limiting use to 80 hikers per day, using vans to transport hikers from an off-site staging area to the trailhead eliminating neighborhood contact, utilizing staff members and the use of color coded RFID wristbands to manage hikers, and measures to eliminate trespassing including effective fencing, security cameras with night vision capability, the use of off-duty HPD officers to issue trespassing citations, 24/7 security including use of a second guard placed on the stairs above the point where any trespassers would join the stairs (such as the 1st platform), and a Security Planning Group composed of neighbors, HPD, private security, the operator, and FHS to implement and supervise the security operation. The key is to issue a \$1,000 trespassing citation 24/7 to any unauthorized person on the stairs by checking the RFID or issuing the citation at the first platform (or other location above section 60) that would catch 100% of people coming up from various paths from the Kaneohe side.

The Kaneohe Neighborhood Board unanimously took a position SUPPORTING REOPENING THE HAIKU STAIRS TO THE GENERAL PUBLIC UNDER A CONTROLLED AND MANAGED ACCESS PLAN.

Substantial progress was made in the last 6 months of 2020 toward resolving remaining issues and creating a safe, legal, managed, environmentally sound plan that would not impact the nearby neighborhood. The City now has the ability to safely and responsibly bring the recreational potential of the stairs to fruition. Now is the time to apply skill and expertise to finally resolve this long-standing issue by concluding a fair agreement for managed access to the stairs, and not the time to suddenly reverse course and remove the stairs.

Thank you for listening to the comments from the rental owners and refining Bill 41. The current Bill is a vast improvement from the original.

The challenge with Bill 41 is creating a law that tries to cover several different zones and rental types simultaneously. Everyone is for the enforcement of illegal rentals, controlling the disruptions they may cause, and preventing the development of monster rental homes. The legal rental units in the Waikiki Resort Mixed-Use Zones generally operate harmoniously with the hotel operators, neighbors, and associations. There should be extended considerations for this.

Changing the 30-day to a 90-day minimum is a point of contention for many. Since the goal is to keep tourists in the Resort Zone, the Bill should provide a provision to allow the Waikiki Resort Zone units to keep the 30-day minimum. There should also be exceptions for buildings like Discovery Bay. Two-thirds of the units are rentals, and it sits directly across from the Resort Zone. The association currently allows 30-day rentals.

Bill 41 will require all TVUs in the Resort Zones to pay the \$1,000 registration fee and a \$500 annual fee. These owners are already paying the 10.25% Transient Accommodations Tax, Bill 40s 3% TAT increase, the Resort property tax, and the GET. That is a lot of additional tax burden for a legal rental owner. Possibly the one of the highest in the country.

The legal TVUs in the Resort Zone are registered under the Resort property tax. It would be fairer if they could use that registration instead of the new TVU registration and forgo the high fees or offered reduced fees. Considering all of the owner's expenses, it seems unfair to have them also fund the enforcement for the illegal rentals.

Of Bill 40s, 3% TAT increase, 50-60% goes to the rail, with the remaining portion used to fund the much-needed tourist environment sustainability programs. An option to support the enforcement would be to use part of the 3% TAT. That is a small amount, and it will serve a fairer purpose until the fines from the illegal rentals help to subsidize the cost of the additional inspectors.

Blaming the vacation rentals, including those in the Resort Zones, for the housing crisis is not a fair statement. Hawaii has the highest median home price in the country and a very high cost of living, making it difficult for the average homeowner. Renting a vacation rental is not an economical choice for many.

The real issue behind the affordable housing crisis is development has fallen behind year after year. The lack of city projects, rigid zoning laws, slow permitting process, and land use ordinances add up to a painfully slow process for the developers. Kudos to Mayor Blangiardi and his team for recognizing the issues and teaming with the new DPP to streamline the process. It is an excellent step forward to address the housing issue.

Please consider allowing the 30-days minimum stays in the Resort Zone, further streamlining the registration process, and considering all the taxes the Resort owners are paying, eliminating or reducing the registration and annual fees.

Thank you to all the hardworking public servants working towards a fair and comprehensive bill.

To the esteemed members of the Honolulu City Council and Budget review committee,
ONCE AGAIN.....

I would like to respectfully voice my support regarding the approval of the FY operations and CIP budget proposed for the Honolulu Ocean Safety Division. In these unprecedented times of fiscal uncertainty, I know every penny will be scrutinized. However, I believe it is critical that in order for us to get our economy and way of life here in Hawaii back on track as the pandemic seemingly rounds a corner, we must not short change our first responders, especially our Ocean Safety personnel and their woefully underfunded and under established support needs.

In spite of all the rhetoric and novel ideas to create a diversified economy moving forward, tourism is still the largest egg in our basket. I would argue that our Ocean Safety personnel have one of the greatest impacts on the tourism industry. Hawaii is viewed as one of the safest visitor destinations in the world, but, is it really that safe or is that just an image we portray? "Come to Hawaii,

we have low COVID numbers” (but, please don’t die in the water while you’re here). Should that be our mantra? Let’s be honest, most people come to Hawaii for our beautiful beaches and our diverse culture. Everything else is just a bonus, cherries on the cake. Most visitors will at least get sand on their feet and dip their toes in our warm waters at some point in their stay. But, in spite of the picture postcard we promote to the world, many of our visitors are unaware that the ocean is a dynamic and potentially very dangerous place. Ignorance is often bliss and people on vacation in “paradise” often leave their sense of situational awareness and cautious mindset at home. Social media often sends them to areas that are incredibly beautiful but extremely dangerous. What was once remote or reserved for local knowledge only has now been found. Our visitors should be dying to come to Hawaii, not coming to Hawaii to die.

Our local folks as well are not immune from hazards. I drove past Maunalua Bay earlier today and observed a lifeless body wrapped in a white sheet at the boat ramp surrounded by police cars. For me it instantly brought back very distressing memories of having to recover and respond to similar cases throughout my career at the exact same location. I learned later that our Ocean Safety Rescue personnel had to respond via jet ski and recover a lifeless woman who died while surfing in the bay. Right now a family is grieving and they are having the worst day of their lives. This is a part of the job you never get used to. Every life is precious and many of these tragic events can be prevented with a greater investment in overall ocean safety services. Modern day lifesaving focuses on prevention through education and early intervention because once a rescue is needed, time is extremely critical. A delayed response posture in the ocean environment is often too late.

Our lifeguards are out there on the front line, forwardly deployed and vigilant. Their goal is to ensure our visitors go home safe and sound from the best vacation of their lives so they can begin to plan their next return visit. They are also on the front line to ensure our Kamaaina also go home safe and sound to their Ohana.

Lifeguards not only ensure for beachgoers safety, they are often the main ambassadors of Aloha our Malihini guests come in contact with. They offering advice on places to visit, eateries and share the local culture.

I won’t even begin to try and touch on the impact our Ocean Safety personnel have on most of our local residents, our way of life and our culture that is inexplicably intertwined with an ocean lifestyle.

Hawaii has some of the best watermen /women in the world and we are fortunate that many have chosen Ocean Safety as a career. Men and women who have inadvertently been training for the rigors of this job their entire life. They are considered the best lifeguards in the world, but the organization they work for, the equipment and facilities they are provided are at times substandard. This reality is not the fault of their internal leaders who bang the drum over and over and beg to provide them with better resources. For an island state surrounded by water and an economy reliant on the overall health and safety of our beaches, we have failed year after year to establish a premier Ocean Safety program as compared to other coastal regions of the globe.

We have been throwing peanuts at the organization. In many ways it is still almost third world-ish with regard to inadequate staffing, offering water safety officers a livable wage, and establishing adequate support facilities. Year after year the powers that be are guilty of woefully underfund the division. Growth is slow and it can be like watching the grass grow. The Ocean Safety Division needs to become its own properly funded and properly managed Department. Remaining as part of Emergency Services offers no benefit as it appears competing priorities, senior management by “non-water” people (for lack of a better term) seems to perpetually stall progress. The needs to serve the ocean recreation community have far surpassed the small division status and mindset long ago. Ocean Safety has decades of neglect to make up. That seems to be common theme or curse in Honolulu, a bustling metropolis with some leaders still clinging to a small town mentality. I wish we were still small town, mom and pop, that’s why I live in Waimanalo one of the last hold outs. But look around, look at all the houses that cluster in the valleys and on the ridges, look at the traffic, look at the crowded beaches even on weekdays, we are not a small town anymore, but we still have a small town lifeguard division.

The current upper management in the division is the best it’s ever been in its 100 year plus history and Ocean Safety has the opportunity to become the premier phoenix agency rising from the ashes of a global pandemic. It just needs the vision and support from our current senior leadership in local government to make that happen. I fear we will lose our best and brightest talent in ocean safety to other agencies or private sector due to sheer frustration.

I wholeheartedly support CM Tupola’s council add to provide lifeguard services at Kahe Point. It’s long overdue. She gets it, she’s a water person. Bravo for her addressing the needs of her community. Electric Beach aka Tracks is an area (through social media) that is rapidly turning into another Hanuma Bay for snorkelers. I made a rescue there last year just passing through on a watercraft heading to the Ko Olina Marina.

Over 6 years ago I submitted a document I entitled Ocean Safety Assessment of Needs. In that document it I called for the creation of additional rescue units and identified several beaches on Oahu that needed lifeguard tower services. I listed Kalama Beach Park in Kailua, Three Tables on the North Shore, and the area of West Waikiki from the Royal Hawaiian Hotel to the Hilton Hawaiian Village just to name a few. Unfortunately SEVERAL people have died in the water in these unguarded areas over the last 6 years. It begs the question, how many precious lives would still be here had we addressed those obvious needs for better services? Why haven’t we taken a greater Kuleana to stem such tragedies? Is it funding? A lack of will? Or just a lack of understanding by the senior decision makers? I’ve notice throughout my career that many non-beach users simply have a hard time understanding the need or prioritizing it. We lose about one person a week due to drowning. Can you imagine if we lost one

person a week due to homicide? Would we for even a minute consider not hiring enough police officers to stem that trend? A loss of life is a loss of life no matter how it happens. It's more tragic when it's preventable.

There are few things more terrifying than nearly drowning to death. I've had some frightening experiences in waves of consequence and I've been in and on the ocean as a surfer and paddler since a very young child and spent half of my adult life as a lifeguard, Coastguardsman and marine enforcement officer. Imagine how horrible it must be to perish in such a horrible manner. Sheer terror.

Please support a more exigent effort to build and establish a professional ocean lifeguard program on Oahu that meets the demands and needs of the times. Please support Councilmember Tupola's Pono effort to better safeguard her community.

Testimony in Opposition of Funding in Budget Bill 14 for Removal of the Ha'ikū Stairs

I am opposed to the City Council including 1.3 million dollars of taxpayer money in the Executive Operating Budget for the Fiscal Year July 1, 2022 to June 30, 2023 to remove Ha'ikū Stairs. This is one of the most sensational hikes in the world, one of the most popular in our state, and one of the safest. It is your job to serve the public not to take extreme, unpopular, costly, unnecessary actions like this and ignore workable solutions.

The plan proposed for management of Ha'ikū Stairs is comprehensive and solves the quality of life issues in the Ha'ikū neighborhood impacted by the stairs. The plan included cultural and environmental education about the area, close monitoring, restricted entry, and high security, unlike the failed security system the City wasted taxpayer money on for years.

Expert testimony about invasive species that was given as part of the Board of Water Supply EIS when that agency was considering removal, concluded removing the stairs would increase that risk. The ability of plant specialists and scientists to access and monitor the area by way of the stairs, combined with a trail of metal steps, would ensure the area remains pristine.

Removing the stairs solves nothing and may even cause problems. Ha'ikū Stairs measures are already turning into a money pit and you have already given us one of those—HART. Ripping these stairs off of the mountain will undoubtedly be even more costly than anticipated, cause environmental damage and possibly trigger erosion and landslides. The City already spent a million dollars to repair the stairs, and next 1 million plus for destruction? This is irresponsible.

There are several people in the Ha'ikū neighborhood impacted by the stairs who are actually in favor of keeping them. I know cultural practitioners in Kailua and Kaneohe, some who steward Ha'ikū Valley, and environmental scientists who also don't agree with the plan to remove them and don't think it is wise. I know Native Hawaiian parents who served on the Board of, and whose children attended Samuel M. Kamakau Public Charter School in Ha'ikū Valley, who don't agree with removing the stairs. They think it's a terrible idea and they have testified about it. Yet, you have ignored the massive amounts of testimony over the years that is always overwhelmingly in support of saving the Ha'ikū Stairs. You are listening to about 70 people and ignoring hundreds.

The last decision the Council made to go through with removal was shockingly horrible news that resonated across the nation and the world. An editorial I wrote with a highly revered cultural practitioner in the Kailua and Kaneohe ahupua'a, my friend, Charles Burrows, about why the stairs should be saved, was quoted in the New York Times:

Please halt this removal process and prevent a disastrous decision. These stairs are historical and loved by many local residents. I am personally passionate about protecting Ha'ikū Stairs because it is my son's favorite hike in the world even though he has hiked all over the world in beautiful places with us. Rightfully, they should remain and be there when his baby daughter is old enough to hike them. My daughter wants her sons to be able to hike the stairs. All, including my daughter, sons, grandchildren, all born and raised here, will be deprived of that opportunity for no logical reason. My family are respectful, considerate hikers who value, take care of, and protect our natural and cultural resources.

Government should be working to preserve and improve the numbers of hiking venues for local people, not destroying them. SKYROCKETING COSTS & UNANSWERED QUESTIONS RE: HA'IKŪ STAIRS REMOVAL

Answers Can Be Found in Community Managed Access Plan

HONOLULU, HI April 13, 2022 –

Since the Friends of Ha'ikū Stairs (FHS) have learned that budgetary error, we have been looking deeper into budgetary issues. We wondered why City's proposed demolition budget has increased 30% to \$1,300,000 in less than six months. This increased cost to taxpayers demands explanation, especially given the overwhelming testimony in favor of keeping the Stairs last fall—with over 90% of public comments (1338 total) opposing demolition. Further unanswered questions concern impacts on endangered species and engineering challenges related to erosion control and potential landslides. The City's own planning documents call for multiple measures to mitigate the impacts of demolition whose costs remain entirely unaccounted for. The cumulative costs of these necessary measures could easily dwarf the current demolition budget. Meanwhile, a new, community-driven, comprehensive managed access plan has emerged that would solve the Ha'ikū Stairs problem at zero cost to the City. Accordingly, we hereby ask that the Council delete its funding for removal of the Stairs, or, alternatively, place a rider to restrict use of said funds solely to preliminary planning and feasibility studies.

FHS's independent analysis of the City's demolition plans raises multiple red flags that suggest the City has grossly underestimated the actual costs to taxpayers. Until the City has addressed these omissions and fully reckoned with the costs, FHS urges the City Council to pause the demolition funding. Rushing into removal puts the taxpayer on the hook for an ill-planned project whose costs could easily spiral out of control. Such a premature commitment would be especially tragic now that a new, community-driven managed access solution is on the table that would fully solve the Ha'ikū Stairs problem at zero cost to the City. We urge the City Council to consider the exciting potential for an environmentally sustainable, culturally respectful solution that preserves public access while bypassing residential neighborhoods.”

FHS believes the failure of the City's budget to account for the full costs of removal largely spring from inadequacies in the City's 2019 Environmental Impact Statement (EIS). The EIS represents the City's principal attempt to evaluate the costs and challenges associated with removal. The original \$1 million removal budget appropriated by the Council last September directly tracked the EIS's estimated removal costs. This \$1 million figure was based solely on the costs of the helicopter operations

to physically detach and remove the Stairs modules from the ridgeline. FHS questions this estimate. Nako, the very company cited in the EIS, estimated helicopter costs in 2011 as almost triple the EIS figure. FHS questions how helicopter costs have declined since then, especially given inflation and skyrocketing gas prices.

Furthermore, the EIS itself makes clear that additional expenditures will be required that go well beyond helicopters. The full extent of these additional costs remains to be evaluated and properly budgeted for. However, a few examples illustrate the EIS's incomplete accounting:

First, the Ha'ikū Stairs occupy a critical conservation habitat with federally protected endangered flora and fauna in the immediate vicinity. The EIS explicitly acknowledges that "removal of Ha'ikū Stairs has the potential to impact endangered plant species." It also notes potential impacts on endangered native bird species, invertebrates, and bats. The EIS calls for further studies by a qualified biologist to assess these risks and determine appropriate mitigation measures. The City's failure to undertake such necessary steps and its failure to budget for the costs is concerning. If threatened and endangered species are likely to be harmed by the Stairs removal, the City will need to formulate a Habitat Conservation Plan and obtain an Incidental Take Permit under both state and federal law before any take happens. The costs of such planning, permitting, and mitigation measures can easily total well over \$1 million. Going through this process will likely take at least a year before any removal work can begin.

Second: the City removal budget fails to account for the potentially significant engineering challenges to prevent landslides and control erosion. The Ha'ikū Stairs occupy extremely hostile terrain, with near vertical, exposed cliff faces lashed by pelting rain and up-to-100 mph winds. The underlying soil and rock is inherently unstable. The EIS itself acknowledges that landslides are known to have occurred in the vicinity of the Haiku Stairs and elsewhere along the Ko'olau Pali and Windward districts.

The EIS suggests erosion issues can be addressed by applying standard grading measures following "best management practices." Yet, there is nothing standard about working in this harsh, unstable terrain. Access is restricted to helicopter; heavy equipment cannot reach the project site; and weather-related interruptions will pose a constant challenge. At minimum, erosion controls measures would cost at least \$4.3 million, according to Chris Dacus, a landscape architect who oversaw public works projects for both the City and State government. However, the full costs could easily be higher.

Ripping a staircase off the side of a steep, rain-soaked mountain will be risky and complicated in myriad ways and may initiate landslides such as those we recently encountered at the Pali Highway tunnels, for example. Tons of soil and rock have piled up against the stair modules over the decades. Failing to take adequate precautions could precipitate a collapse.

At minimum, the engineering and construction costs entailed need to be assessed. The Pali Highway repairs were budgeted at \$20 million and took several months to complete. Unlike the Pali Highway repairs, which dealt only with natural erosive forces, the Stairs demolition entails an active intervention to remove an 80-year structure anchored to a ridgeline that rises over 2300 feet and 2.2 miles from valley floor to summit.

Furthermore, this is a matter of public safety, not just cost— human lives and property are at stake. Unlike the Pali tunnels, hundreds of homes and a school lie directly below the Stairs project site. The City's failure to grapple seriously with the costs, safety risks, and engineering challenges is concerning to FHS. We hope that the Council will agree that even if the risk of a catastrophic collapse is low, it needs to be addressed before proceeding with demolition.

The shortcomings and omissions in the City's budget and planning go beyond these examples. FHS has compiled a long list of hidden costs, unanswered questions, and potential obstacles. Other essential, but unaccounted for costs include the "temporary and permanent sediment control measures" that the EIS contemplates, the costs of revegetating the denuded hillside once the Stairs are removed, and continuing security expenses. Further potential obstacles include toxicology concerns, a historic preservation covenant (which the EIS entirely overlooks), required State and Federal permitting, and potential lawsuits.

All these issues need to be addressed before proceeding further toward demolition. The City Council should pause its demolition funding and protect O'ahu taxpayers from a potentially costly mistake. The last thing we need is to blunder into another open-ended public works project where planning failures lead to costly overruns, especially where a better alternative awaits: a complete, zero-cost solution that was not on the table last September.

The costs and concerns surrounding demolition can be entirely avoided if the City and County move forward with a community non-profit managed access plan for the Stairs. FHS is partnering with a diverse array of stakeholders and civic organizations who are

committed to solving the problem and preserving the Stairs for future generations. The Ha'ikū Stairs are a historically significant World II monument and iconic Windward landmark, whose majestic views have thrilled generations of kama'āina families. A majority of the O'ahu and Windward public supports keeping this popular destination open. When the issue of demolition was before the Council in September 2021, 1,338 citizens took their time to submit testimony opposing the Stairs removal—representing over 90% of submitted comments.

The City's rush to removal is especially troubling given the emergence of a promising new, community-driven alternative solution. Instead of spending taxpayer money to destroy a priceless, historic monument, the City Council should take stock of the potential for a win-win solution that can solve the problem without the need for any public funding. In the six months since the Council voted for demolition budget, we have brought together local community members, Native Hawaiian groups, and other key stakeholders to develop a new vision for Haikū Valley that includes preservation of the Haikū Stairs for future generations through a non-profit, community-driven managed access plan. The plan allows for controlled public access in a safe, environmentally sustainable manner that respects traditional cultural protocols, fully protects the City from costs and liability, eliminates trespassing and disturbances to valley residents, and provides safe and sustainable public access and parking that avoids residential neighborhoods.

Momentum behind this new collaborative vision continues to build. Given the chance, we can fully resolve the issues surrounding Haikū Stairs in a positive manner that generates local jobs and community investment. The Friends of Ha'ikū Stairs urges the City Council to slow down and fully account for the costs and challenges of destroying the Stairs. Once you have done so, FHS is confident you will see the advantages offered by preservation over demolition.
