Councilmember Say stated that the Honolulu Authority for Rapid Transportation (HART) made a major cut in their authorization of bond financing, by lowering their debt service.

Councilmember Fukunaga stated that one thing that disturbed her about the HART budget was that one member of the HART Board raised concerns that have not been addressed by the other members of the HART Board and noted that she will be voting no on Bills 18 and 19. Councilmember Fukunaga stated that she hopes that the Council can work with the Administration and the HART Board to provide greater transparency.

Councilmember Tsuneyoshi echoed the comments of Councilmember Fukunaga and stated that she will be voting no on Bills 18 and 19. She stated that it is unfortunate that the common practice is to always get information to the Council after the budgets have been approved. She noted that the Council has not seen the Recovery Plan or any drafts.

Councilmember Tupola stated that she has concerns on Bills 18 and 19. She stated that the Recovery Plan is crucial for the Administration to receive the remaining \$744 million from the Federal government. Councilmember Tupola stated that the budgets need to be tight and as accurate as can be because the City budget and the Recovery Plan is being done at the same time. She noted that she will have more questions in Committee.

In response to councilmembers, Joey Manahan and Lori Kahikina, Executive Director and Chief Executive Officer, HART, stated that:

- He is not aware of any fiscal impact study provided to HART.
- HART is scheduled to go before the HART Board next Friday with an initial draft of the Recovery Plan.
- The current CIP budget does not go all the way to Ala Moana. The CIP budget put out this year was from Middle Street to Ala Moana but the base phase will only be going to the Civic Center. If HART is able to get additional funds, then it will be bid additives for the remainder of the project. She noted that HART is doing phase funding like other City departments do. Right now HART is in the planning phase. The first phase of the project will be by requests for qualifications.
- HART will get a copy of the Recovery Plan to the Council as soon as possible. The HART Board Chair wants to submit the plan before the end of April.

RESOLUTION DETERMINING THE REAL PROPERTY TAX RATES FOR THE CITY AND COUNTY OF HONOLULU FOR THE FISCAL YEAR JULY 1, 2022 TO JUNE 30, 2023.

Councilmember Say moved that Committee Report 85 be adopted and Resolution 22-45 be referred back to the Committee on Budget. Seconded by Councilmember Cordero.

Councilmember Tsuneyoshi stated that she is concerned about the transit vacation units (TVU) in the resort area have been paying Hotel/Resort real property taxes at a substantially higher rate. She stated that if Bill 41 (2021) moves forward then the TVUs in the resort area will pay the registration fee that timeshares do not have to pay in resort areas. Councilmember Tsuneyoshi stated that her questioning was on the lines of equity and that there should be a different tax classification for the TVUs.

Councilmember Say stated for the record that he would like to address all different types of classifications. He noted that the Oahu Real Property Tax Advisory Commission discussed different classifications and had a presentation from Maui regarding short term and long term rentals whereby Maui has a classification. Councilmember Say stated to the public that the City and County's responsibility is only for real property tax rates and that the Department of Budget and Fiscal Services and the Division of Real Property determines valuation.

Councilmember Kiaʻāina stated that Bill 4 deals with taxation relating to short-term rentals and also stated that it is her desire to have a separate tax rate for transient vacation units that will be between the rate for bed and breakfast homes and hotel and resort. She stated that another area she would be looking into is potentially seeking relief for the seniors who have been impacted rising property taxes.

In response to councilmembers, Andy Kawano, Director, Department of Budget and Fiscal Services (BFS) stated that:

- No one is classified under the bed and breakfast home classification because Bill 89
 was not enforced.
- The Department of Planning and Permitting (DPP) will be the main execution and enforcement component and will give the BFS information for real property tax assessment.
- The DPP should have a list of nonconforming use certificates. The issue is when the Bill gets passed, how many more will apply.
- The 3 percent tax collected under Bill 40 comes straight to the County and after two months of collections, the City collected about \$13 million.

Councilmember Say stated that there was a loss of revenue in the agricultural classification with the solar and wind farms being classified as agriculture rather than industrial or commercial. The State Legislature said it is a permitted use, not realizing the unintended consequence of the loss of revenue. Councilmember Say noted that he would like to address a classification for vacant homes and businesses that use agricultural lands for other purposes outside of the classification.

Committee Report 85 was adopted and Resolution 22-45 was referred back to the Committee on Budget.

In response to councilmembers, Dawn Takeuchi Apuna, Deputy Director, Department of Planning and Permitting (DPP) stated that:

 The DPP will provide a listing of nonconforming use certificates as well as the locations but she would have to check if they have a listing of all the condo or co-op units currently located in resort zoned residential districts that are currently paying transient accommodations tax and general excise taxes.

- There was a study by the University of Hawaii Economic Research Organization that estimates about 14,000 illegal short-term rentals.
- Owners within the resort zoned areas who want to operate as a transient vacation unit (TVU) or a bed and breakfast (B&B) will need to register with the Department.
- The DPP is trying to be fair across the board and that the registration fees is to help run the program and make sure that all TVU's and B&B's are treated equally and allow the DPP to monitor and ensure compliance.
- There are different provisions throughout the Bill including tightening up on the ability to serve notice of violations on illegal short-term rentals, advertising of short-term rentals, and raising the fines in order to deter and penalize illegal short-term rentals. The DPP will have seven positions dedicated to investigate the thousands of illegal short-term rentals.
- Short-terms rentals are permitted in the Waikiki Special District and resort areas.
- The two Waikiki properties were selected after going through the legislative process, including input from different stakeholders and the public.

Councilmember Fukunaga stated that she introduced two floor drafts to address unintended consequences from Bill 41, CD2 but it would be more practical to identify the actual numbers of visitors who require short term residential accommodations that are not vacation units. She noted that Bill 4 would more appropriately address the uses. Councilmember Fukunaga stated that she is withdrawing both floor drafts that she introduced so that the Council can move forward and try to address the kinds of needs in a more comprehensive fashion.

Councilmember Say stated that he introduced a floor draft to primarily address the enforcement but will be withdrawing it. He noted that he is happy with Bill 41 because it clamps down on the residential zoned districts in his community to a certain degree.

Councilmember Kia'āina stated that the most important issue is enforcement. She noted that a lot of work has been done on the issue and that she would like the measure to move forward.

Councilmember Elefante stated for the record that he filed a Disclosure of Interest with the City Clerk's Office (CC-129).

In response to Councilmember Tupola, Mike Formby, Managing Director stated that:

- He is not aware of any request made to the Ethics Commission.
- He and the Mayor met with the Honolulu Board of Realtors and the World Surfing League to inform them of their position on the measure and to listen to their concerns. The Mayor supports enforcement to ensure the culture and sense of place of residential communities respect for natural resources, and to mitigate the impact of the businesses in residential communities.

In response to councilmembers, Duane Pang, Deputy Corporation Counsel stated that:

- If Bill 41 passes and the court deems it illegal, then Bill 89, Ordinance 19-18, would still be valid.
- The Land Use Ordinance has a provision where the matter can be referred to the Prosecutor and if the Land Use Ordinance is violated it may be deemed a criminal violation. The administrative procedure that the DPP performs is in addition to what can happen with the Prosecutor's Office.
- Bill 41 basically says no TVUs, no B&Bs in any residential areas and it makes it simpler for enforcement because anything that is not a NUC or a nonconforming hotel in a residential area is illegal.
- The Waikiki Banyan has a pending civil lawsuit and a Zoning Board of Appeals appeal.

Councilmember Tsuneyoshi stated that she will be voting with reservations on the measure. She noted that when Bill 89 passed, she was hopeful that the City was going to move forward on enforcement. She stated that she has concerns with the idea that property owners who have been operating legally would have to pay a registration fee. Councilmember Tsuneyoshi raised another concern on the issue of landlord/tenant codes and rental agreements. She stated that she would like the communities and residents to be safe from investors and see communities returned to the residents.

Councilmember Tupola stated that she opposes illegal vacation rentals under the current law and she would support an enforcement bill. She noted that Bill 41 is not an enforcement bill, but rather suggests changing the law and then talking about enforcement later. She stated that the City needs to uphold the current laws and as stated by Corporation Counsel, Bill 89 is the current law. Councilmember Tupola stated that she will be voting no on the measure and would like more housing.

Councilmember Kiaʻāina stated that her primary reason for supporting the measure is because of the impact of short-term rentals on residential communities. She noted that she would like to work with the Zoning and Budget chairs on creating a fair tax rate for those who run TVUs.

Chair Waters stated that he is not against people staying in a B&B or a TVU, but the City needs to control the illegal ones and that is what Bill 41 does. A B&B or TVU would need a permit to advertise. He stated that this is what the Administration said we need and we should help them accomplish it.
