Dear Honorable Mayor Blangiardi, CCH Chair Tommy Waters, Vice Chair Esther Kiaaina and Councilmember Andrea Tupola,

We, the residents of 87-016 through 87-085 Kulaaupuni Street, thank you for including us in the FY2023 City Budget for \$100,000 as announced during the May 17, 2022 Nanakuli Ma'ili Neighborhood Board meeting by Lei Llanos. We understand that funds have been budgeted for the planning and designing of drainage and landscape improvements.

Thank you, especially to Councilmember Tupola who twice visited our neighborhood first to assess the situation and then came with officials from the Department of Facilities and Maintenance and others for their input in seeking steps to be taken to resolve the lack of drainage.

Next year, hopefully, the planning and designing of the drainage for our street will be budgeted for fruition of the much needed drainage which our neighborhood petitioned for following unprecedented flooding in early December 2021 and early January 2022. Unprecedented flooding occurred because the natural flow of flood water was impeded by the development of an apartment complex.

Residents were impaired by the flooding and could not go to work or medical appointments or suffered property damage. Government services such as mail delivery or trash pickup were nearly interrupted due to the flooding and comments were made by these service providers about the depth of the flooding on this Ma'iliili Stream end of Kulaaupuni Street. Rented pumps helped to alleviate the situation, however, where to pump the water was an issue as there were no drainage outlets.

Again, thank you for including the Ma'iliili Stream end of Kulaaupuni Street in the FY2023 Budget and we hope to resolve the drainage problem before the next flood.

Dear Chair Waters and Members of the City Council,

My name is Trevor Nagamine, and I am writing in support of Bill 15. I am a resident of Mililani and a member of Neighborhood Board No. 25 (Mililani/Waipio/Melemanu); however, I am submitting this testimony in my individual capacity, and this testimony does not reflect any official position of Neighborhood Board No. 25.

I am specifically testifying in support of the \$58,738,000 appropriation to the Department of Transportation Services (DTS) on page 34 of the CD2 draft (project no. 1978005), which is to fund the purchase of new vehicles for TheBus and TheHandi-Van. This is a necessary and vital appropriation for TheBus and TheHandi-Van to replace aging vehicles that have exceeded their useful life by several years.

The Draft Transit Asset Management Plan that was published by DTS this past April notes that as of 2021, 27.93% of TheBus' fleet of articulated buses had exceeded their useful life and that 45.69% of TheBus' fleet of conventional buses had exceeded their useful life. Given that TheBus currently has 546 vehicles, 110 of which are articulated buses, and that the Draft Transit Asset Management Plan sets the useful life of a bus at 14 years, this translates to 230 vehicles currently in service that are over 14 years old. (The specific number of vehicles may be off due to vehicles that may have been recently retired from service.)

I urge the City Council to support this appropriation and Bill 15. Thank you for your consideration in this matter.

Honolulu City Council Bill 15 (2022), CD2, FD1 (Proposed TW) June 1, 2022

Chair Waters and members of the Honolulu City Council, mahalo for the opportunity to submit testimony on behalf of the Hawai'i Lodging & Tourism Association, the state's oldest and largest private sector visitor industry organization.

The Hawai'i Lodging & Tourism Association—nearly 700 members strong, representing more than 50,000 hotel rooms and nearly 40,000 lodging workers—have long prioritized public safety for residents and visitors in the Waikiki community and throughout the entirety of the City & County of Honolulu. For a number of years, we have hosted the Visitor Public Safety Conference which brings together area stakeholders, tourism industry professionals, community groups, policymakers, and law enforcement to address safety issues that affect residents and visitors alike, and we have continued to organize these meetings throughout the pandemic.

Over the past several months, crime rates have continued to climb, and this has made us all feel less safe and has threatened Hawai'i's reputation as a safe, premier travel destination. Recognizing this, HLTA has been an outspoken advocate for the establishment of a new Weed & Seed Hawai'i site in the Waikiki area. First established in 1998 and now operating as a nonprofit, the organization's weeding and seeding strategy has been highly successful in Site 1 (Kalihi-Palama-Chinatown-Ala Moana-Sheridan), Site 2 (Waipahu), and Site 3 (Ewa Beach-Ewa). As a City councilmember and mayor, I have been a longtime supporter of Weed & Seed and feel strongly that a Waikiki site is not only needed, but would also be successful.

Working with our Visitor Industry Public Safety Coalition members including the Waikiki Business Improvement District Association, the Hawai'i Hotel & Visitor Industry Security Association, the Waikiki Improvement Association, and the Visitor Aloha Society of Hawai'i, we have found widespread support for this initiative. We have conveyed our strong support in discussions with Mayor Rick Blangiardi, Council Chair Tommy Waters, Prosecutor Steve Alm, and HPD Interim Chief Rade Vanic. Additionally, we have been in discussion with Weed & Seed Hawai'i Executive Director Gale Braceros, the organization's board of directors, Senator Kurt Fevella, and Councilmember Augie Tulba and recognize that funds are needed to stabilize the three existing sites—as they expand their reach into Waikiki.

As such, we are grateful for the inclusion of monies to support Weed & Seed Hawai'i in this draft of the City's proposed budget bill. It is our position that sustained funding for this initiative

will pay dividends for the entire county, and that this is a necessary step in proactively addressing growing crime rates that are affecting our safety and the success of our state's leading industry in the City & County of Honolulu.

For these reasons, HLTA supports Bill 15 (2022), CD2, FD1 (Proposed TW).
