At the September 8th, 2021 City Council hearing when the agenda item regarding the removal of the Ha'iku Stairs was being addressed, Councilwoman Estern Kia'aina made a motion to dismiss all written testimony from area codes that are not 808 numbers. I feel compelled to give oral testimony as this now larger budget item for the same issue is again under Citycouncil review and I want my voice to be heard. First and foremost I would like to clarify that my zip code is used to determine my electoral district, not my area code, and my area code has not matched where I've lived for the past 15 years. My zip code is in district 3 and deserves to be heard, as this is my community.

I would like this budget item for the removal of the Ha'iku Stairs to be struck from this budget. I believe that there are many benefits to keeping the Ha'iku Stairs that are not being properly addressed, and that the loss of the Stairs would be a loss of WWII history as well as a resource that could be utilized as a community benefit.

The first issue I have is that the budget seems shortsighted. \$1.3 million dollars is what it costs to demolish a building, on grade, with adequate crane access from multiple sides. Not a demolition that would be completely performed on a mountain ridgeline by a helicopter.

The second issue is the historical significance, by definition of being older than 50 years the 80 year-old Stairs are historic and should be saved to protect history and Hawaii's role in winning the second world war. My grandfather was a prisoner of war for two years of his life, and as that generation is passing we are losing their stories, memories, and relics of that time - a time that should not be forgotten.

The final issue I have is the community benefit these Stairs could provide. If access is managed as to not disturb the adjacent neighbors, revenue from the stairs could help serve the adjacent community. The Stairs are a landmark and should be protected as so; not a demolition item on a poorly crafted budget.

I oppose allocating 1.3 million dollars to the City budget to remove Haiku Stairs. Why waste millions of dollars of taxpayer money to destroy a precious resource, destroy native species, and possibly create dangerous erosion and landslides on this ridge when there is absolutely no logical reason to do so. This is irresponsible, destructive, expensive, and absolutely unnecessary. It almost seems as though the Council has lost all perspective on what they are proposing to do when it comes to Haiku Stairs. What is this obsession with tearing down Haiku Stairs? There are huge problems on this island that need to be addressed. The list is endless and it should not include destroying a beloved hiking trail for residents that has a comprehensive access management

plan ready to go. How did Haiku Stairs even make the list when we need to fix homelessness, crime, gun violence, the high cost of living, brain drain, lack of school teachers and resources (no new books in many schools!), shoddy school facilities and grounds in disrepair and classrooms needing air conditioning, the lack of nurses, doctors, EMTS, police, life guards, social workers and other professionals, inequity, how to get Oahu to 100% renewable energy and achieve sustainability, lack of successful agricultural resources and the ability to provide much higher percentages of locally produced food, overcrowding, over development on precious, scarce open lands instead of urban renewal, a failing rail construction project draining city funds, child poverty in this state, lack of social services, a very troubled foster care system that needs serious attention and resources, mental health and drug treatment programs, neglected natural resources without enough staff to care for and manage them, and more.

Why did destroying Haiku Stairs get priority as a necessary expense to put in the City Budget? This is absurd. Why would you take something like this away from taxpayers—a valuable, spectacular resource, and a structure that provides access to education, environmental studies, stewardship, cultural history, and the restoration and preservation of native plants and the removal of invasive plants on this ridge. It is important to maintain this access in order to protect the native plants there. The City has been irresponsible and neglected to steward this fragile area and has allowed damage there to occur over the years and invasive plants to start takin over. Graduate students from the University, native plant specialists, and professors should be brought into this area to determine how to restore it.

Instead, you are proposing to destroy an historic structure that is an iconic hike known the world over for its breathtakingly beautiful views. Why would you take this resource away from residents and future generations and spend millions of dollars of taxpayer money to do so? Why aren't you actually doing something for Hawaii residents and future generations with our taxpayer money like providing needed new parks, new trails, building a cultural, historical, environmental educational preservation park in Haiku Valley that includes the Haiku Stairs, other trails and pathways in the area, as well as restrooms, parking, an interpretative center, a cultural center, native species restoration and stewardship programs, managed staff, and entry fees for out of state visitors? Managed access would take care of the area, end trespassing, allow public access in a safe, environmentally sustainable manner, end neighborhood problems and would cost taxpayers nothing, generate jobs and create investment in the community. If the Council can't conceive of how important saving this area for residents and understand their intrinsic value. Hiking trails, parks, bike pathways, recreational and cultural facilities, and access to natural resources contributes to higher quality of life for taxpayers. Taking away hiking trails and access to recreational opportunities is detrimental.

The public wants to save the stairs. A majority of island wide residents always give overwhelming majority testimony (near 90% + in recent years) in support of saving the stairs, but for some reason the City is determined to include destroying special natural resources and hiking trails to its budget and agenda. A 2022 poll shows 55 percent of Windward residents are in favor of preserving the stairs. I would assume it is much higher judging from the amount of supportive testimony submitted to the Council over the years. The Kaneohe Neighborhood Board passed two unnanimous Resolutions in favor of preserving the stairs. The Koolaupoko Sustainability Plan demands preserving scenic views, scenic trails, outdoor recreational resources, and preserving natural, cultural and historical resources. Tearing down Haiku Stairs goes against everything the plan promotes.

City Management Amendment relating to "Death Benefit" Reimbursement for Citizens of the *Freely Associated States* • Amendment increased to \$2,500,000

Dear Chair Waters,

The Hawaii Funeral & Cemetery Association, Inc. is a Domestic Nonprofit Corporation, comprised of 12 independent Board of Directors representing 14 mortuaries and 10 cemeteries that serve the largest majority of Hawaii's families. We would like to give our support on the Death Reimbursement amendment that would help families of the Freely Associated States that were unable to qualify for the FEMA Reimbursement program for Covid related deaths. The FEMA reimbursement program provided up to \$9000 that, if qualified could be reimbursed to a family that incurred funeral and burial expenses.

The current management amendment of \$2,500,000 is appreciated and we believe will be very helpful covering actual funeral and cemetery cost of families we believe affected.

In addition, due to gathering restrictions and travel lockdowns families were unable to transport their loved ones back to their home (overseas). The transcontinental air-transport of decedents was shut down for a long period of time due to country lock-downs. This placed added stress on families, including added cost depending on their decisions to burial in Hawaii permanently, or temporarily until restrictions were lifted. The last two years have been extremely difficult on Hawaii families that had a death, "Covid or non-covid related deaths" families not only had to go through the grief of loss, they were not allowed to have their customary traditional "spiritual and religious ceremonies" due to the State and County restrictions, this just added to their grief.

#### Based on the mortality rate data gathered by the Hawaii State Department of Health,

<u>https://health.hawaii.gov/coronavirusdisease2019/tableau\_dashboard/mortality-data/</u> as of May 4<sup>th</sup> 2022 there have been 1391 Statewide covid related deaths; "1043 Honolulu County". (Attached exhibit) The primary race affected were Filipino - 329 deaths, Pacific Islander - 224 deaths, Japanese – 226 deaths and Native Hawaiian - 252 deaths. I think it's a fair statement to estimate that a large percentage of the Pacific Islander deaths would not have qualified for the FEMA reimbursement program and are citizens of the Freely Associated States.

This is a opportunity to help families that did not qualify for the FEMA reimbursement program. We suggest the current Death Benefit Amendment be increased to match FEMA's \$9000 per qualifying family and is budgeted for approximately 224 famillies and families affected in the future. We support the current amendment of \$2,500,000

Note: Fema qualifications should be used as a guideline to qualify families for the Honolulu County Reimbursement Program.

Waikīkī sits at the heart of Honolulu's tourism economy. The special improvement district was created to assist in preserving this unique resource. The Waikiki Transportation Management Association (WTMA) was established to coordinate and assist in the management of certain transportation operations within the WTMSID. The goal of the Special Improvement District is to improve the long-term sustainability of transportation and traffic solutions in Waikīkī. Coordination is necessary to achieve this goal because of the numerous stakeholders that use transportation infrastructure.

Aloha Chair Waters, Vice Chair Kia'āina and Council Members,

The Hawaiian Humane Society supports the proposed floor draft of Bill 14, CD2, as it restores vital funding for animal services and law enforcement.

The Hawaiian Humane Society is the animal services contractor for the City and County of Honolulu. As such our teams enforce animal-related laws; serve as the official pet lost and found for the island of O'ahu; ensure that pet animals have a place to get help if they are stray or can no longer be cared for by their owners; provide services to pet owners in need so that families can stay together; spay/neuter pet cats, dogs, rabbits and Free-Roaming cats; serve as first responders in natural disasters and animal emergencies; adopt homeless animals into new families; and much more. The majority of our work for the City entails direct animal care and law enforcement. The contract also includes funding for the spay/neuter of Free-Roaming cats and the pets of residents on government assistance.

In the aftermath of COVID's devastation of the local economy, City animal care and law enforcement funding was reduced by nearly 14 percent, which resulted in a reduction of services and some shifting of law enforcement responsibilities to the Honolulu Police Department. This floor draft restores funding to pre-pandemic levels.

We urge the Council to pass Bill 14, CD2, Proposed FD1.
