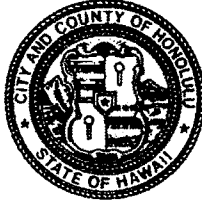

SUBJECT: Resolution Relating to the Transfer of Funds

In accordance with Section 2-17.2 (c)(1), Revised Ordinances of Honolulu 1990, as amended, the Department of Parks and Recreation requests your approval of the attached resolution authorizing the transfer of funds between activities.

The transfer is necessary to cover the matching funds for the City and County of Honolulu to establish a City Street and Park Tree Inventory and Asset Management System from the U.S. Department of Agriculture. RESOLUTION

RELATING TO THE TRANSFER OF FUNDS.

WHEREAS, Section 2-17.2(c)(1), Revised Ordinances of Honolulu 1990, as amended, requires that the Council of the City and County of Honolulu ("City") approve by resolution any transfer of funds between activities whenever the cumulative amount of transfers from or to an activity totals in excess of \$100,000 or ten percent of the amount appropriated for that activity in the executive operating budget ordinance, as it may be amended, whichever is less; and

WHEREAS, the Department of Parks and Recreation has requested the transfer of funds in order to cover the matching contribution required for the City's receipt of Grant funds from the United States Department of Agriculture for the City and County of Honolulu's City Street and Park Tree Inventory and Asset Management System; and

WHEREAS, a transfer of \$300,000 from the Provision for Grants, Partnerships and Security activity (current expenses) to the Department of Parks and Recreation, Division of Urban Forestry activity (current expenses) for Fiscal Year 2023 is required to meet the local match grant program needs of the Department of Parks and Recreation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that \$300,000 in General Fund (GN) monies be transferred between the following activities:

BE IT FURTHER RESOLVED that the Mayor, or the Mayor's designee, is hereby authorized to carry out the provisions of this resolution; and
