BE IT RESOLVED by the Council of the City and County of Honolulu that this body confirms the reappointment of Mr. Landon Kaneshiro to the Zoning Board of Appeals for a term expiring on June 30, 2027; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Mr. Kaneshiro for his willingness to be considered for public service and actively participate in city government; and
