Mr. Chair:

Your Committee on Parks and Community Services, which considered Resolution 22-191 entitled:

"RESOLUTION AFFIRMING THE OFFICIAL PLACE NAME OF KŪ'ĪLIOLOA HEIAU, LOCATED WITHIN PŌKA'Ī BAY BEACH PARK IN WAI'ANAE AND REQUESTING THE CITY ADMINISTRATION TO OFFICIALLY DESIGNATE THE NAME AND INSTALL APPROPRIATE SIGNAGE,"

introduced on August 16, 2022, reports as follows:

The purpose of Resolution 22-191 is to affirm the official place name of Kū'īlioloa Heiau, located within Pōka'ī Bay Beach Park in Wai'anae, and request that the City Administration officially designate the name and install appropriate signage, including historical markers.

Kehaulani Puu, Deputy Director of the Department of Parks and Recreation ("DPR"), testified that DPR is supportive of the measure. There has been confusion amongst community members about the proper place name and DPR has asked the community to come to an agreement on the name.

At your Committee's meeting on August 25, 2022, three individuals testified in support, and one individual offered comments on the Resolution. Written testimony in support was received from six individuals. Comments were received from one individual.


