WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended, provides the City Council ("Council") with authority to accept gifts to the City and County of Honolulu ("City"); and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City; and

WHEREAS, the policy provides for the acceptance of gifts by affirmative action by the Council; and

WHEREAS, the National League of Cities ("NLC") is an organization that serves the interests of 19,000 cities, towns, and villages in the United States, as well as professionals working in municipal governments, and is dedicated to helping city leaders build better communities; and

WHEREAS, the Large City Council Presidents Convening is a gathering organized by the NLC for a peer group of legislative leaders from the nation's largest cities; and

WHEREAS, the NLC has submitted a request to the Council for acceptance of a gift to the City of registration and lodging, valued at \$1,562.68, for the Council Chair to attend the 2022 Large City Council Presidents Convening in San José/San Francisco, California, from September 21 – 24, 2022; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body gratefully accepts the gift valued at \$1,562.68 from the National League of Cities that is more fully described in the Declaration of Gift attached as Exhibit A; and
