

**SUMMARY OF PROPOSED COMMITTEE DRAFT:**

**Resolution 22-206  
CONFIRMING THE REAPPOINTMENT OF MR. LANDON KANESHIRO TO THE  
ZONING BOARD OF APPEALS.**

The **PROPOSED CD1** makes the following amendments:

- A. Amends the second WHEREAS clause by quoting language from Charter Section 6-1516 regarding the duties of the Zoning Board of Appeals.
- B. Adds two WHEREAS clauses explaining the appointee's prior appointment to the Board.
- C. Makes miscellaneous technical and nonsubstantive amendments.



## **RESOLUTION**

**CONFIRMING THE REAPPOINTMENT OF LANDON KANESHIRO TO THE ZONING BOARD OF APPEALS.**

WHEREAS, Section 6-1516 of the Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended ("Charter"), establishes the Zoning Board of Appeals consisting of five members appointed by the Mayor and confirmed by the City Council ("Council") to staggered five-year terms; and

WHEREAS, Charter Section 6-1516 states that the Zoning Board of Appeals "shall hear and determine appeals from the actions of the [Director of Planning and Permitting] in the administration of zoning ordinances, including variances therefrom, subdivision ordinances and any rules and regulations adopted pursuant to either"; and

WHEREAS, by Mayor's Message 146 (2022), dated August 18, 2022, the Mayor has reappointed Landon Kaneshiro to the Zoning Board of Appeals; and

WHEREAS, by Resolution 17-264, the Council confirmed Mr. Kaneshiro's first appointment to the Zoning Board of Appeals for at term expiring on June 30, 2022; and

WHEREAS, Mr. Kaneshiro has been serving as a holdover member of the Board since July 1, 2022; and

WHEREAS, if confirmed by the Council, Mr. Kaneshiro will serve for a term to expire on June 30, 2027; and

WHEREAS, Charter Section 13-103, which applies to the Zoning Board of Appeals, requires that appointees to City and County of Honolulu ("City") boards and commissions be registered voters of the City; and

WHEREAS, the Council has reviewed Mr. Kaneshiro's qualifications and character and finds that Mr. Kaneshiro qualifies to serve on the Zoning Board of Appeals and deserves confirmation; now, therefore,

**BE IT RESOLVED** by the Council of the City and County of Honolulu that it confirms the reappointment of Landon Kaneshiro to the Zoning Board of Appeals for a term expiring on June 30, 2027; and

**BE IT FURTHER RESOLVED** that the Council expresses its gratitude and appreciation to Mr. Kaneshiro for his willingness to be considered for public service and actively participate in City government; and
