PAR HAWAII IS THE STATE'S LARGEST SUPPLIER OF PETROLEUM PRODUCTS AND TRANSPORTATION FUELS, AND OPERATES THE STATE'S ONLY OIL REFINERY, LOCATED IN CAMPBELL INDUSTRIAL PARK. AS A MARITIME SECURITY (MARSEC) AND FOREIGN TRADE ZONE (FTZ) FACILITY, PAR OPERATES UNDER THE AUTHORITY OF THE TSA, USCG, AND USCBP. WE ARE ALSO ACTIVE PARTNERS WITH DHS CISA. SECURITY IS OF THE UTMOST IMPORTANCE TO BOTH OUR FACILITY AND TO OUR STATE'S ENERGY SECURITY. PAR HAWAII CAN ATTEST TO THE INCREASING NUMBER OF SECURITY INCIDENTS THAT HAVE TAKEN PLACE OVER THE LAST 2-3 YEARS INSIDE THE CAMPBELL INDUSTRIAL PARK, INCLUDING FENCE LINE BREACHES, THEFT, VANDALISM, ARSON, AND CHOP SHOP ENCAMPMENTS SET UP ON PRIVATE PROPERTY. WHILE WE FEEL OUR FACILITY IS SECURE, THE SERIOUSNESS AND NUMBER OF SECURITY THREATS TAKING PLACE OUTSIDE OF OUR FACILITY SEEMS TO BE INCREASING EACH YEAR. PAR WELCOMES ANY EFFORTS IN REDUCING ILLEGAL ACTIVITY IN THE CAMPBELL INDUSTRIAL PARK. SEVERAL BUSINESSES HERE EMPLOY PRIVATE SECURITY, BUT ADDITIONAL LAW ENFORCEMENT PRESENCE AND MONITORING WOULD BE AN ADDITIVE DETERENT.
