"A BILL FOR AN ORDINANCE RELATING TO THE OAHU HISTORIC
PRESERVATION COMMISSION,"

introduced on July 15, 2022, which passed First Reading at the Council's meeting of August 10, 2022, reports as follows:

The purpose of Bill 44 (2022) is to amend the ordinance relating to the Oahu Historic Preservation Commission.

The Acting Director of the Department of Planning and Permitting testified in support of the Bill.

At your Committee's meeting, representatives of the Office of Hawaiian Affairs, Sierra Club of Hawai'i, Pu'u honua O Wailupe, and Iwi Kūpuna; and three individuals testified in support of the Bill.
