Your Committee on Zoning and Planning, which considered Resolution 22-202 entitled:

"RESOLUTION CONFIRMING THE REAPPOINTMENT OF MR. PANE MEATOGA III TO SERVE ON THE PLANNING COMMISSION OF THE CITY AND COUNTY OF HONOLULU,"

introduced on August 23, 2022, reports as follows:

The purpose of the Resolution is to confirm the reappointment of Mr. Meatoga III to serve on the Planning Commission of the City and County of Honolulu for a term to expire on June 30, 2027. The Mayor has requested Council confirmation of the reappointment of Mr. Meatoga III through Mayor's Message 140 (2022).

A public hearing on Mr. Meatoga III's reappointment was held at the City Council meeting on September 7, 2022.

At your Committee meeting on September 22, 2022, Mr. Meatoga III provided information on his background, expressed his willingness to continue serving on the Planning Commission, and responded to questions from Councilmembers.

The Acting Director of Planning and Permitting testified in support of the Resolution.
