## RESOLUTION

CONFIRMING THE REAPPOINTMENT OF GRANT KAGIMOTO TO SERVE ON THE GRANTS IN AID ADVISORY COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 9-205 of the Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended ("Charter"), establishes a Grants in Aid Advisory Commission ("Commission") consisting of seven members; and

WHEREAS, Section 6-52.4, Revised Ordinances of Honolulu 1990, sets forth the powers, duties, and functions of the Commission; and

WHEREAS, pursuant to Charter Section 13-103, the members of the Commission are appointed by the Mayor and confirmed by the City Council ("Council") and serve for staggered five-year terms; and

WHEREAS, by Mayor's Message 144, dated August 18, 2022, the Mayor has reappointed Grant Kagimoto to the Grants in Aid Advisory Commission; and

WHEREAS, if confirmed by the Council, Grant Kagimoto will serve for a second term to expire on January 14, 2027; and

WHEREAS, Charter Section 13-103, which applies to the Commission, requires that appointees to all City boards and commissions be registered voters of the City; and

WHEREAS, the Council has reviewed Grant Kagimoto's qualifications and character and finds that Grant Kagimoto qualifies to serve on the Commission and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the reappointment of Grant Kagimoto to the Grants in Aid Advisory Commission for a term expiring on January 14, 2027; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Grant Kagimoto for his willingness to be considered for public service and actively participate in City government; and
