SUBJECT: Bill 46 (2022), CD1 Relating to Height Limits for Rooftop Structures

The Office of Climate Change, Sustainability and Resiliency (CCSR) supports Bill 46 (2022), CD1, which expands existing height limits to allow solar panels above existing rooftop equipment and ensures area beneath rooftop solar panels does not count towards floor area to encourage the creation of more rooftop gathering spaces.

Hawaiian Electric's Power Supply Improvement Plan assumes a need for three and half times more distributed solar photovoltaic (PV) power than currently exists, which means the vast majority of our rooftops will need solar PV in order to meet our energy equity and climate goals<sup>1</sup>. Rooftop solar has been and continues to be one of the most effective tools for lowering residential energy costs. However, through past policy discussions, CCSR has heard from building industry stakeholders that current height limits can severely impede their ability to utilize existing rooftop spaces for solar and bring the benefit of costs savings to residents.

Bill 46, CD1 is consistent with objectives of the O'ahu General Plan, as well as both the City's O'ahu Resilience Strategy and Climate Action Plan, which further define the importance of rooftop spaces in meeting our sustainability and community resilience goals<sup>2,3</sup>. These amendments will encourage the installation of more, much needed
