Your Committee on Parks and Community Services, which considered Bill 48 (2022) entitled:

"A BILL FOR AN ORDINANCE RELATING TO COMMERCIAL ACTIVITIES  
AT PUBLIC PARKS.

introduced on August 3, 2022 and which passed first reading at the August 10, 2022 Council meeting, reports as follows:

The purpose of Bill 48 (2022) is to address commercial activities at certain beach parks.

Kehaulani Puu, Deputy Director of the Department of Parks and Recreation, testified that the administration is working on a county wide plan and offered an update on the status of the draft measure.

At your Committee's meeting on October 20, 2022, three individuals testified in support, five individuals testified in opposition, and one individual offered comments on the resolution. Your committee also received oral testimony in opposition from two individuals from Nui Tours and Travel.

Written testimony in support was received from five individuals. Written testimony in opposition was received from 38 individuals. Written comments were received from one individual. Your Committee also received written testimony in opposition from Custom Island Tours and Haleiwa Surf School.
