RESOLUTION

CONFIRMING THE MAYOR'S APPOINTEES TO SERVE ON THE ECONOMIC REVITALIZATION COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-109, Revised Charter of the City and County of Honolulu, 1973 (2017 Edition), as amended ("Charter"), establishes an Economic Revitalization Commission ("Commission") consisting of nine members; and

WHEREAS, Charter Section 6-109, sets forth the duties of the Commission; and

WHEREAS, pursuant to Charter Section 13-103, the members of the Commission are appointed by the Mayor and confirmed by the City Council ("Council") and serve for staggered five-year terms; and

WHEREAS, by Mayor's Message 194, dated October 12, 2022, the Mayor has appointed nine members with staggered terms to the Commission; and

WHEREAS, Charter Section 6-109(h) requires that the Commission members have expertise in small business, finance, sustainable economics, and community development; and

WHEREAS, Charter Section 13-103 requires that each appointee to the Commission be a registered voter of the City; and

WHEREAS, the Council of the City and County of Honolulu has reviewed the qualifications and character of the appointees and finds that each of the appointees qualifies to serve on the Commission; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the Mayor's appointments of the following persons to serve on the Economic Revitalization Commission of the City and County of Honolulu:

1. Anthony Mizuno, for an initial one-year term;
2. Bobby-John "Olu" Campbell, for an initial two-year term;
3. Eliza Talbot Manchester, for an initial two-year term;
4. Deborah Lui-Anderson, for an initial three-year term;
5. Reid Chung, for an initial three-year term;

7. Keoni Lee, for an initial four-year term;
