Councilmember Tsuneyoshi stated that there was a very passionate discussion in Committee and thanked all that came to testify and share their concerns. She noted that there is a petition to protect Kokololio from the devastation that has been happening on a daily basis.

Councilmember Kia'āina stated that she is aware of Director Thielen's comment to defer the Bill until an island wide approach can be implemented but she feels that this needs to be done now because an island wide approach will be a long term approach.

In response to councilmembers, Laura Thielen, Director, Department of Parks and Recreation (DPR) stated that:

- Nothing else can be done other than the open and close hours of the park which would apply to everyone.
- DPR is in discussion with Corporation Counsel on a Bill for an island wide approach which will be brought to the Council in the first quarter of next year.
- Everyone should park within the parking stall.
- DPR is working with the Hawaii Tourism Authority on the Oahu destination management plan.
- DPR did some work with the Public Utilities Commission (PUC). Under the PUC the licensees have to be in compliance with the State and County laws. DPR also worked with the PUC on illegal dumping.

• The Council is the policy maker. The DPR will be bringing a Bill to the Council for consideration on an island wide approach and if the Council wants to designate by region one park or another for commercial activities all the time, the Council has the authority to alter the proposed Bill.

- They will commit to continue to involve the community in every step of the process. They will continue going to and including the community in continuing dialog to address their concerns.
