

RESOLUTION

RELATING TO THE TRANSFER OF FUNDS.

WHEREAS, Section 2-17.2(c)(1), Revised Ordinances of Honolulu 2021 ("ROH"), requires that the City Council ("Council") approve by resolution any transfer of funds between activities whenever the cumulative amount of transfers from or to an activity totals in excess of \$100,000 or 10 percent of the amount appropriated for that activity in the executive operating budget ordinance, as may be amended, whichever is less; and

WHEREAS, ROH Section 2-17.2(c)(2) requires that the City Council approve by resolution any transfer of funds between characters of expenditure within the same activity whenever the cumulative amount of transfers from or to a character of expenditure exceeds the lesser of (a) \$100,000, or (b) the greater of (i) 10 percent of the appropriation for either the originating or receiving character of expenditure, or (ii) \$10,000; and

WHEREAS, the Honolulu Emergency Services Department (HESD), Emergency Medical Services Division, has requested the transfer of funds in order to procure two Advanced Life Support (ALS) Training Manikins for paramedics to receive a more realistic experience during recertification training; and

WHEREAS, a transfer not to exceed \$36,881.00 from current expense (CE) to equipment (E) for fiscal year 2023 is required to purchase two ALS Training Manikins; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that \$36,881.00 in General Fund monies be transferred between the following characters of expenditure:
