Bill 48 was waived to the Council floor by the Chair of the Parks and Community Services Committee (CC-356).

In response to Councilmember Tupola, Kehaulani Pu'u, Deputy Director, Department of Parks and Recreation stated that at the last Parks Committee meeting, she stated that the island wide approach Bill should be ready within the next three to six months. Since then, the Department submitted a draft to Corporation Counsel for their review and will have it ready within the next three months, the first quarter of 2023.

Councilmember Tupola stated that if she does not see a Bill within the 3 months, she will be proposing a similar Bill. She agreed that there needs to be a Bill that the Department can stand behind and have written park rules. Councilmember Tupola stated that she is in support of the measure.

Councilmember Kiaʻāina stated that she is the only councilmember who has laws on prohibiting commercial activity in her community at Kailua and Waimanalo and is empathetic to those who have come to testify on the measure. She stated that she supports the measure and appreciates Choon James for making sure that everyone knows that this is not anti-tourism. Councilmember Kiaʻāina stated that she looks forward to working with the Department of Parks and Recreation and that tourism is appreciated but they will not stand for people taking advantage of the communities and the land and natural resources.

Councilmember Tsuneyoshi stated that the communities have been told that there would be an island wide ban and the communities, the beaches, and the environment cannot wait any longer for action. She noted that it is unacceptable and the Council needs to take charge and stand with the communities to make sure their voices are heard and that appropriate action is taken to address the issues. Councilmember Tsuneyoshi stated that the beach parks should not be commercialized and overrun with commercial activities. She stated that the park rules have not been updated since the 1980's. Councilmember Tsuneyoshi noted that the parks were given to the State and City for the benefit of the people and that needs to be taken seriously to understand what is happening now and the history of what the lands were supposed to be used for which was for the people. She stated that she if very grateful for what is happening with the measure.
