ADOPTION RESOLUTION 22-294

RESOLUTION RELATING TO THE OFFICERS OF THE COUNCIL OF THE CITY AND COUNTY OF HONOLULU.

Councilmember Kia⁴āina moved that Resolution 22-294 be adopted. Seconded by Councilmember Cordero.

Zhizi Xiong, CARES (M-0002) (Support)

Councilmember Kia'āina stated that it has been an honor to serve alongside of Chair Waters. She noted that under Chair Waters' leadership the Council navigated through the pandemic by appropriating \$95 million in American Rescue Plan Act funding for Fiscal 2023 budget; which has been added to the City's affordable housing portfolio. Councilmember Kia'āina stated that historic preservation policies were prioritized, the residential neighborhoods were protected from over commercialization, and updates to major planning documents like the Oahu General Plan, Communities Sustainable Plan, and the Transit Oriented Development Plans were finalized. She noted that she anticipates that under Chair Waters' leadership the Council will update the Land Use Ordinance, continue to seek a balance between commercial activities and protection for residential communities, update the shoreline setbacks and special management area laws, and provide some property tax relief to the residents while still balancing the budget.

Councilmember Cordero thanked councilmembers for their consideration of the Resolution. She stated that the past two years have been a great experience and opportunity working with the leadership which encouraged her to speak up for her community and her office team. She noted that she looks forward to continuing to work with the leaders and councilmembers.

Resolution 22-294 was adopted.
