

RESOLUTION

RELATING TO THE APPOINTMENT OF REBECCA SOON TO SERVE ON THE SALARY COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 3-122, Revised Charter of the City and County of Honolulu 1973 (2017 Edition), as amended ("Charter"), establishes the Salary Commission; and

WHEREAS, the Salary Commission is responsible for establishing the salaries of the elected officers of the City and County of Honolulu ("City"), the Managing Director, the Deputy Managing Director, department heads, deputy department heads, the Band Director, and the salary schedules for deputies of the Corporation Counsel and Prosecuting Attorney; and

WHEREAS, the Salary Commission is composed of seven members, appointed to staggered five-year terms as follows:

1. The Mayor, without necessity of confirmation by the City Council ("Council"), appoints three members;
2. The Council appoints three members; and
3. The Mayor appoints, subject to Council confirmation, the seventh member; and

WHEREAS, the Council proposes to appoint Rebecca Soon as a member of the Salary Commission; and

WHEREAS, if approved by the Council, Rebecca Soon would succeed Brian Tamamoto, whose term expired on January 15, 2022, and serve a term to expire on January 15, 2027; and

WHEREAS, Charter Section 13-103 requires that members of City boards and commissions be duly registered voters of the City; and

WHEREAS, the Council has reviewed Rebecca Soon's qualifications and character and finds that Rebecca Soon is qualified to serve on the Salary Commission; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body appoints Rebecca Soon to the Salary Commission to serve a term expiring on January 15, 2027; and
