# A BILL FOR AN ORDINANCE

TO AMEND CHAPTER 10, ARTICLE 4, REVISED ORDINANCES OF HONOLULU 2021, RELATING TO FEES FOR USE OF MUNICIPAL GOLF COURSES.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose. The purpose of this bill is to amend Section 10 of the Revised Ordinances of Honolulu 2021 relating to fees for a golf identification card.

SECTION 2. Sections 10-4.8 and 10-4.9, Revised Ordinances of Honolulu 2021, are amended to read as follows:

## "§ 10-4.8 Golf identification card.

- (a) To qualify for the rates expressly provided in § 10-4.2 for persons with golf identification cards each person must present the person's golf identification card at the time of payment of golf fees.
- (b) Verification of Hawaii residency, age, and identity through provision of appropriate documents shall be required in order for a person to qualify for a golf identification card.
- (c) A \$5.00 fee shall be assessed for the initial golf identification card.
- (d) A [\$5] \$10.00 fee shall be assessed for replacement of a golf identification card.

# § 10-4.9 Surcharge for use of qualifying documents.

Persons who present a qualifying document at the time of payment of golf fees instead of a golf identification card shall be charged green fees applicable to persons with golf identification cards in § 10-4.2 plus an [\$4] \$8.00 surcharge."

SECTION 3. Ordinance material to be repealed is bracketed and stricken and new material is underscored. When revising, compiling, or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the Revisor of Ordinances need not include the brackets, the material that has been bracketed and stricken, or the underscoring.
